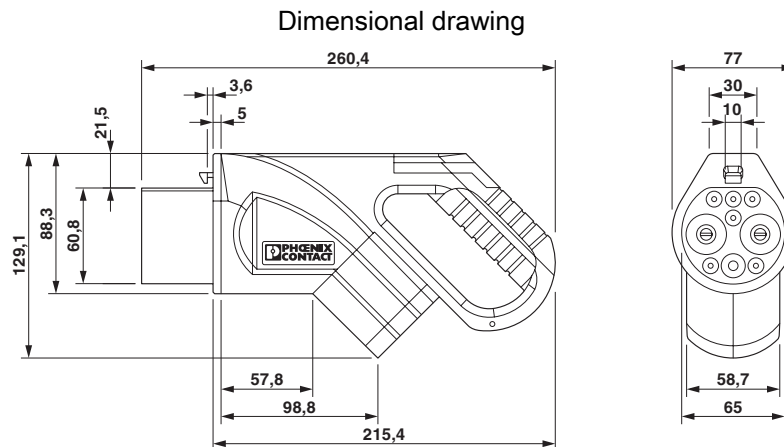

Schematic diagram



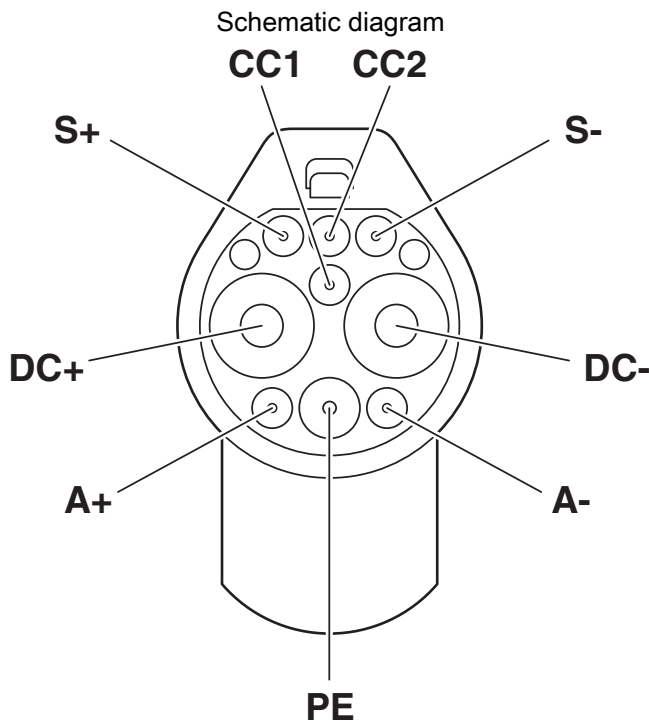
