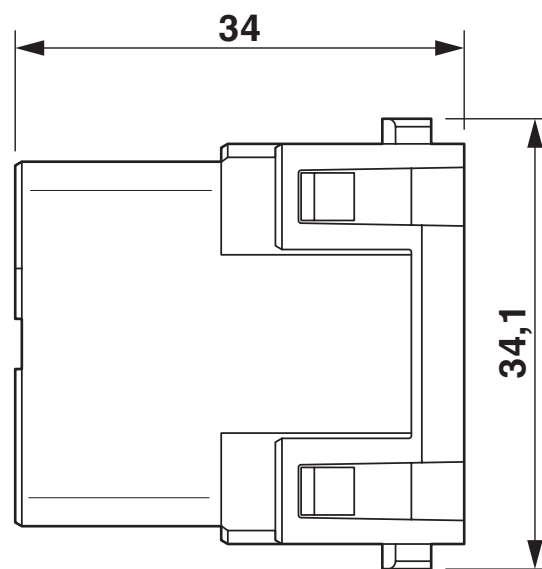

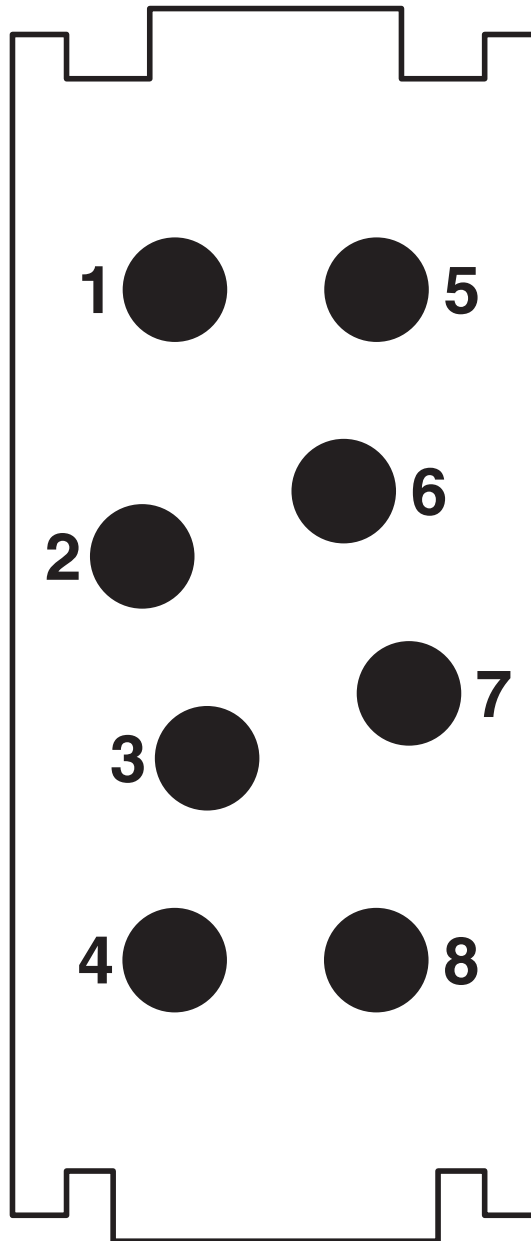

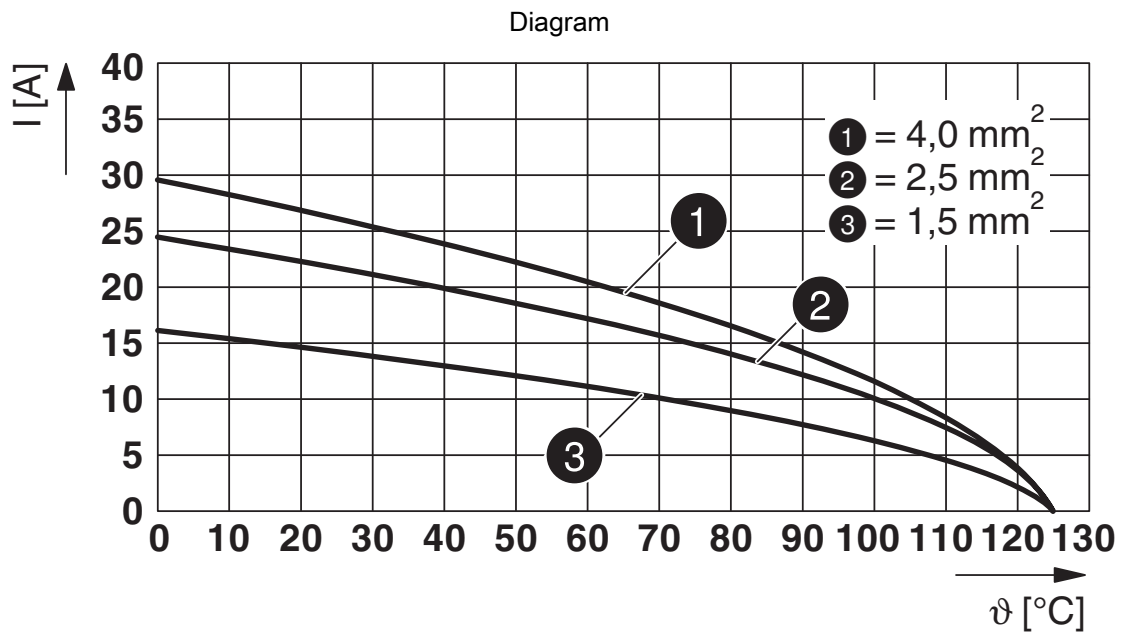
Schematic diagram
