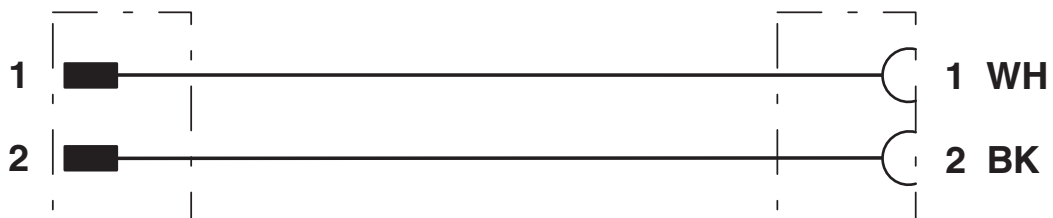
Pin assignment, plug, 7/8"-16UNF, 2-pos., view of male side
