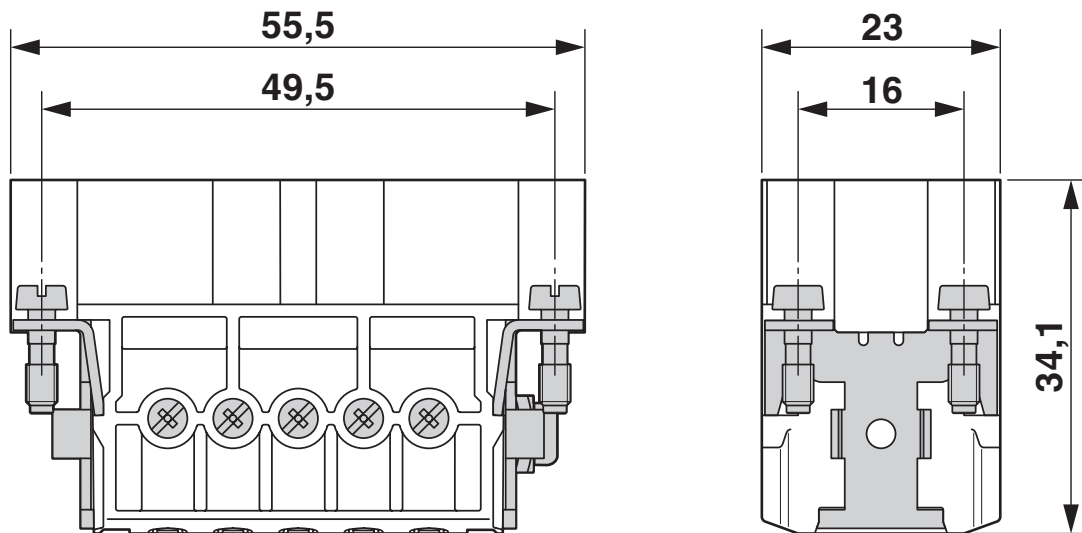

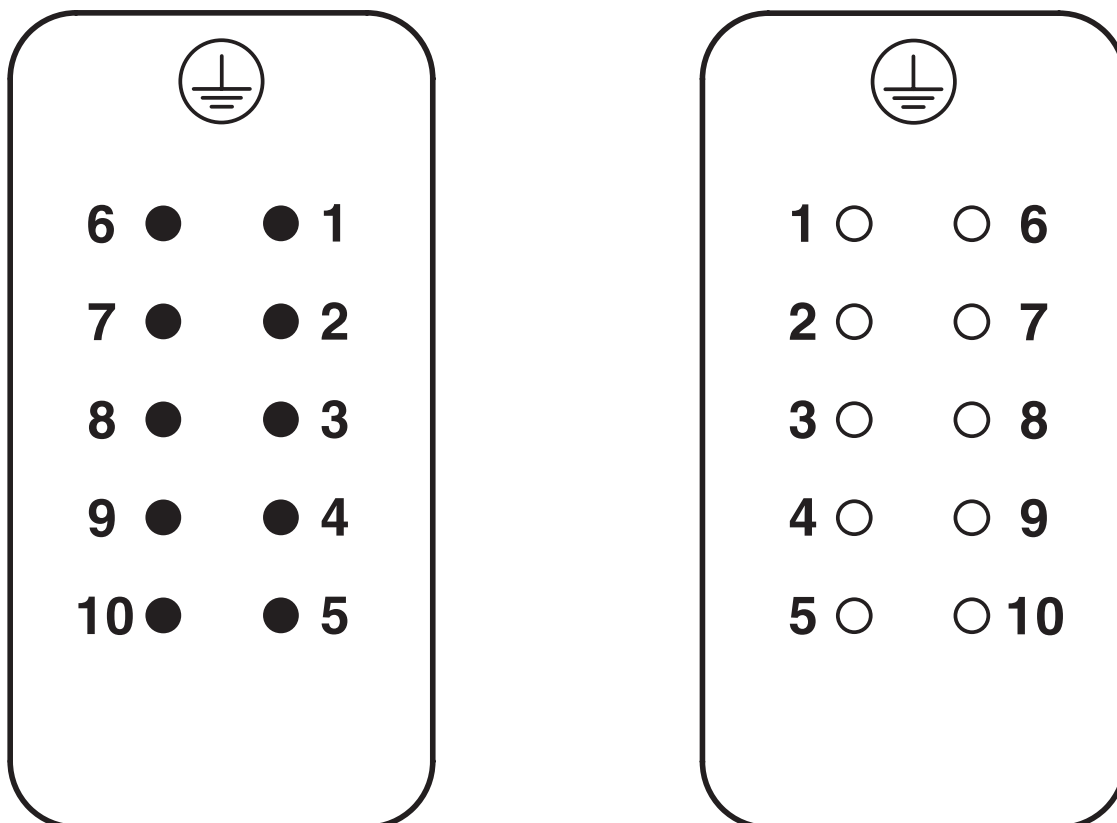
Mounting cutout when used without housing

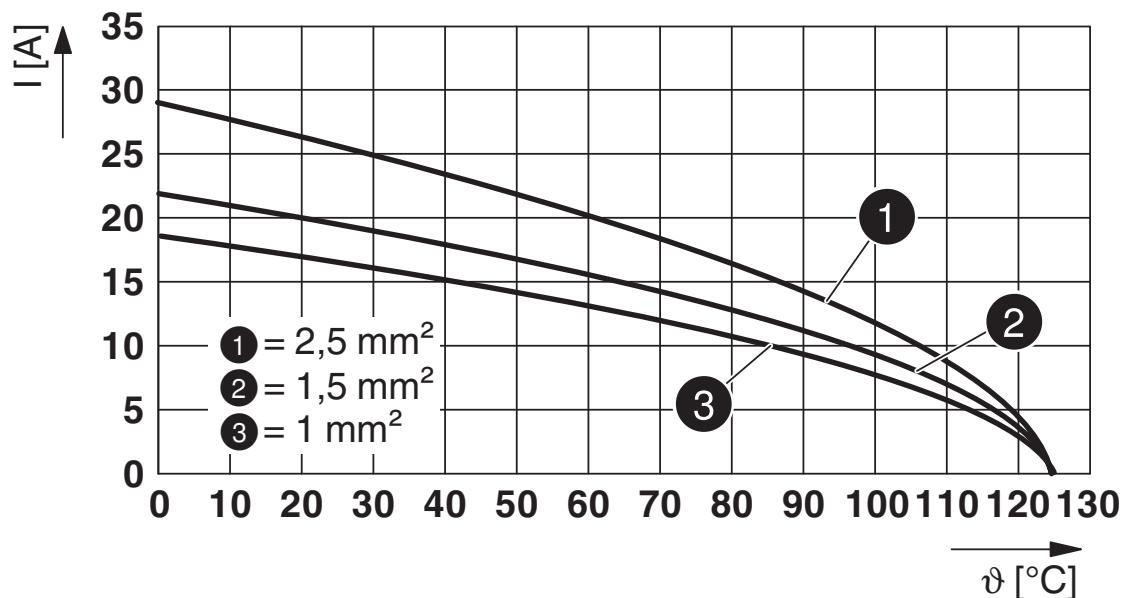
