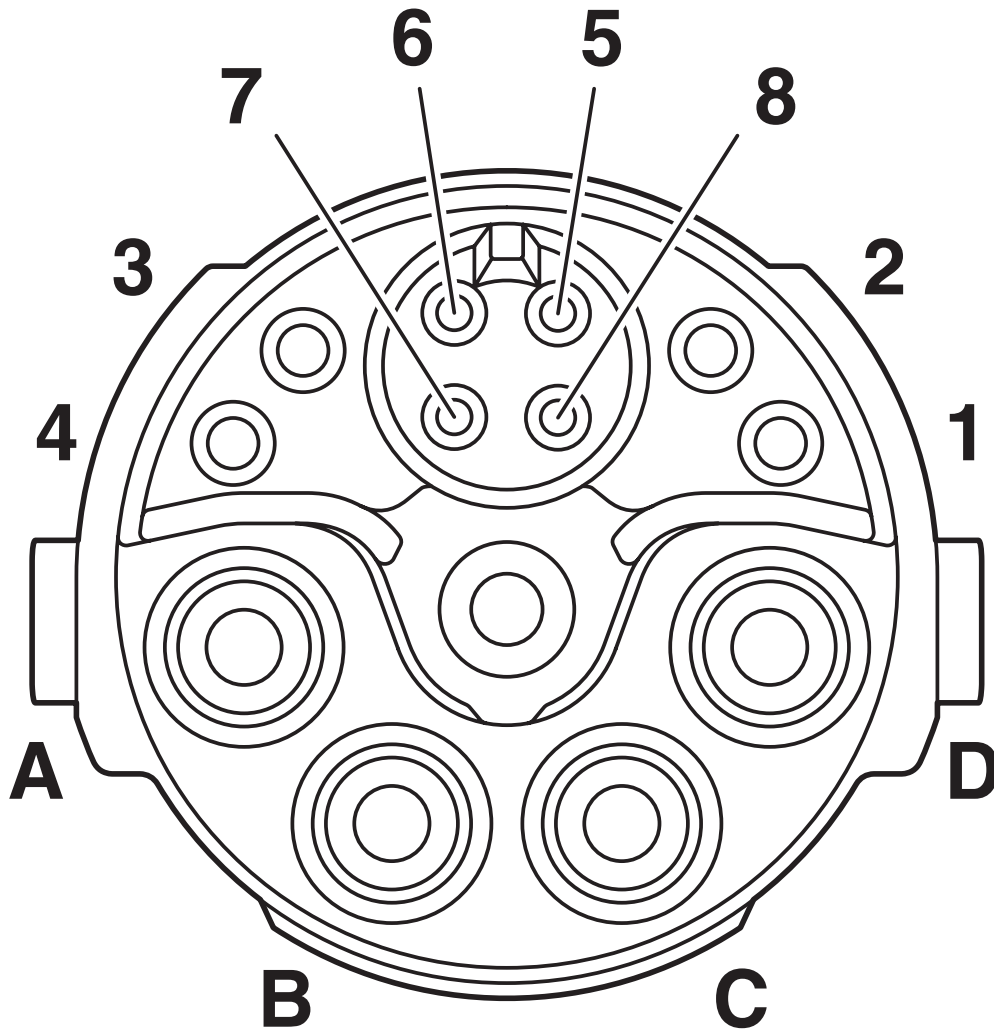

Schematic diagram



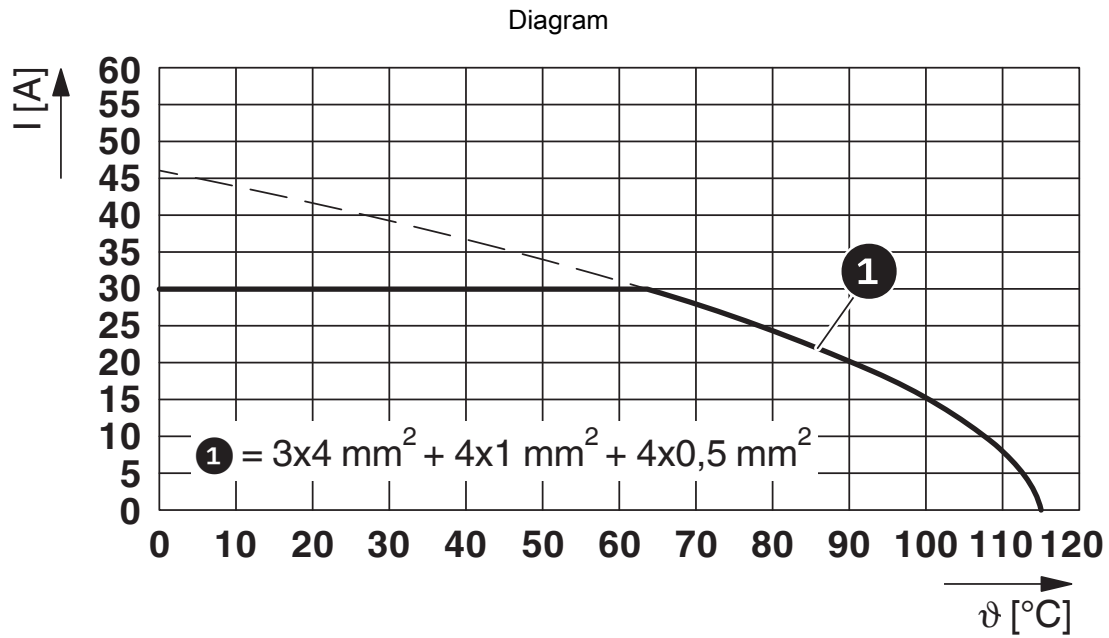
