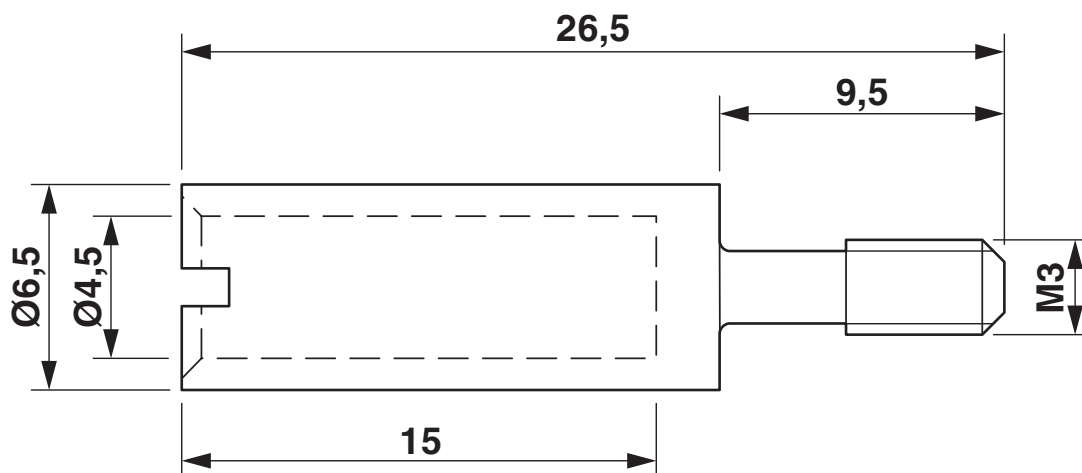

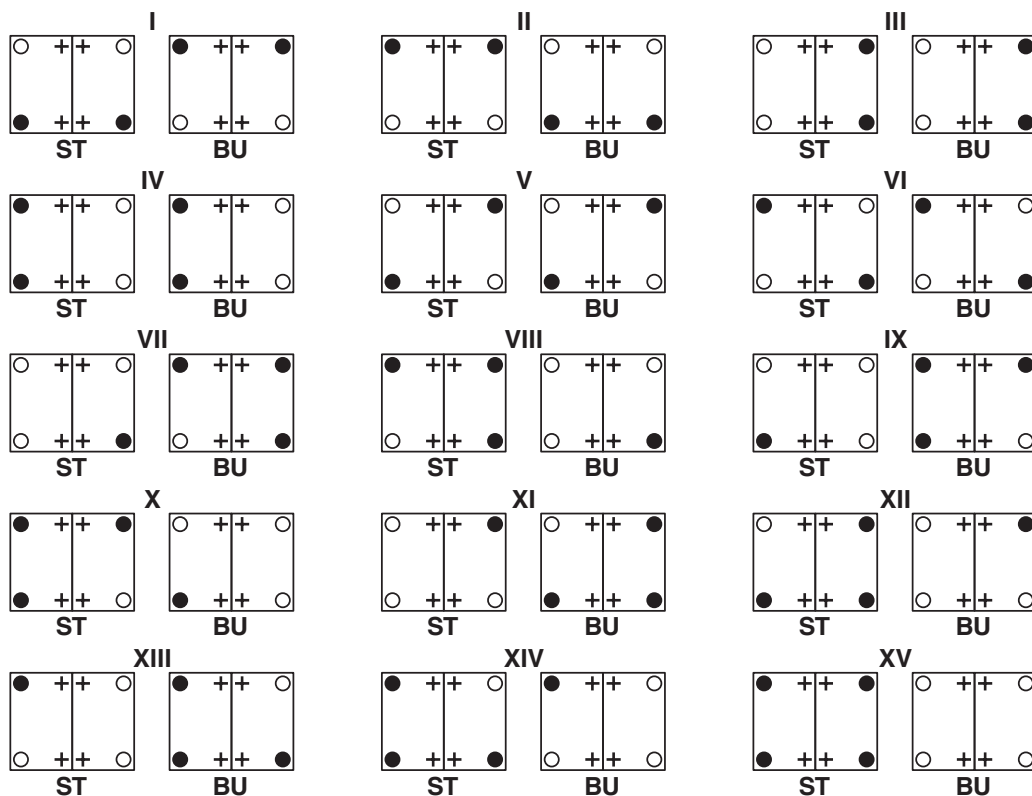

Schematic diagram



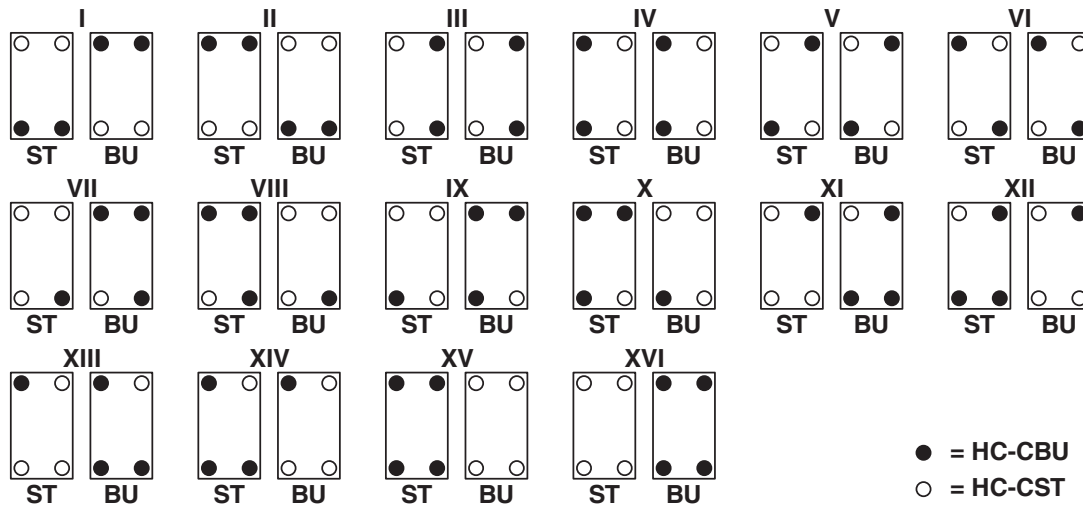
Coding with HC-CBU and HC-CST, for housings with two contact inserts
