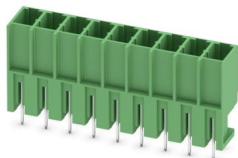

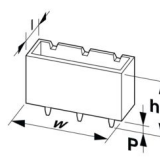

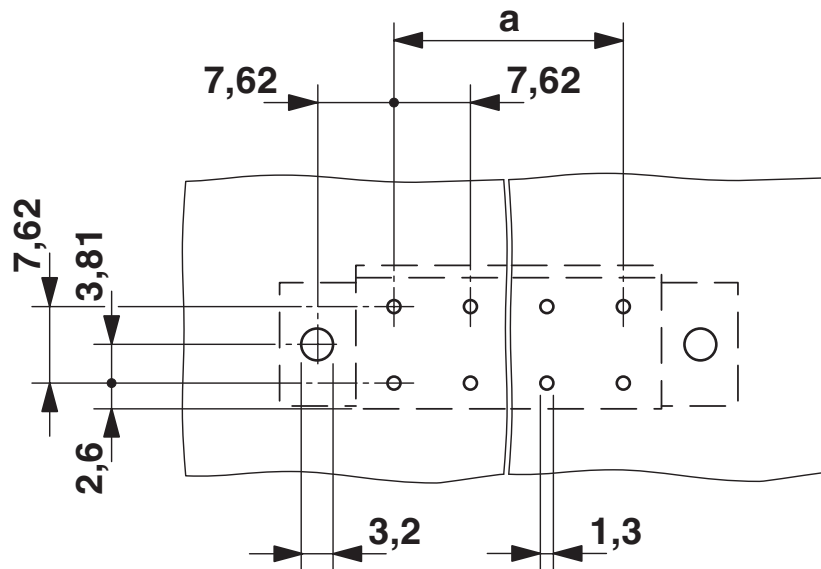


Type: PC 5/...-STF1-7,62 with PCV 4/...-G-7,62 and BF-PC 4
