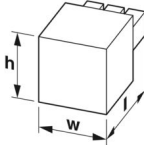

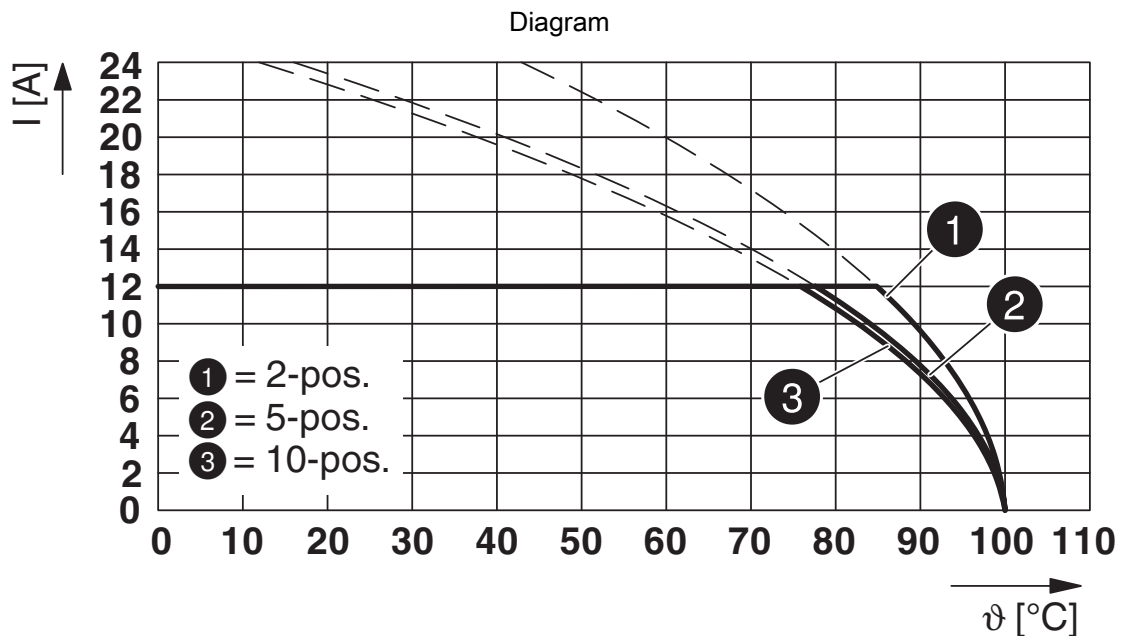

Type: TFKC 2,5/...-ST-5,08 with CC 2,5/...-G-5,08 P...THR



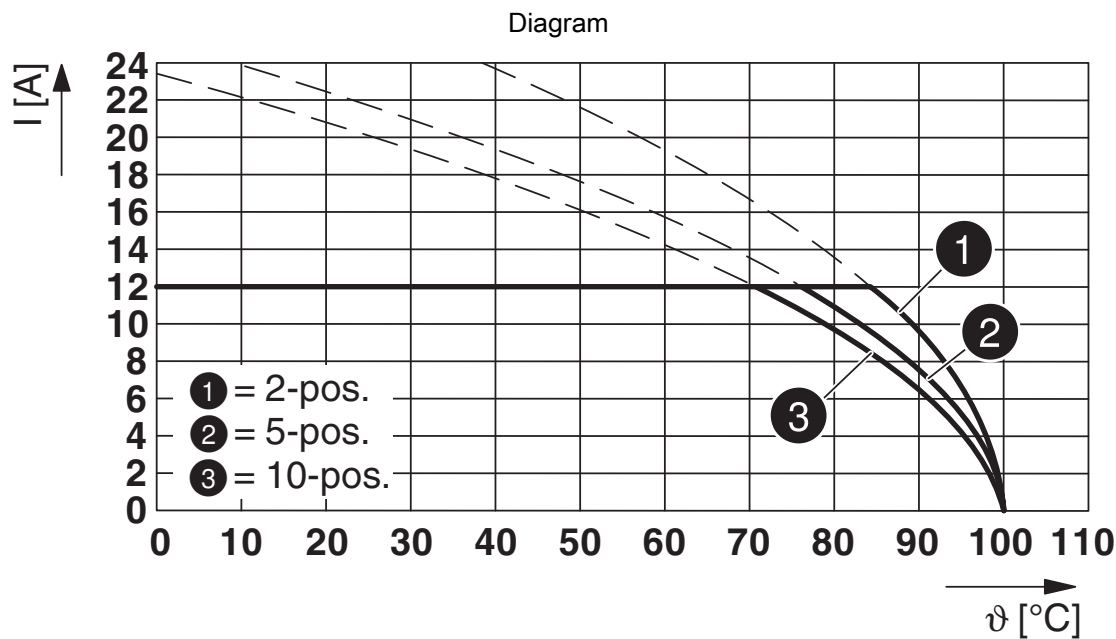

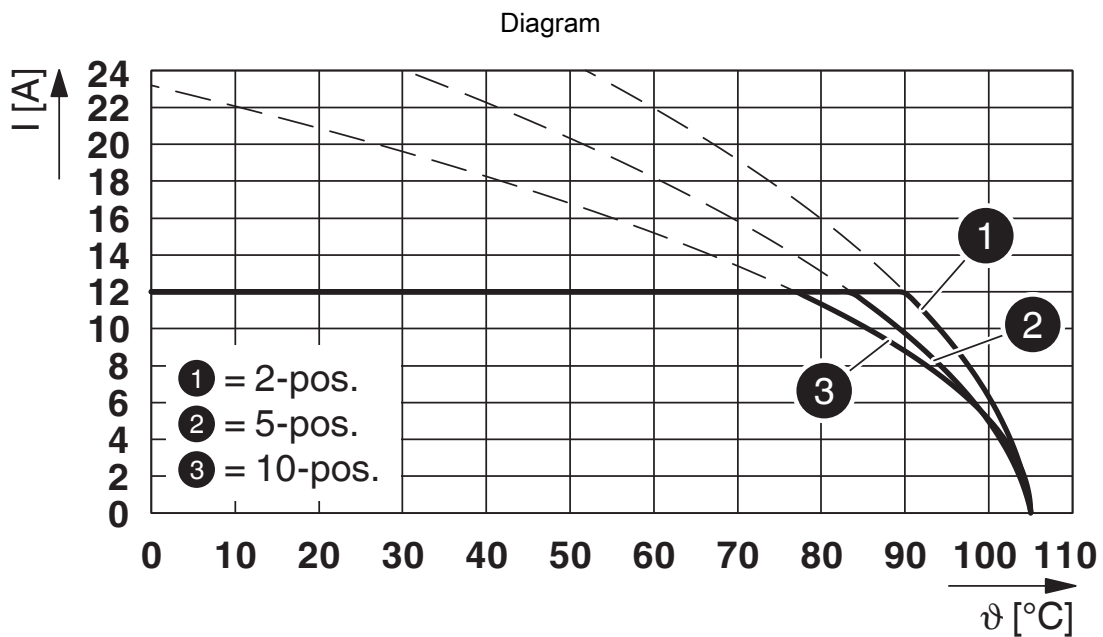

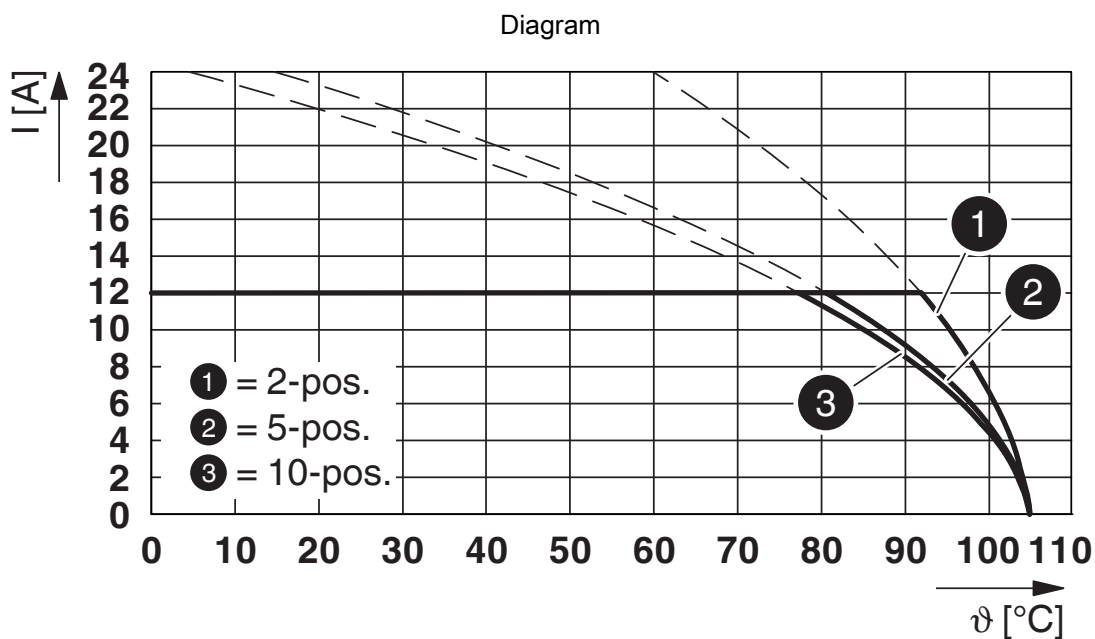

Type: TFKC 2,5/...-ST-5,08 with SMSTBA 2,5/...-G-5,08

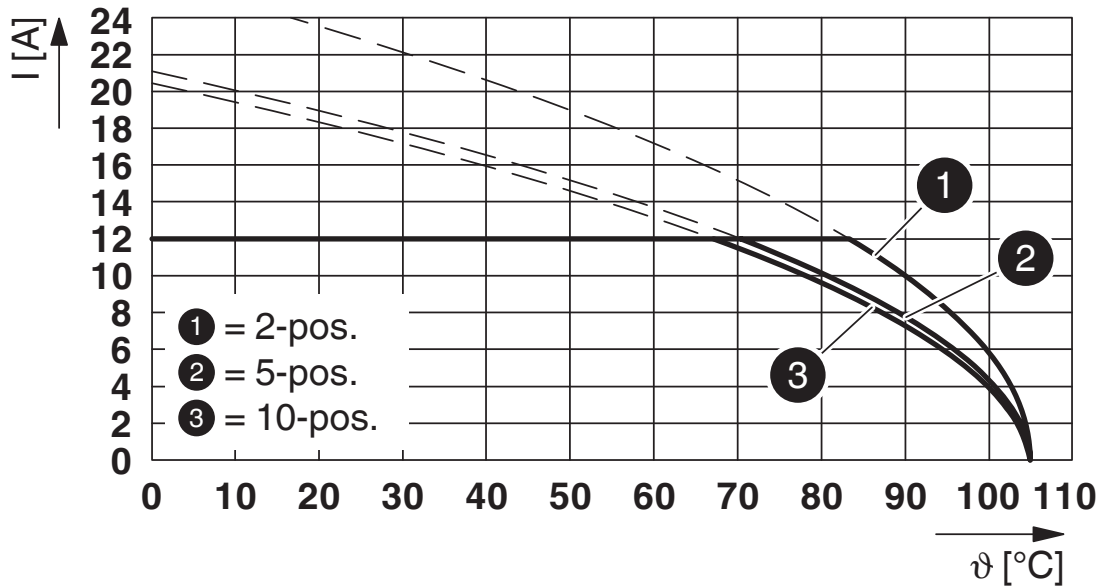

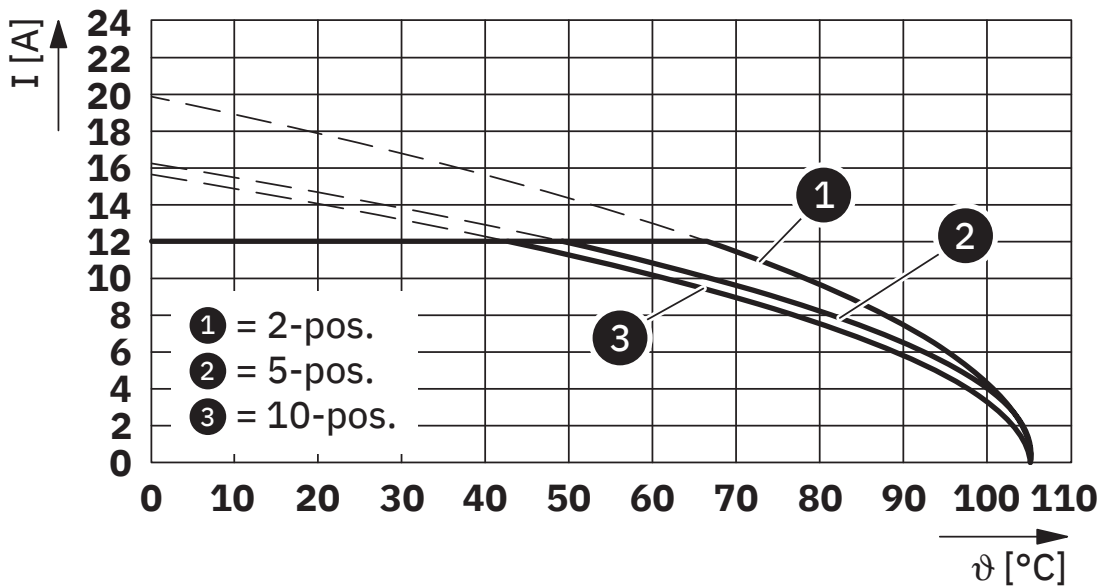
