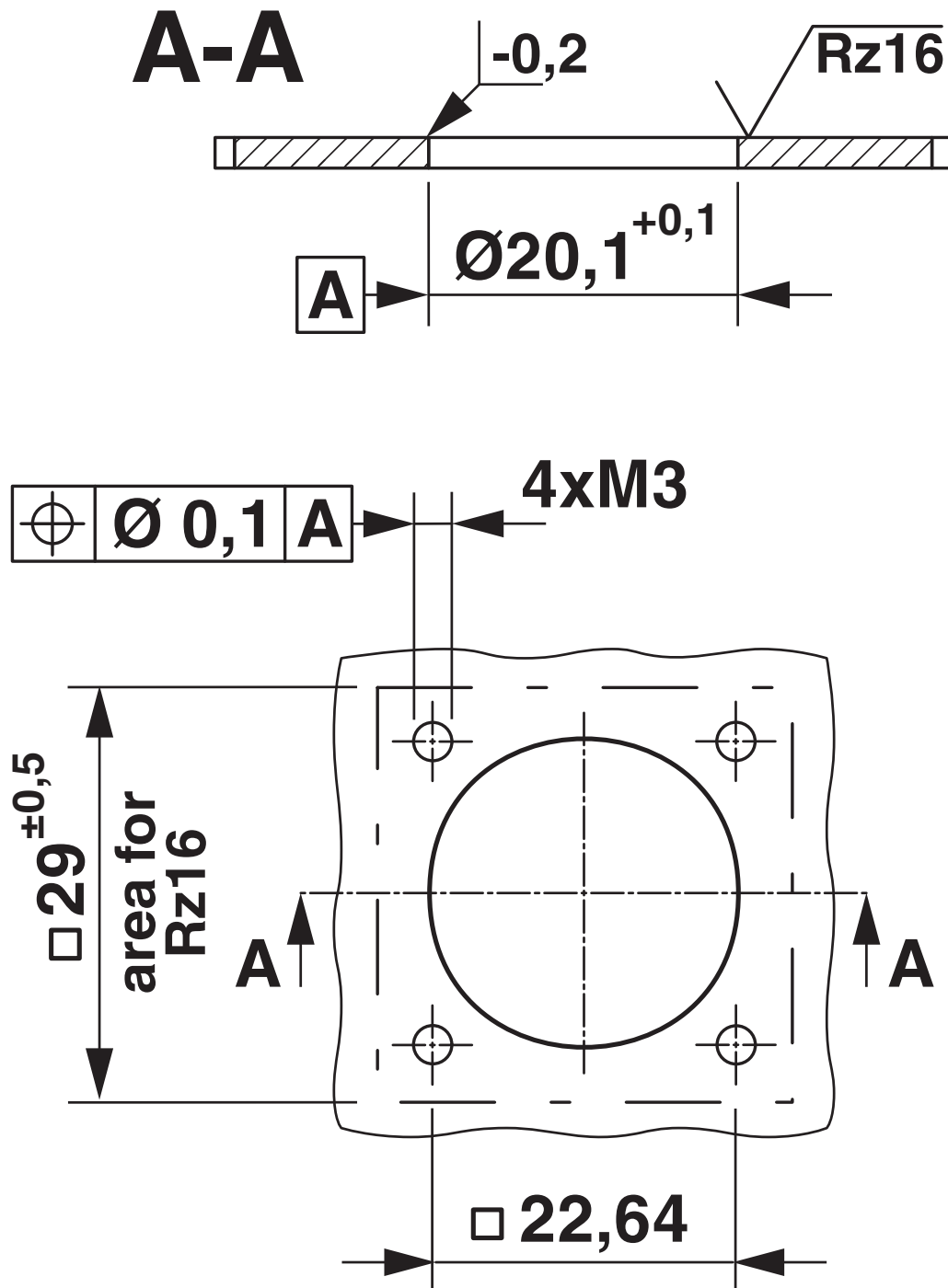

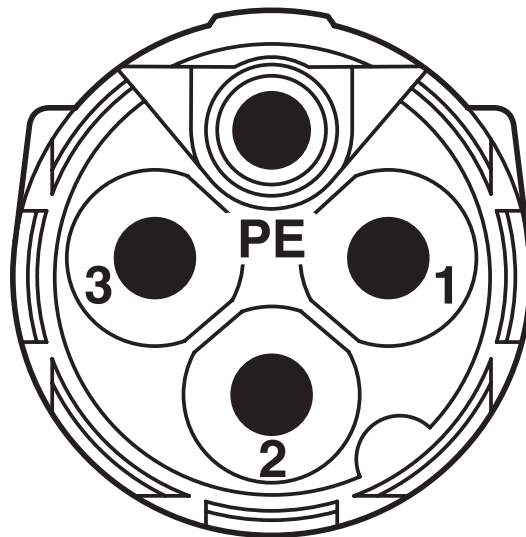

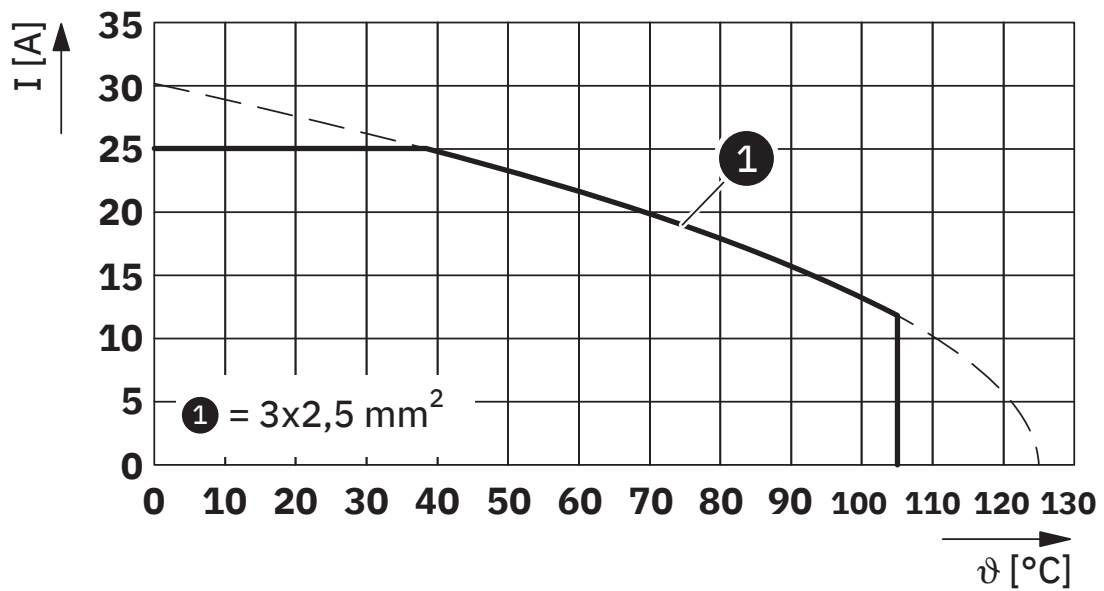

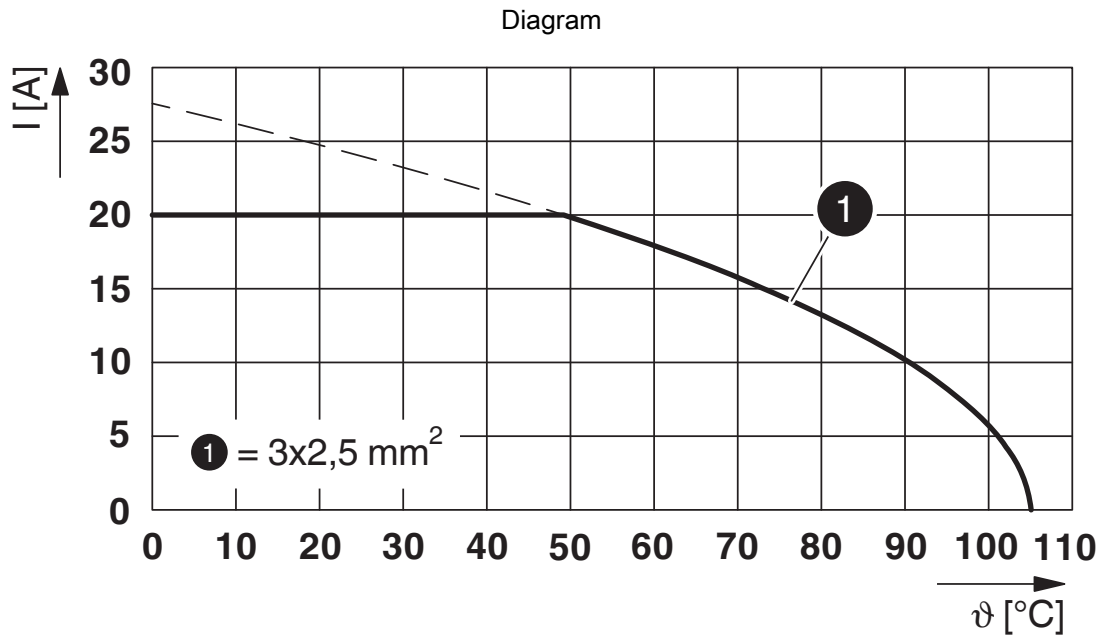


I = current strength, ϑ = ambient temperature, $3 \times 25 \text{ A}$
