Connector pin assignment

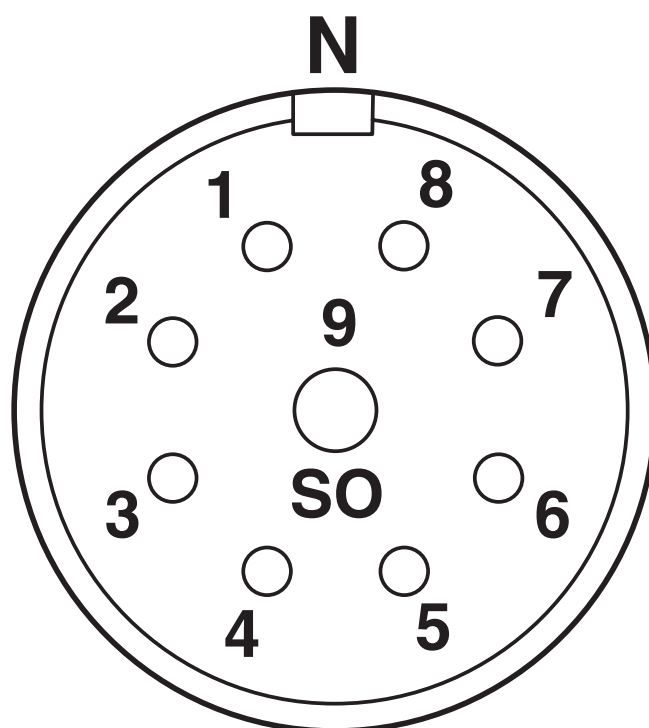
