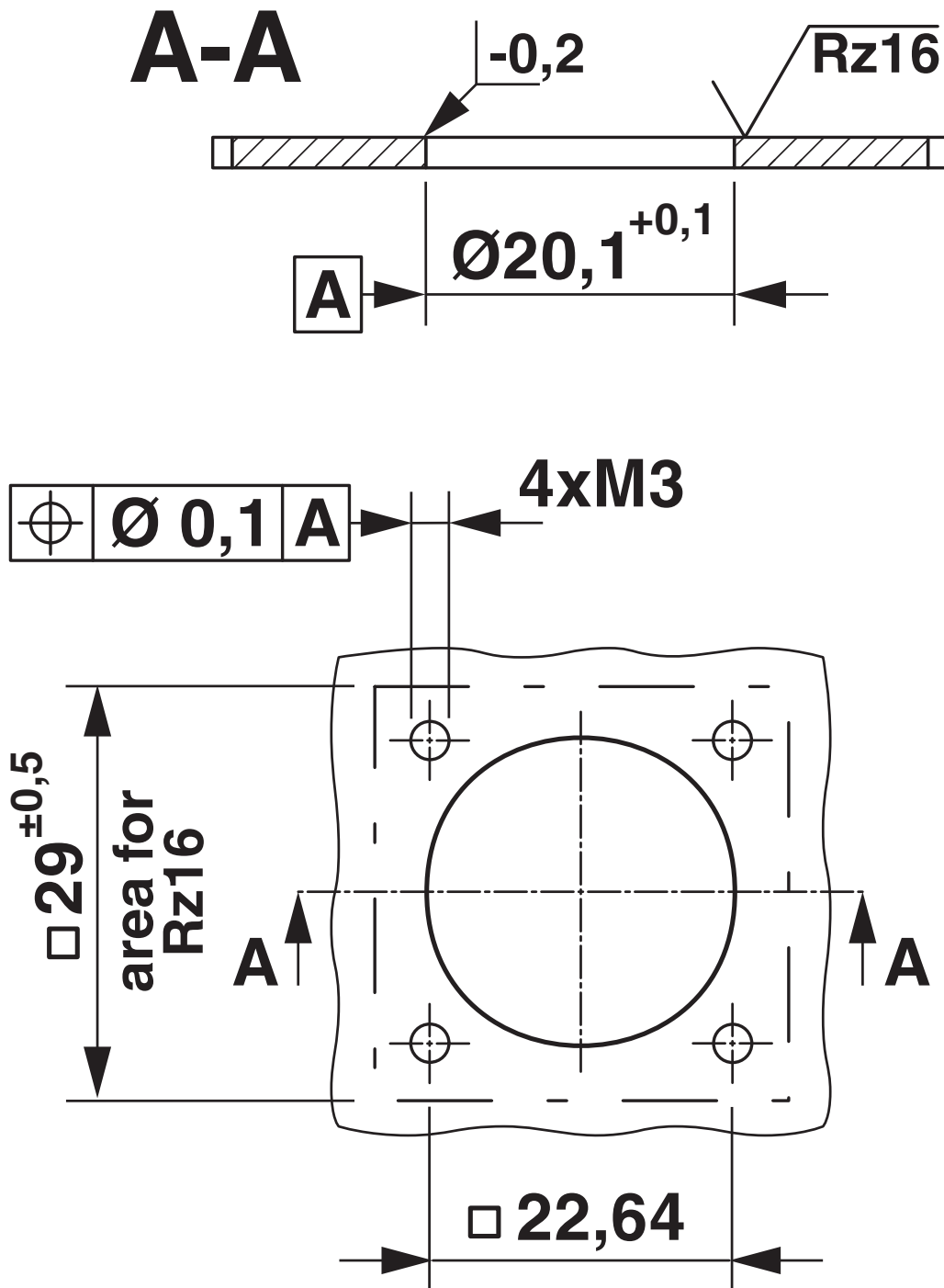

Schematic diagram

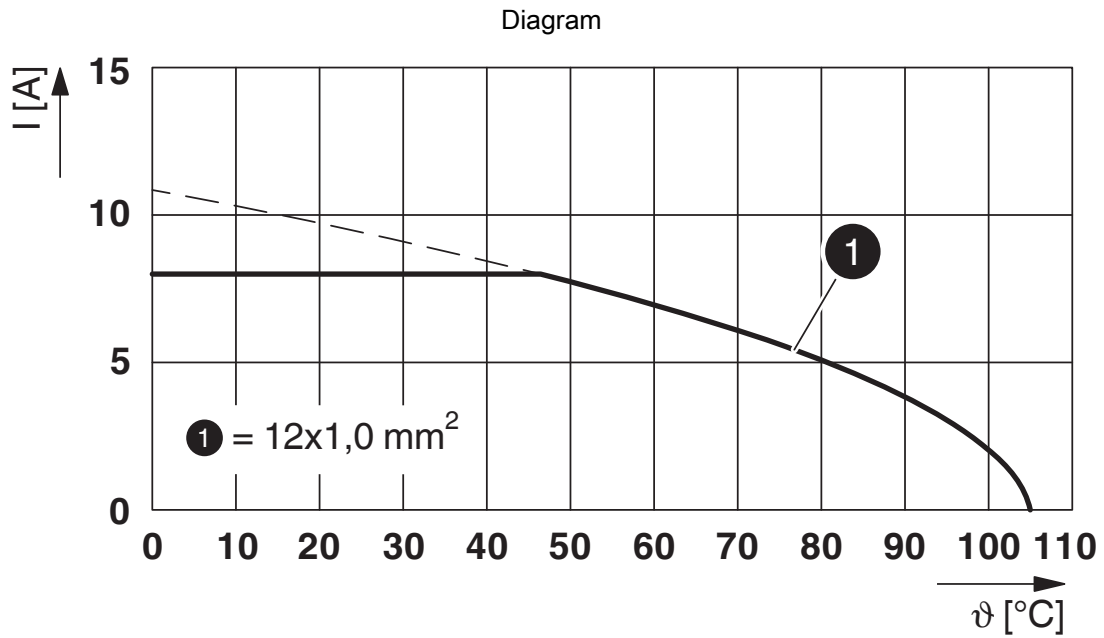


Contact chamber numbering (view of plug-in side)
