Schematic diagram



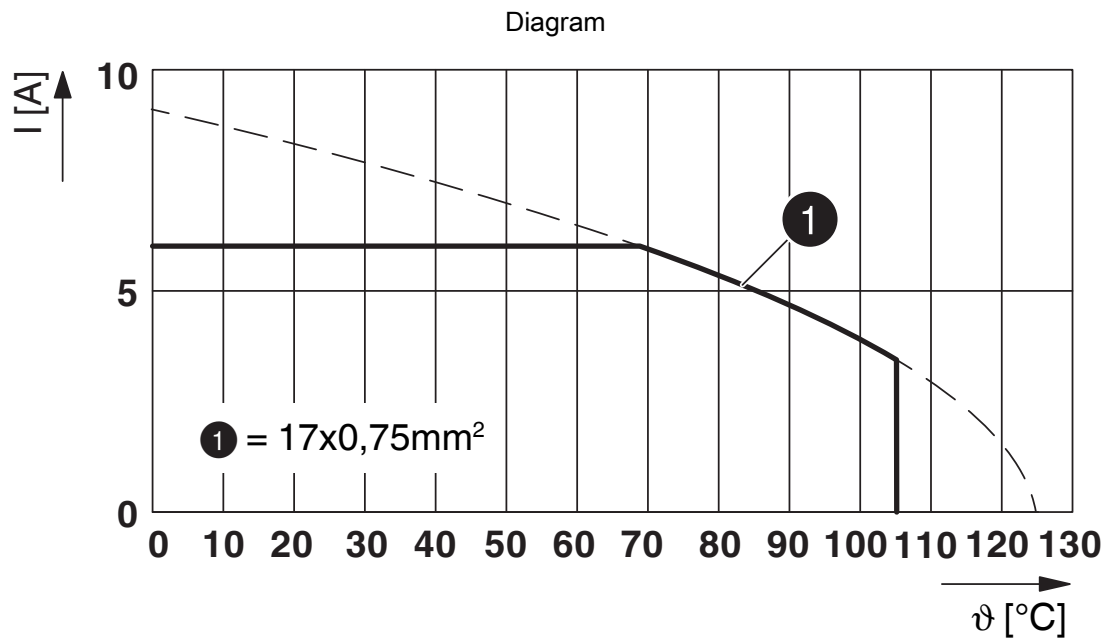
