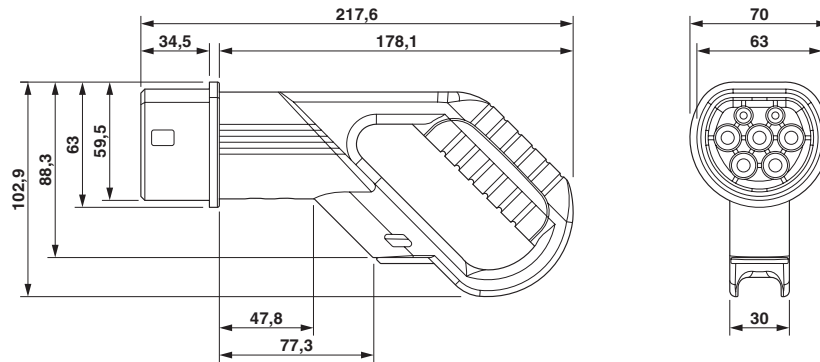

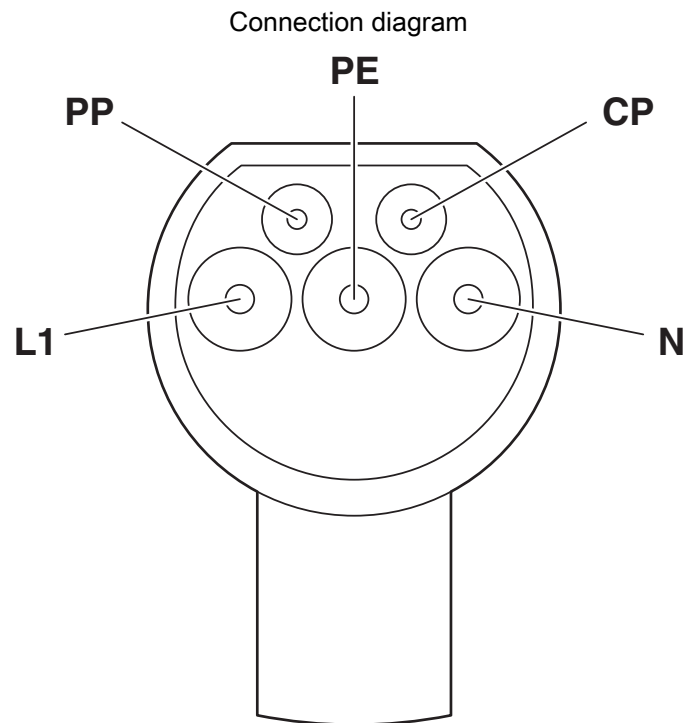


Infrastructure plug

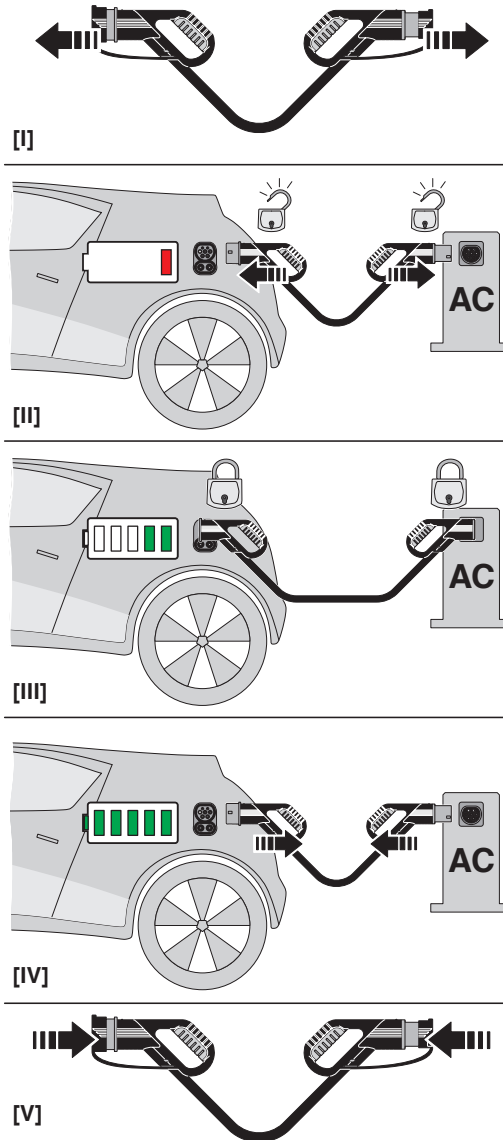
Pin assignment of Infrastructure Plug
