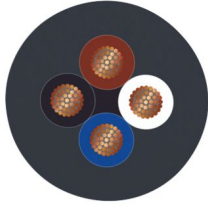

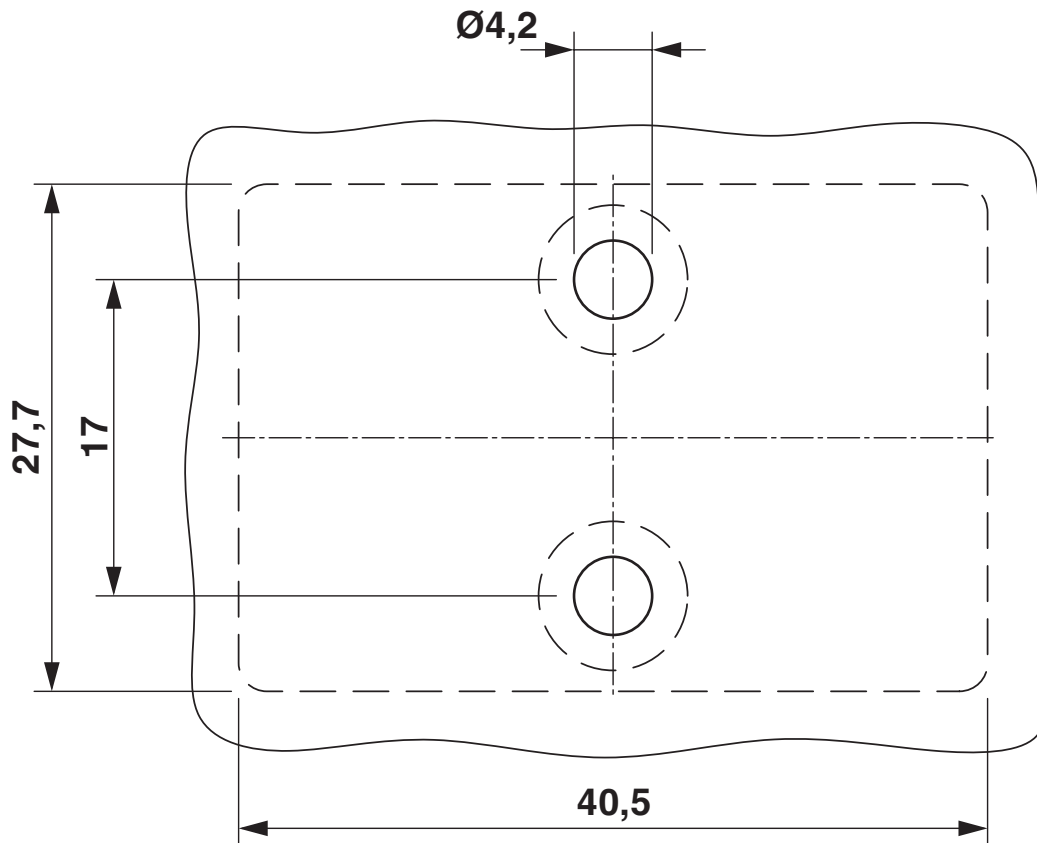

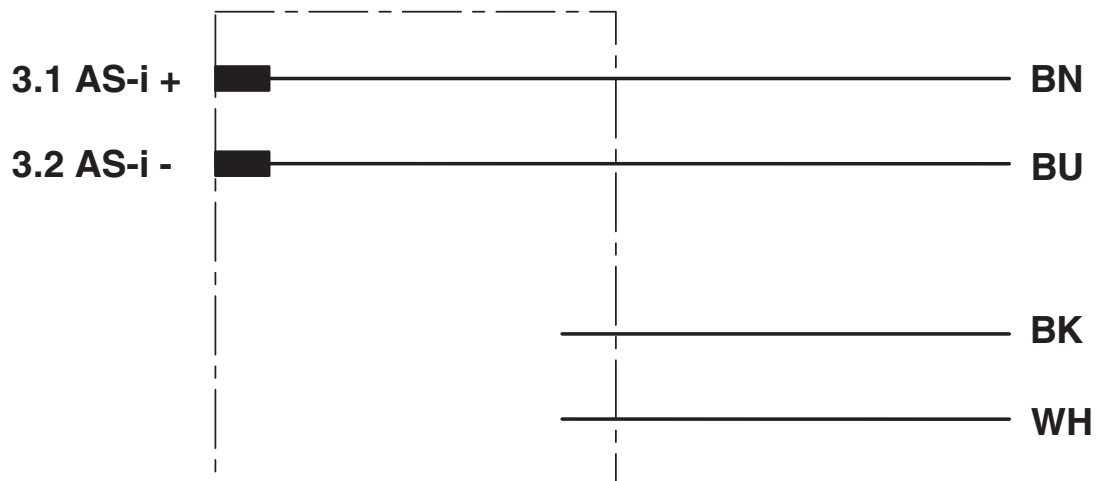


Distance and position of the mounting holes
