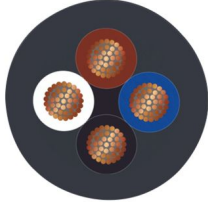

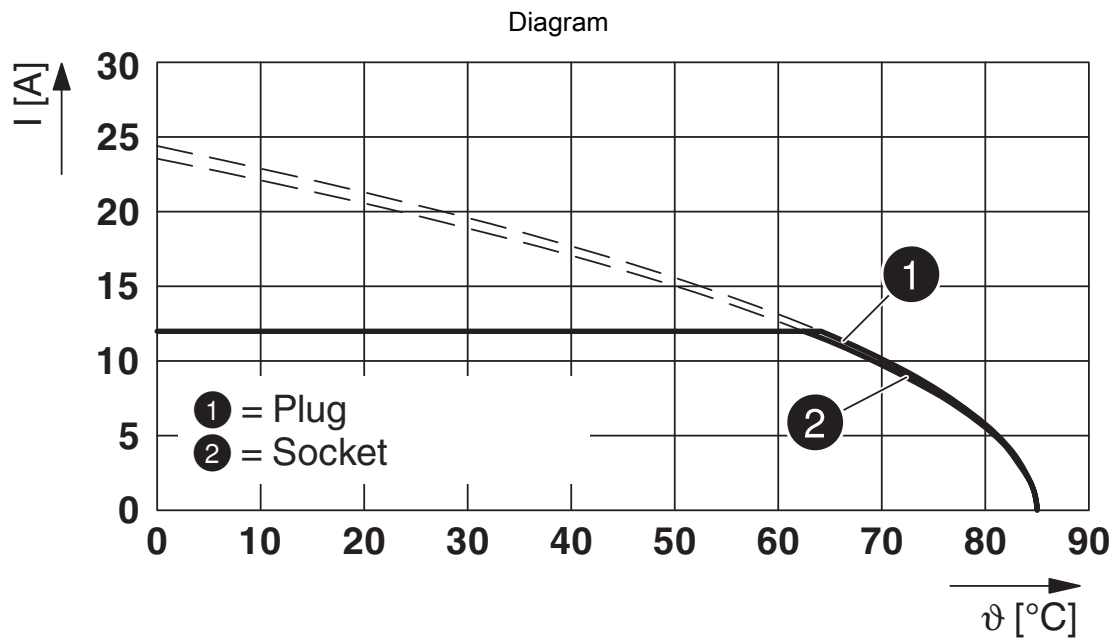


M12 x 1 socket, straight

Schematic diagram

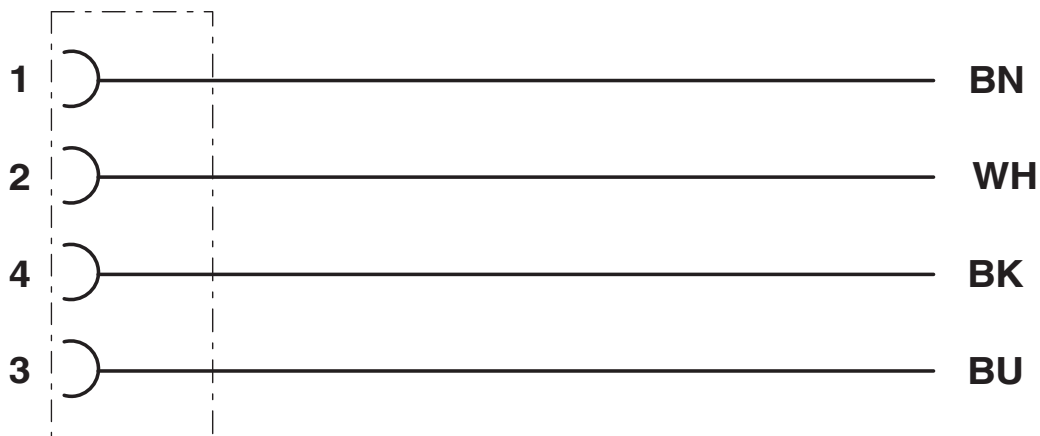


Pin assignment of M12 socket, 4-pos., T-coded, socket side view
