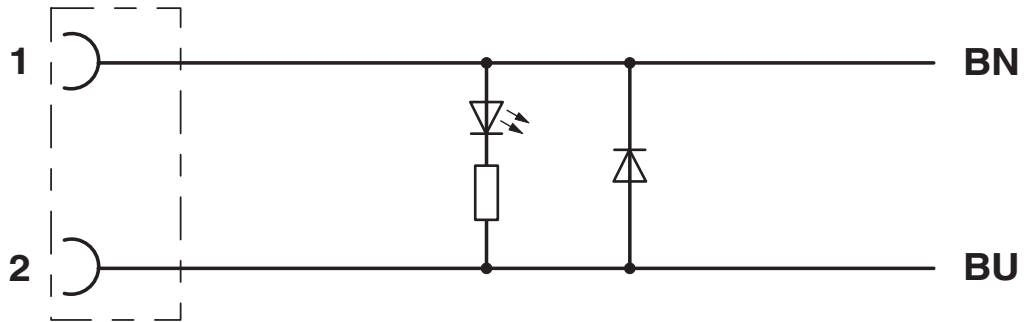
DEUTSCH DT06-2S pin assignment
