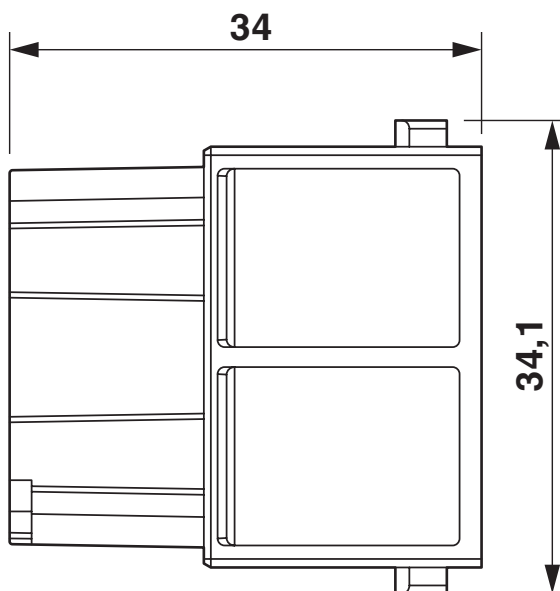

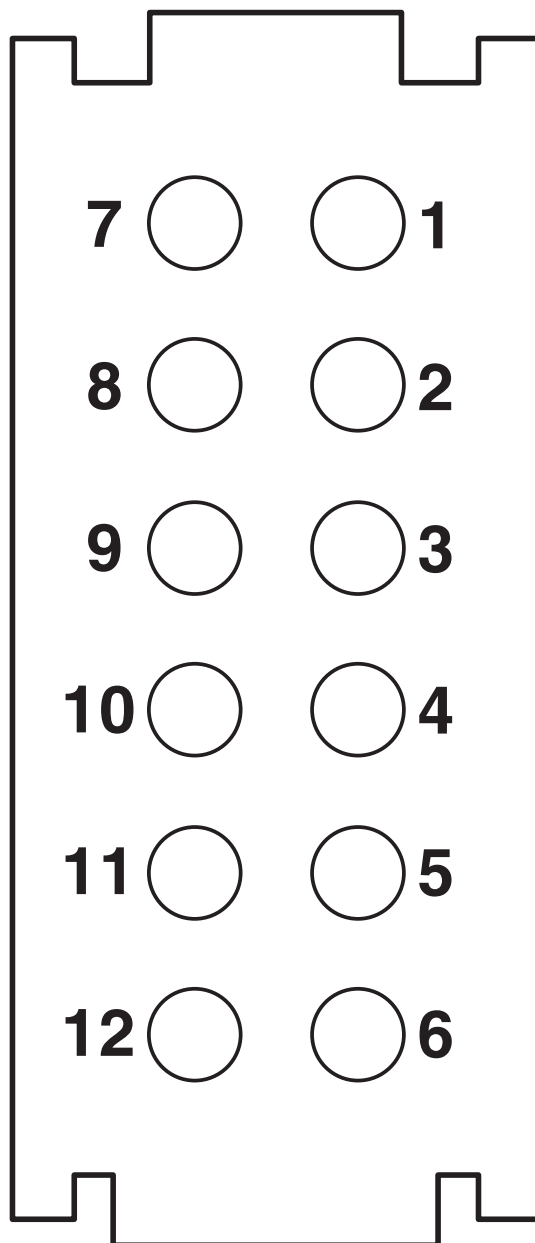

Connector pin assignment, connection side

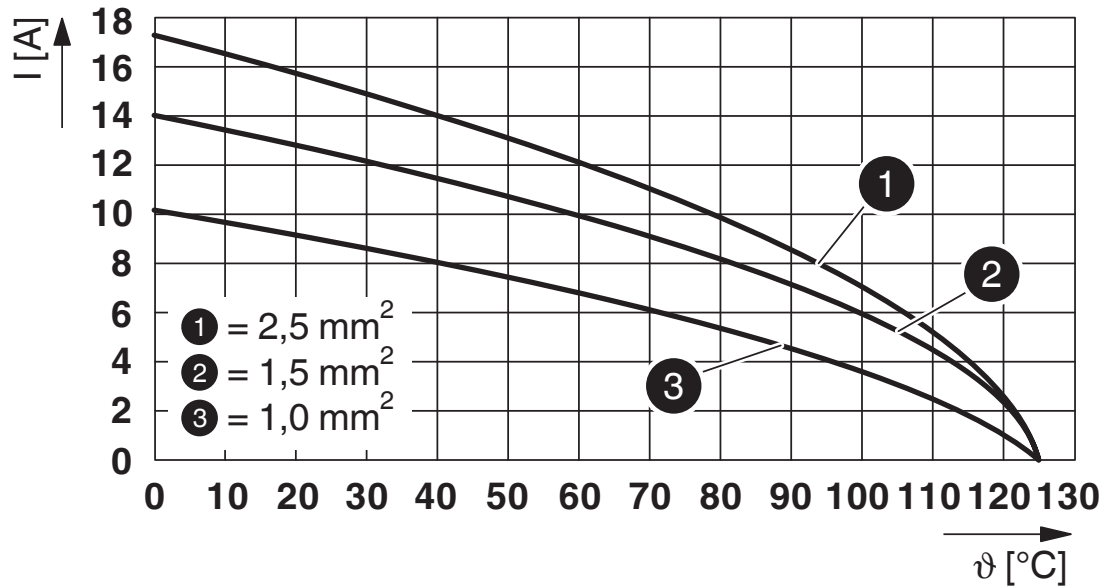
