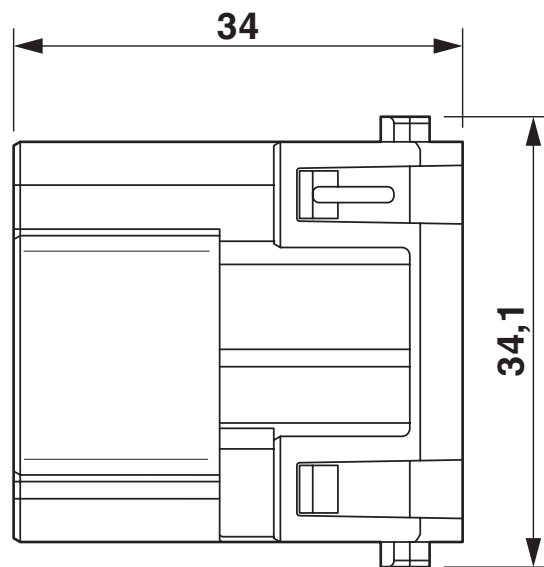

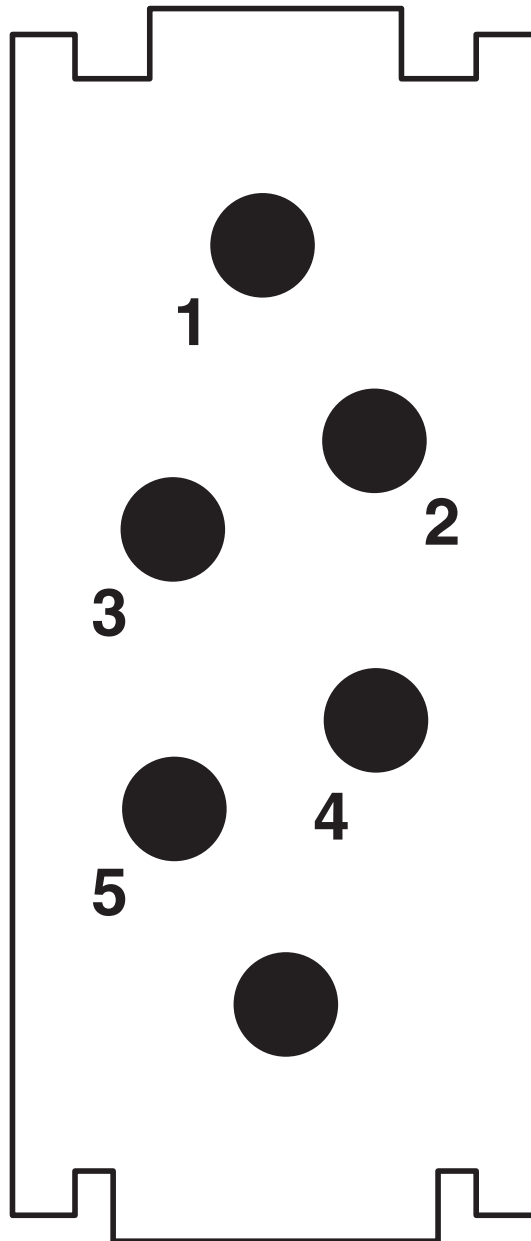

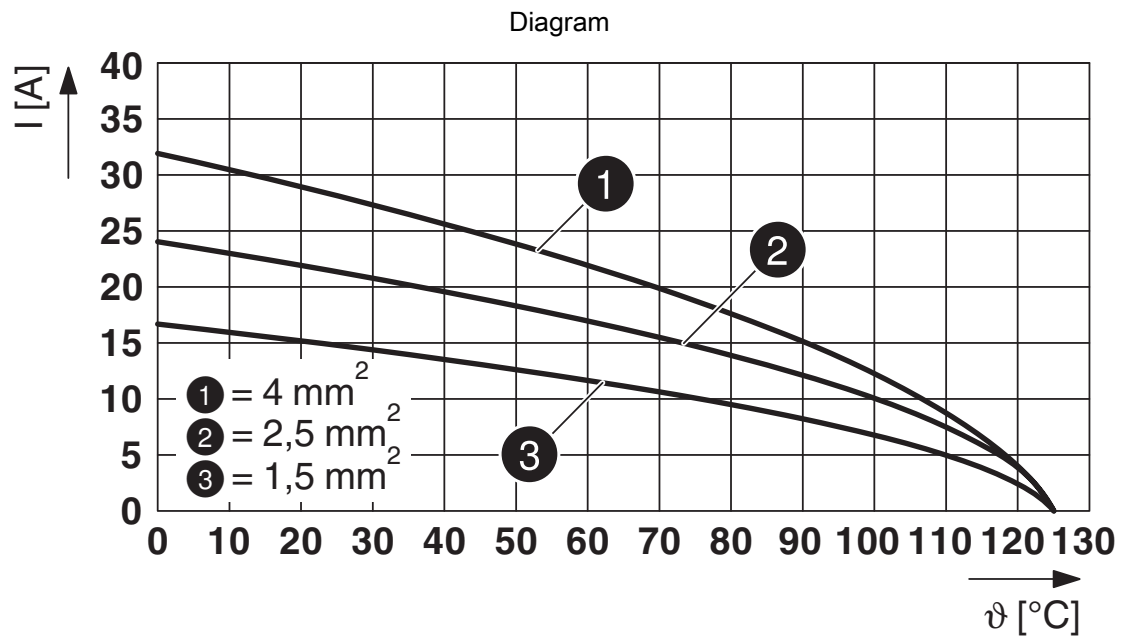
Schematic diagram
