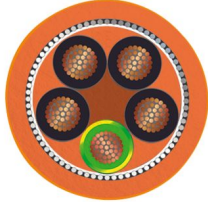

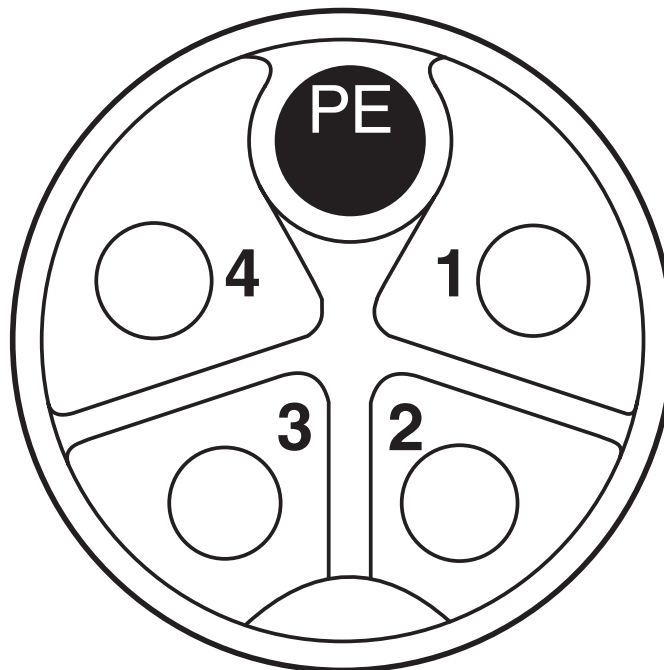

Pin assignment of M12 socket, 5-pos., K-coded, socket side view

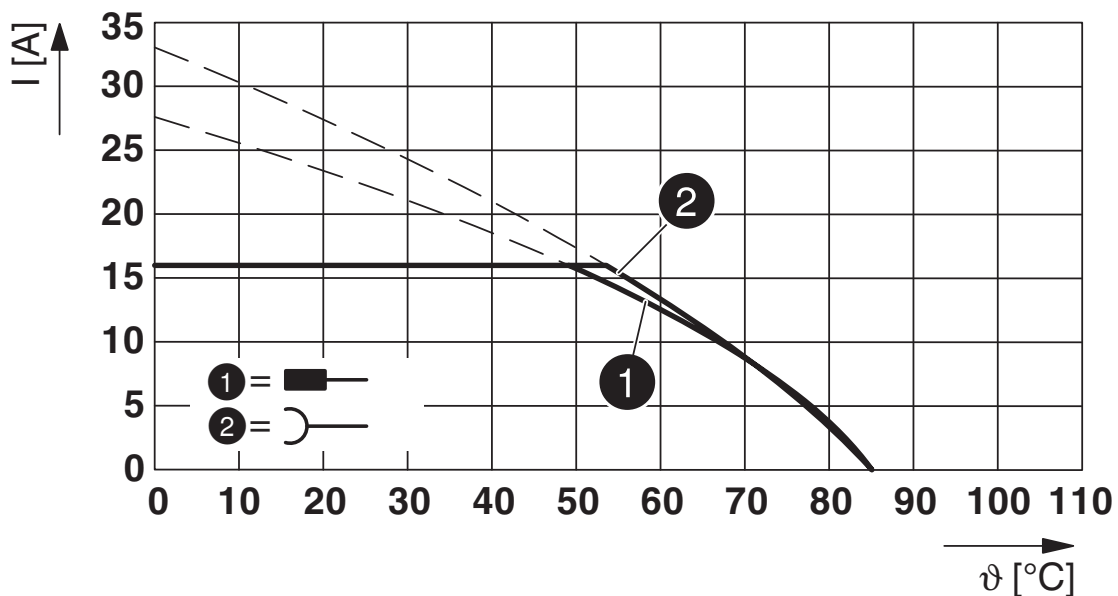

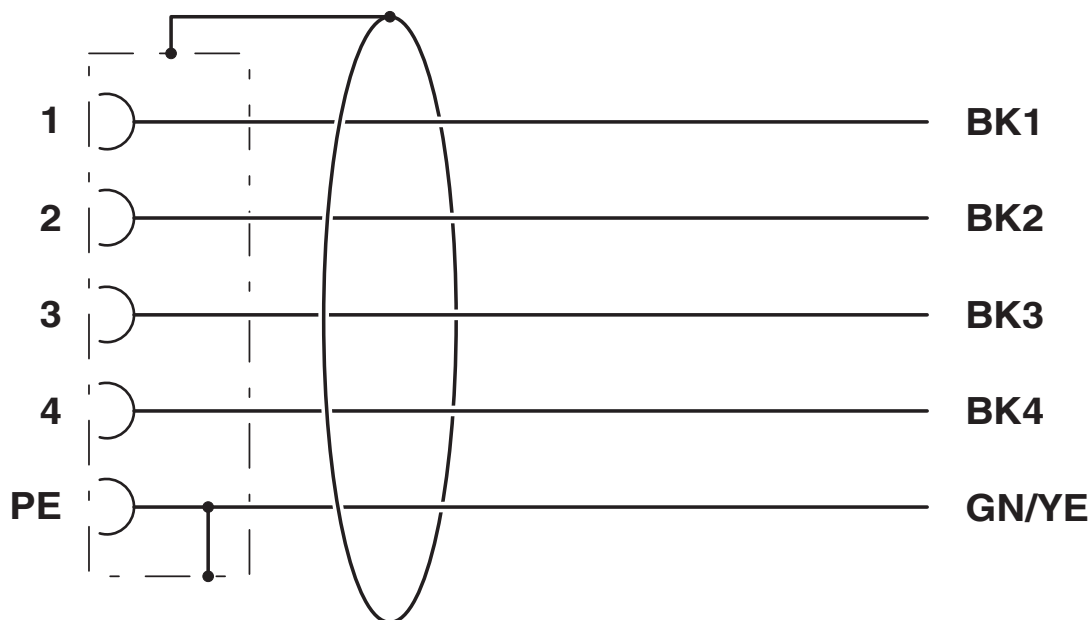
