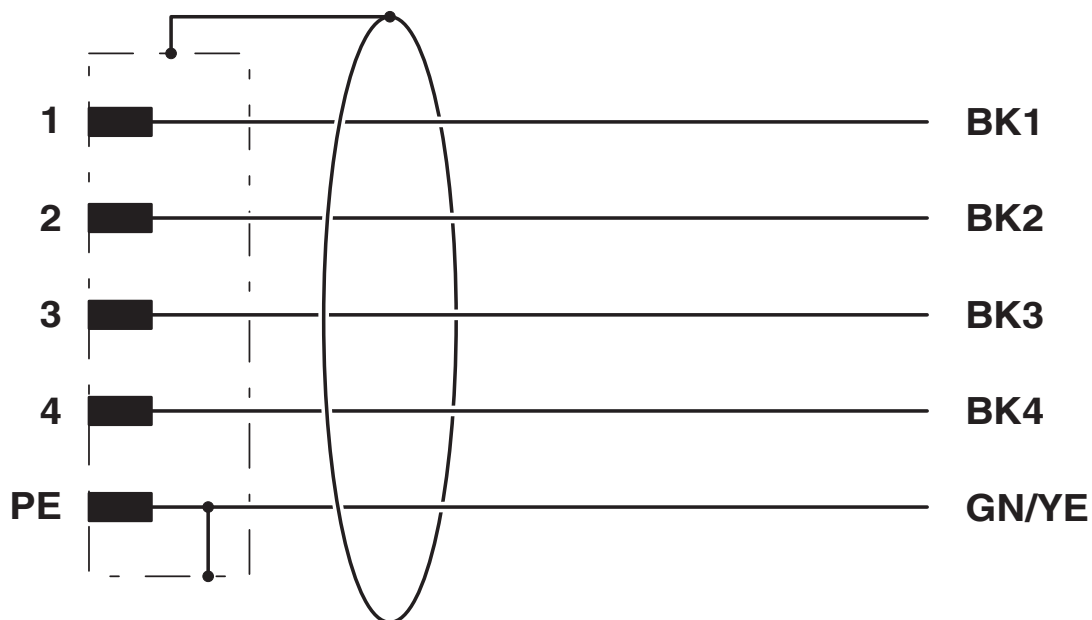


Connector pin assignment of M12 plug, 5-pos., K-coded, pin side view
