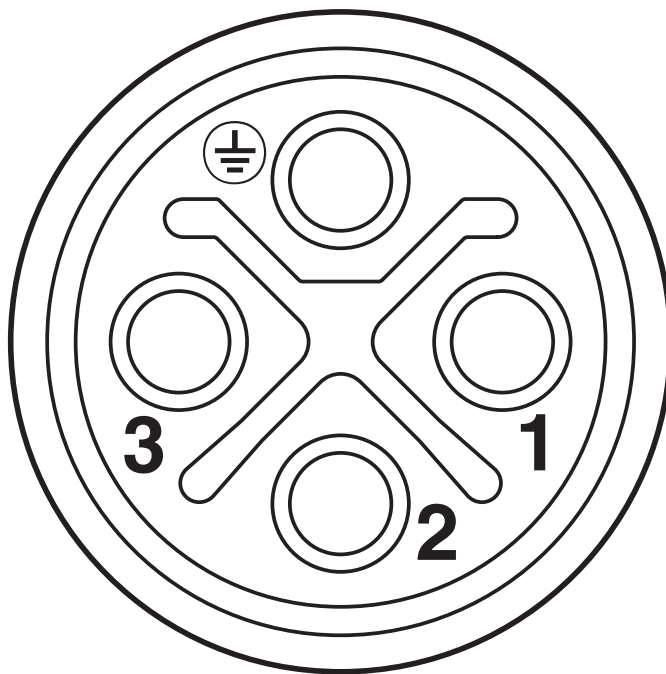


M12 x 1 socket, angled

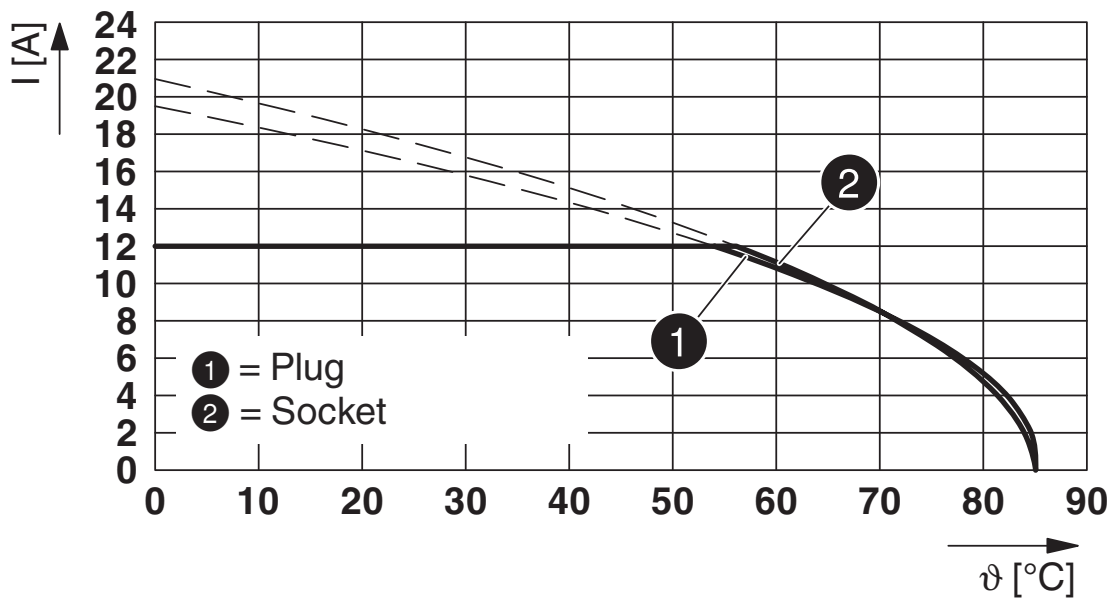

Base curve

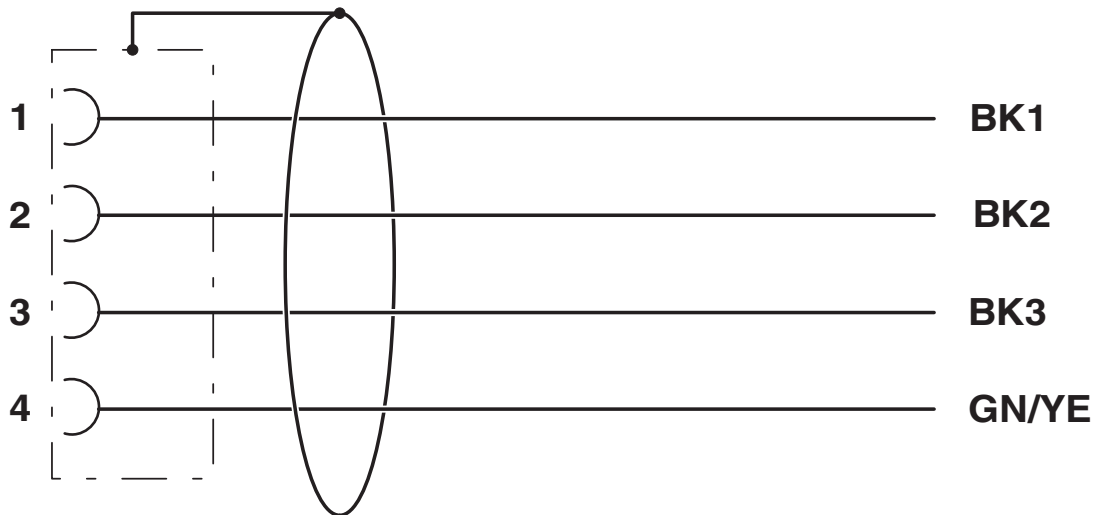
