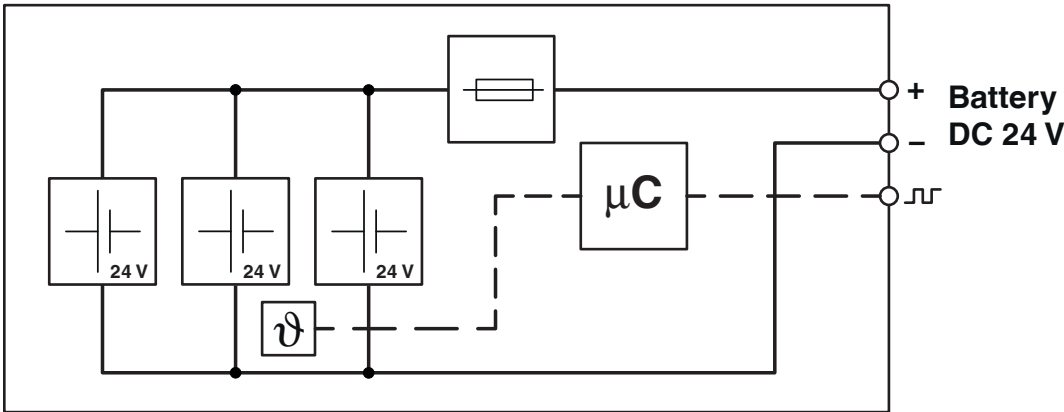

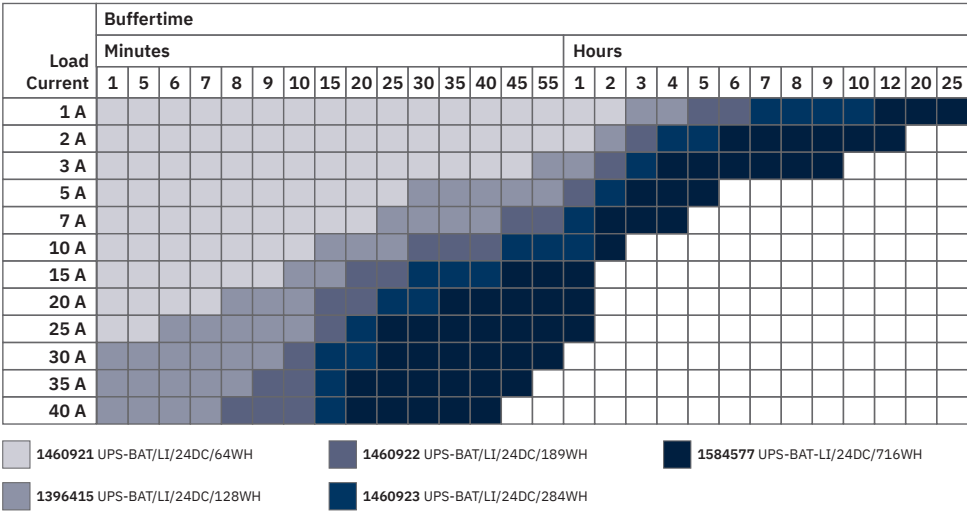

Lithium battery buffer times for QUINT DC UPS

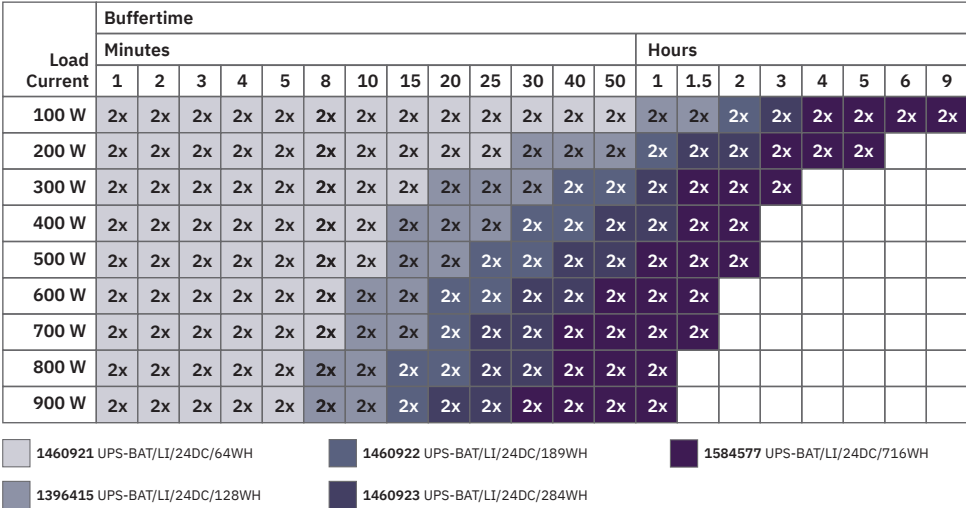

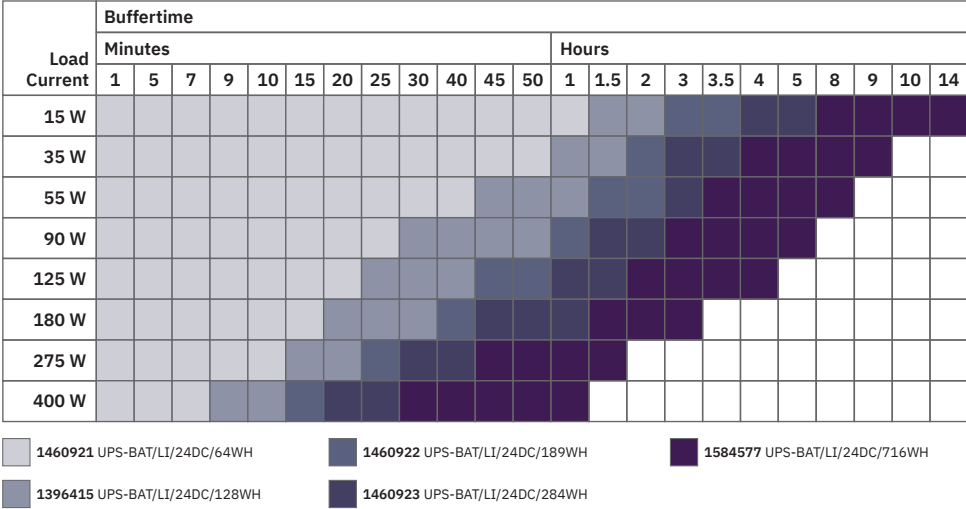
