

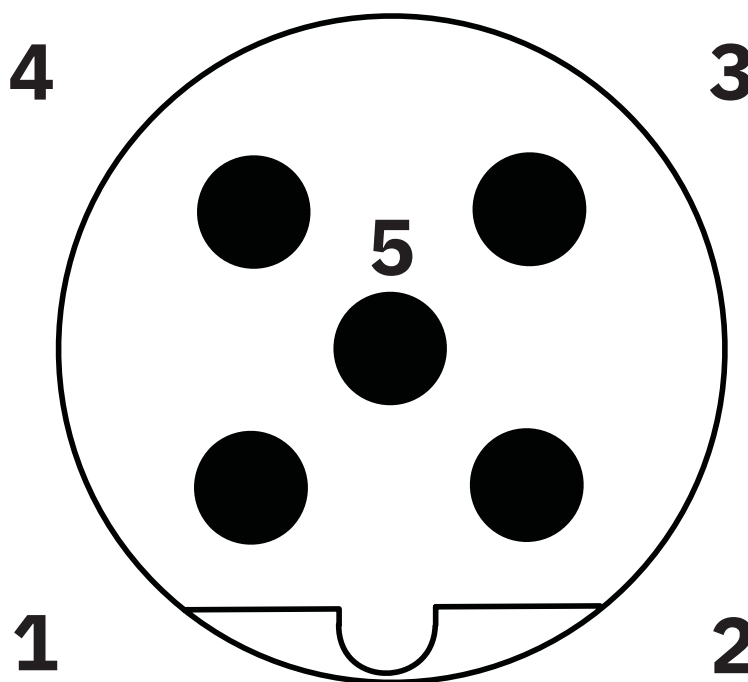

Schematic diagram



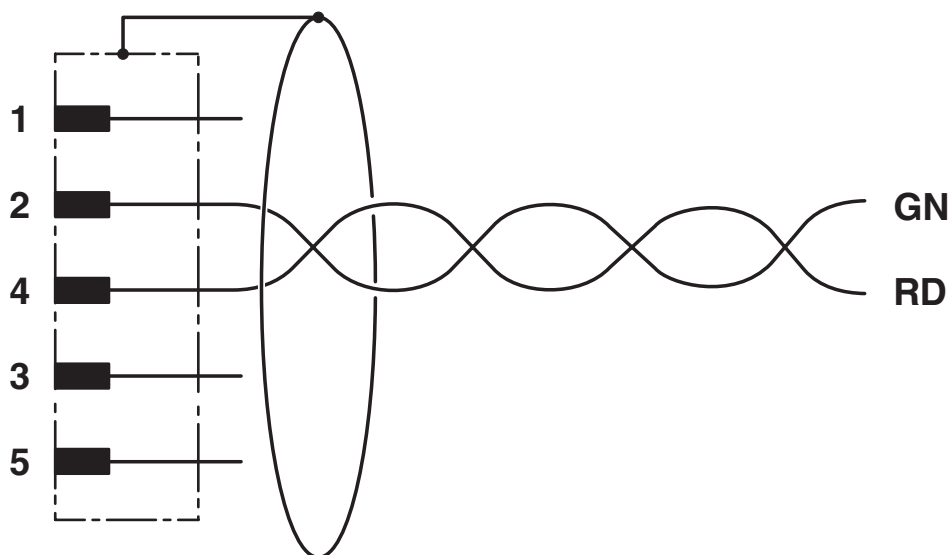
Pin assignment M12 male connector, 5-pos., B-coded, male side
