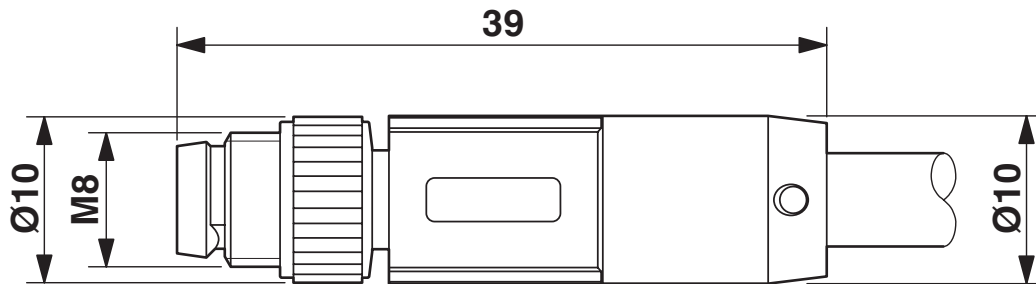

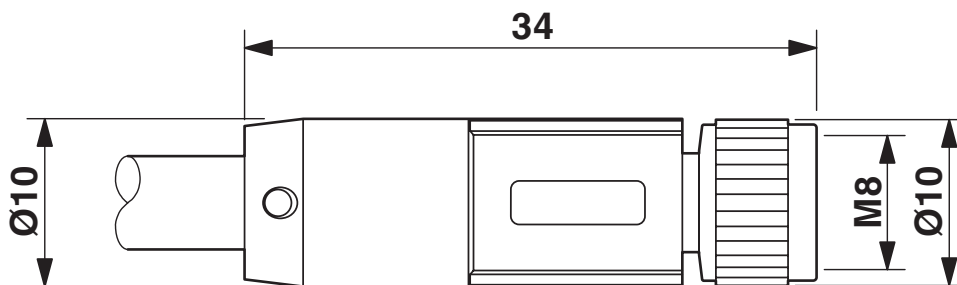

Pin assignment, socket side, M8, 5-pos., B-coded

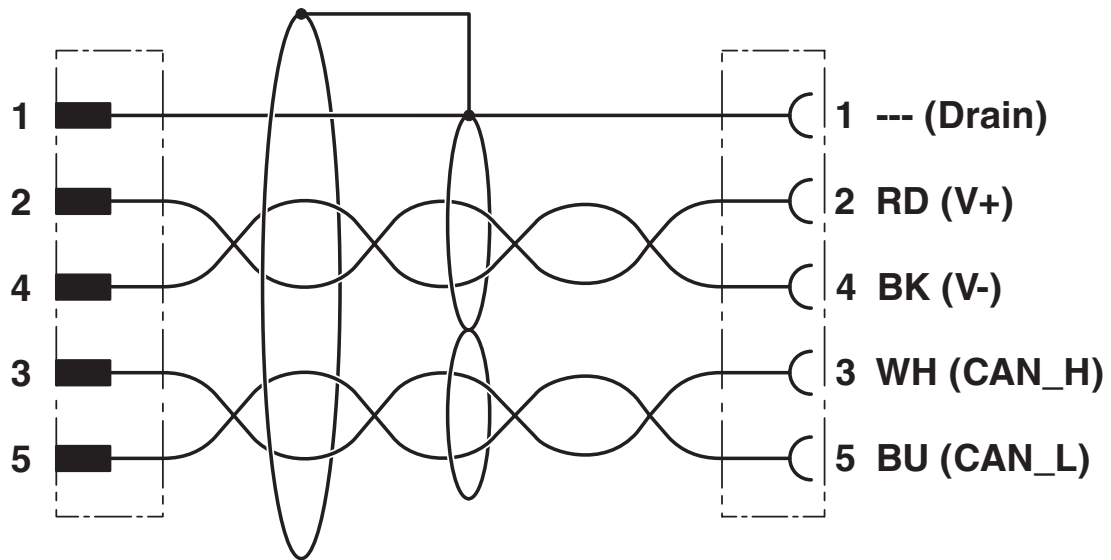
