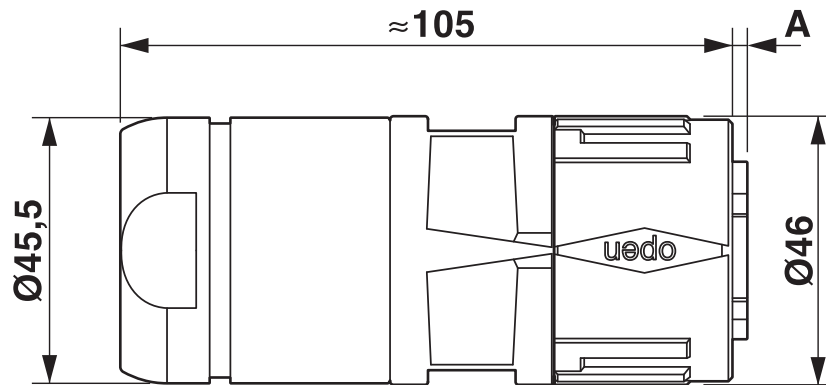

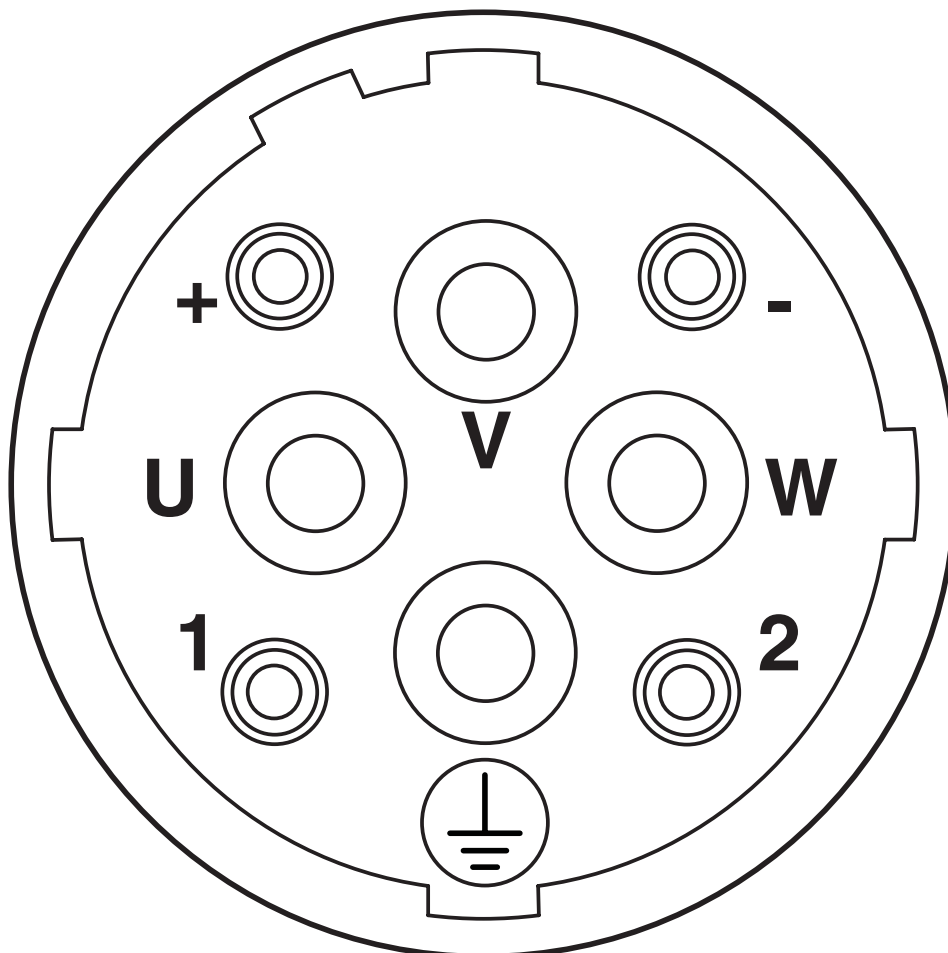

Connector pin assignment

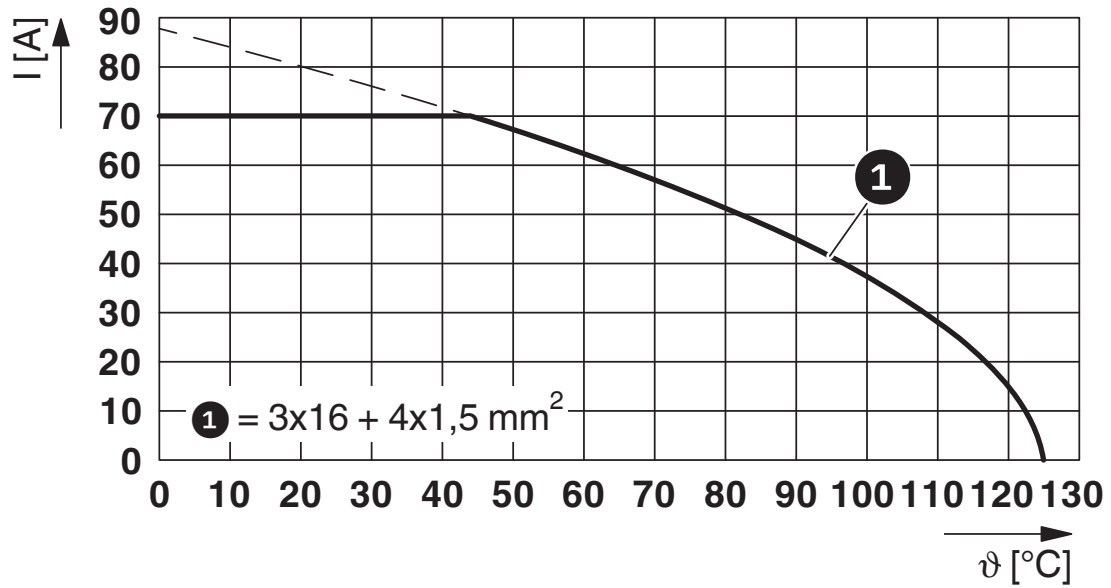
