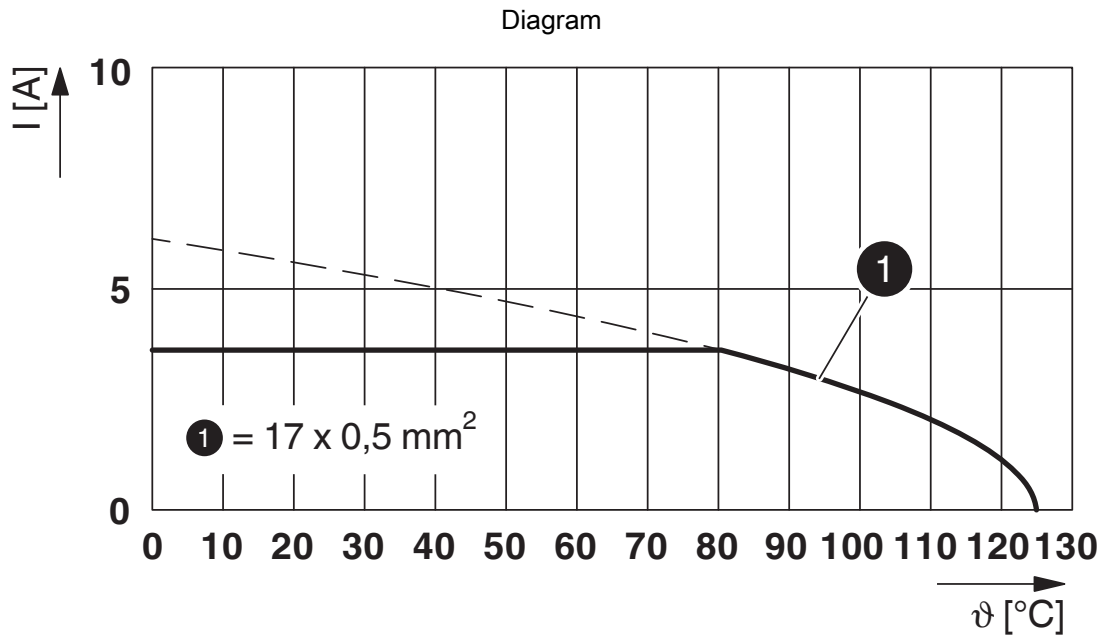


Connector pin assignment
