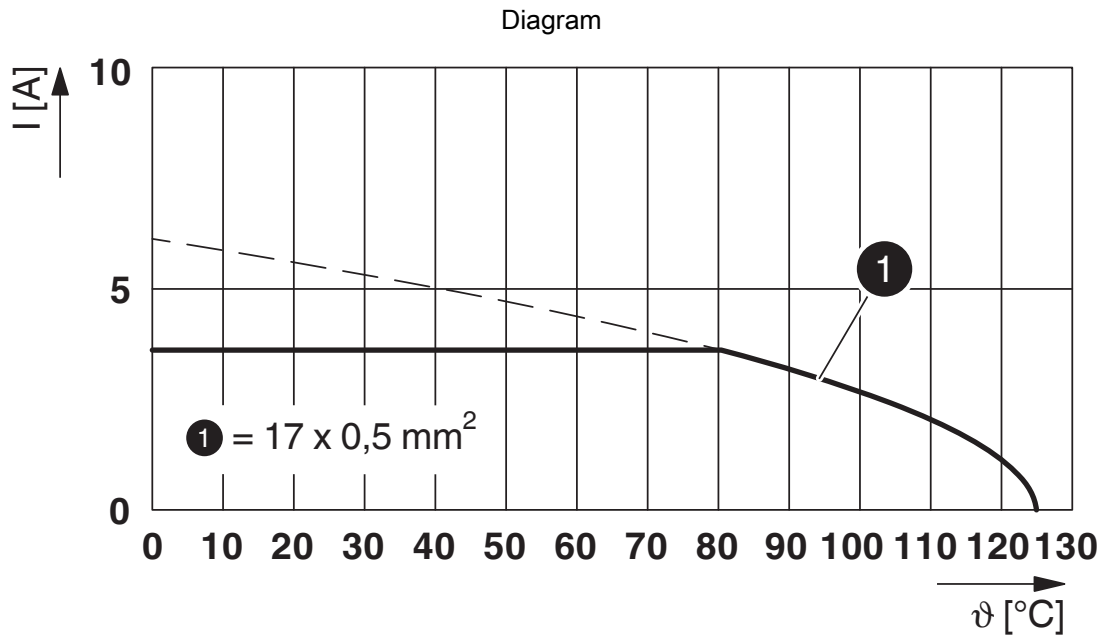
Connector pin assignment
