

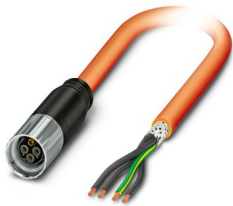

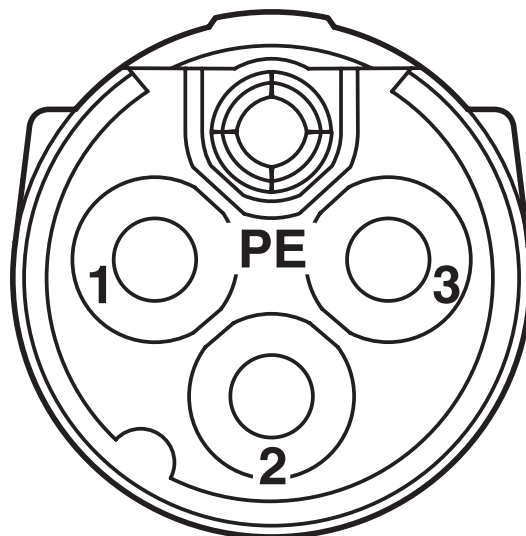

Schematic diagram



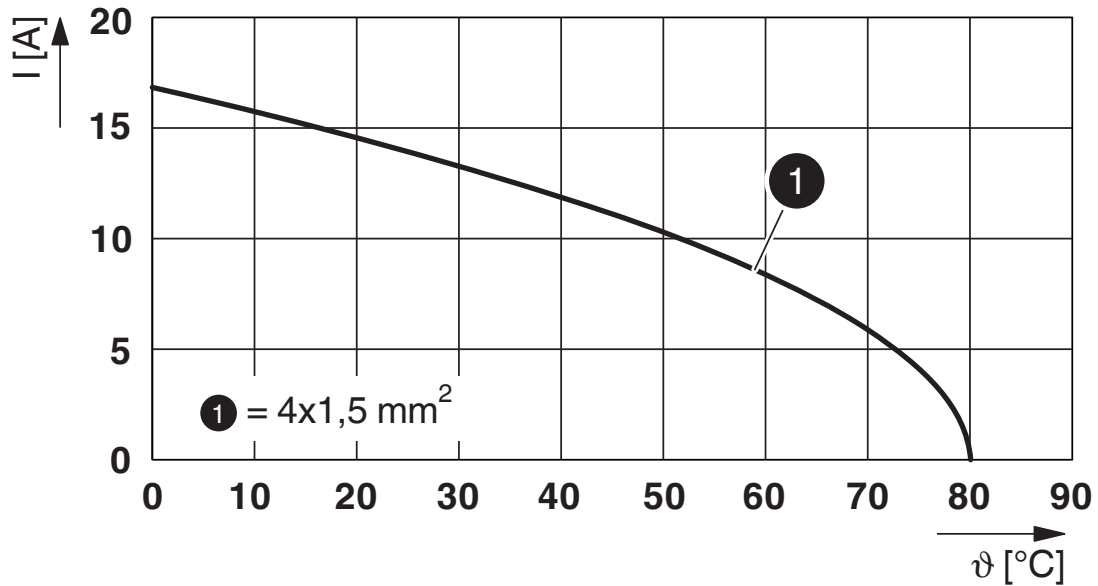
Socket pin assignment

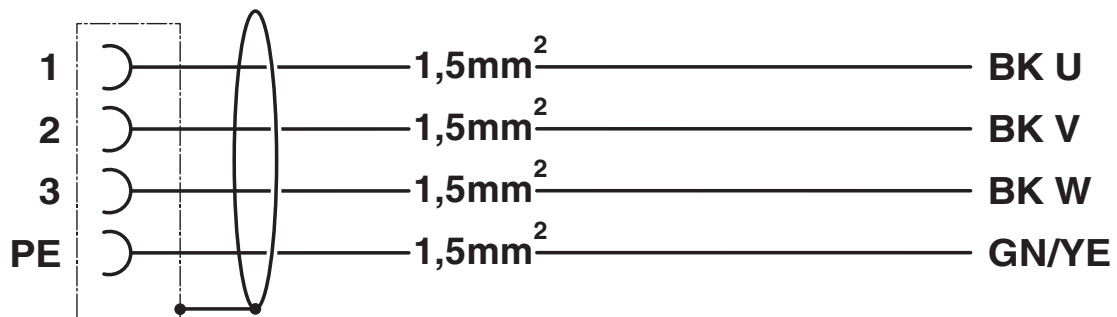
