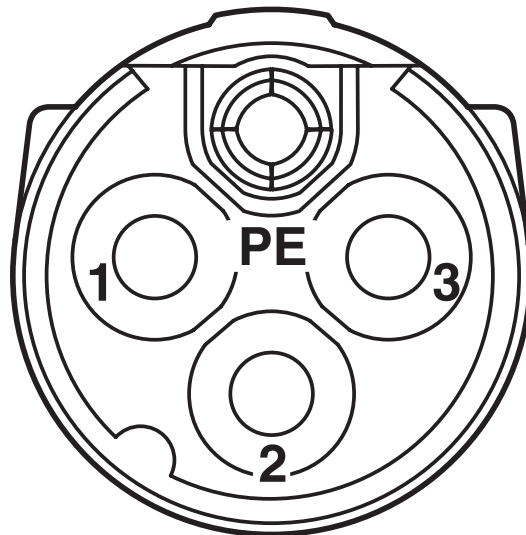

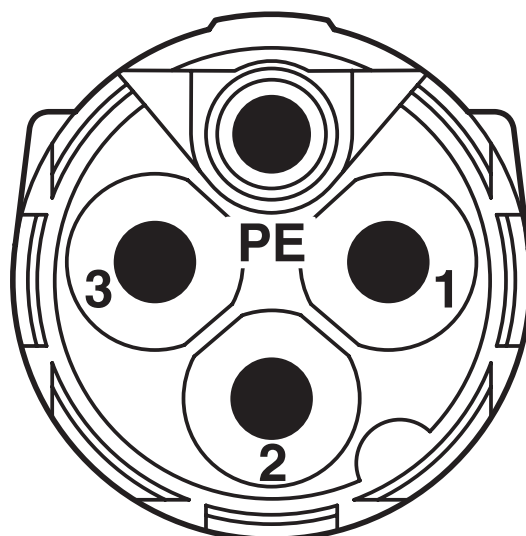

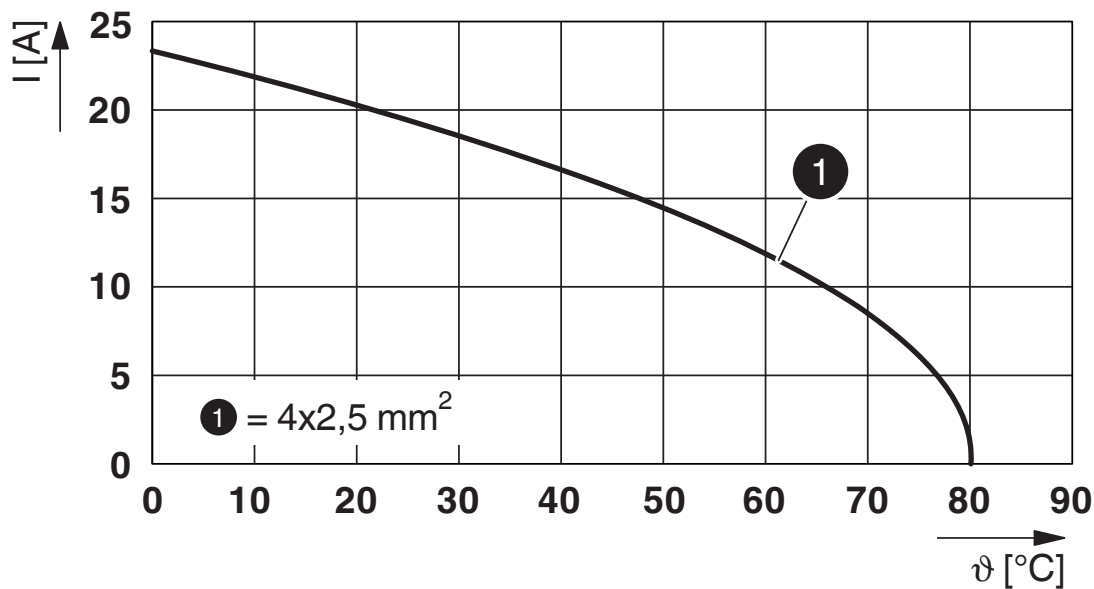
Pin assignment of pin
