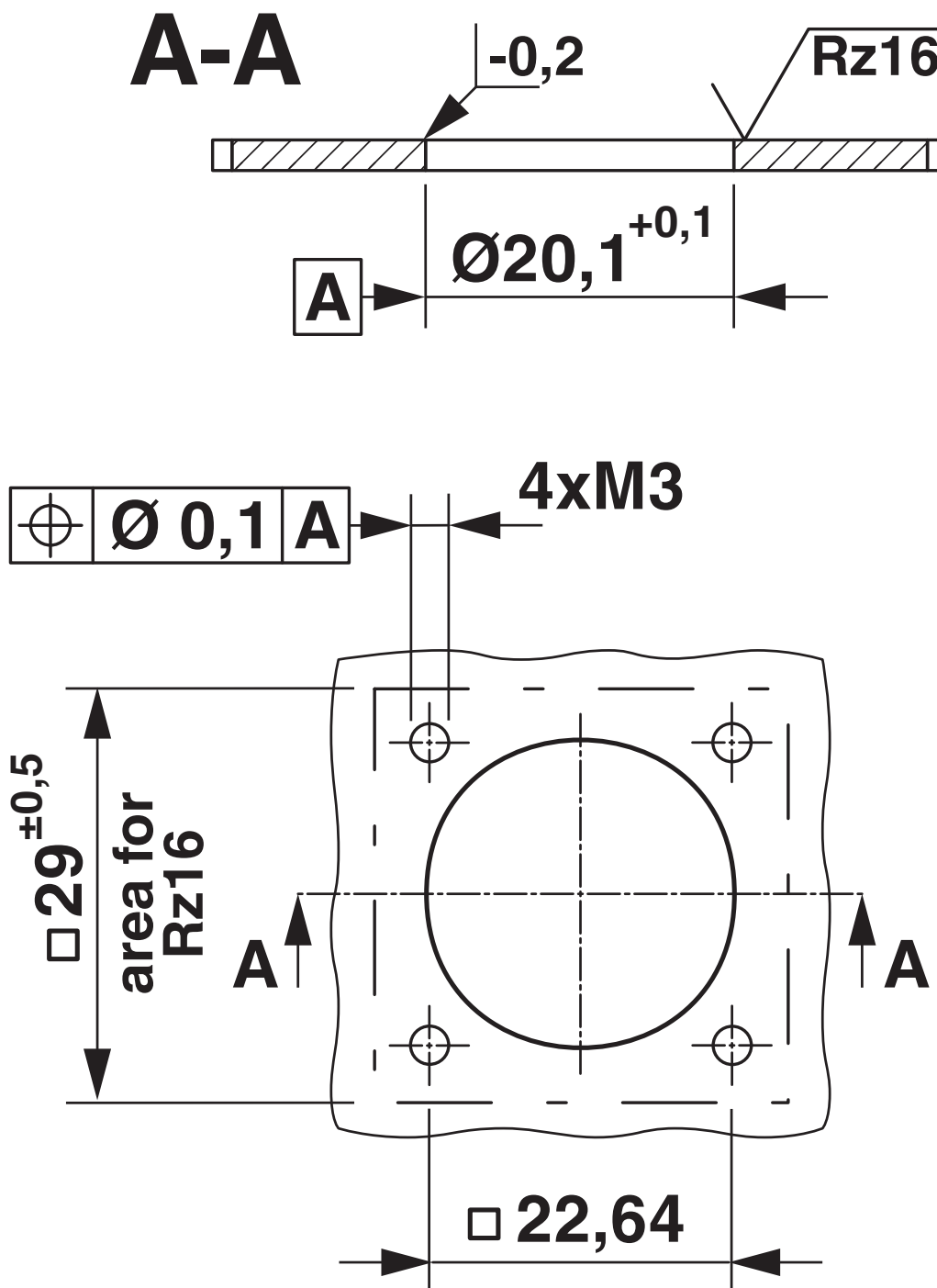

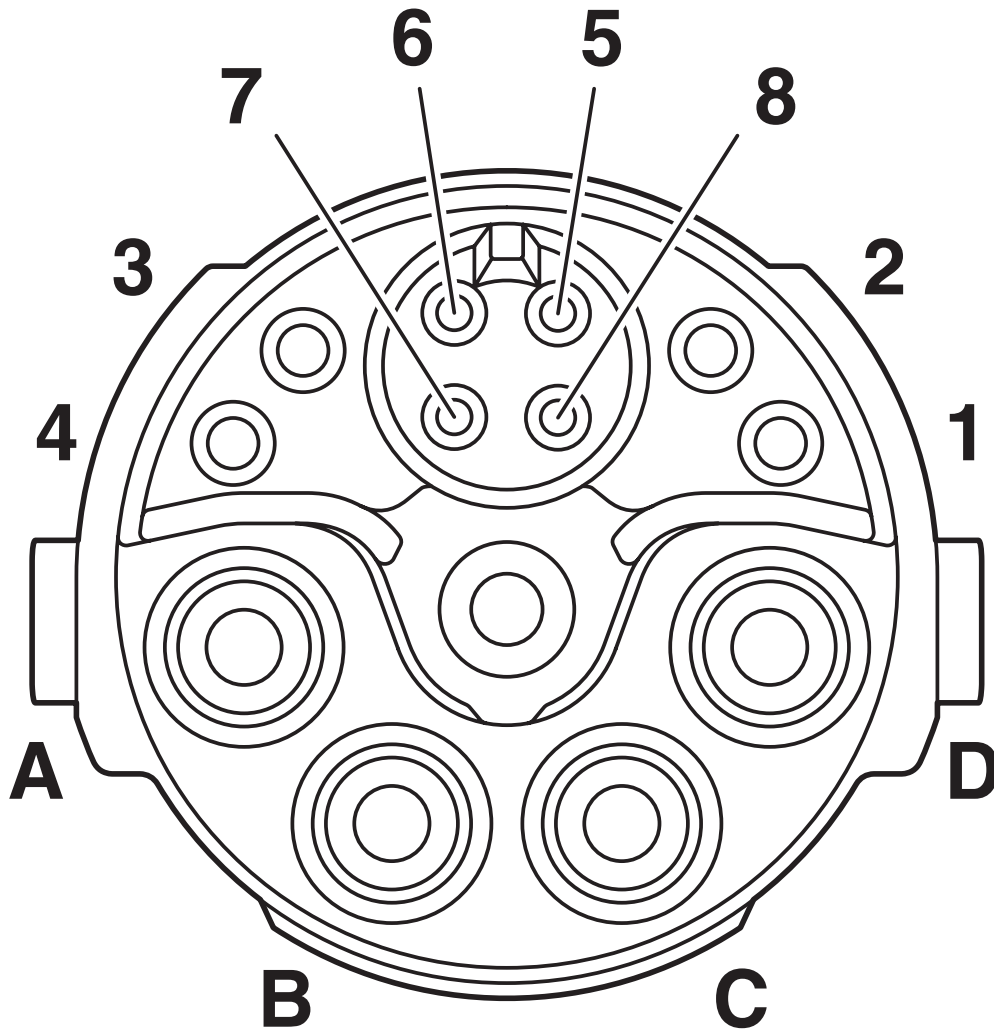

Schematic diagram



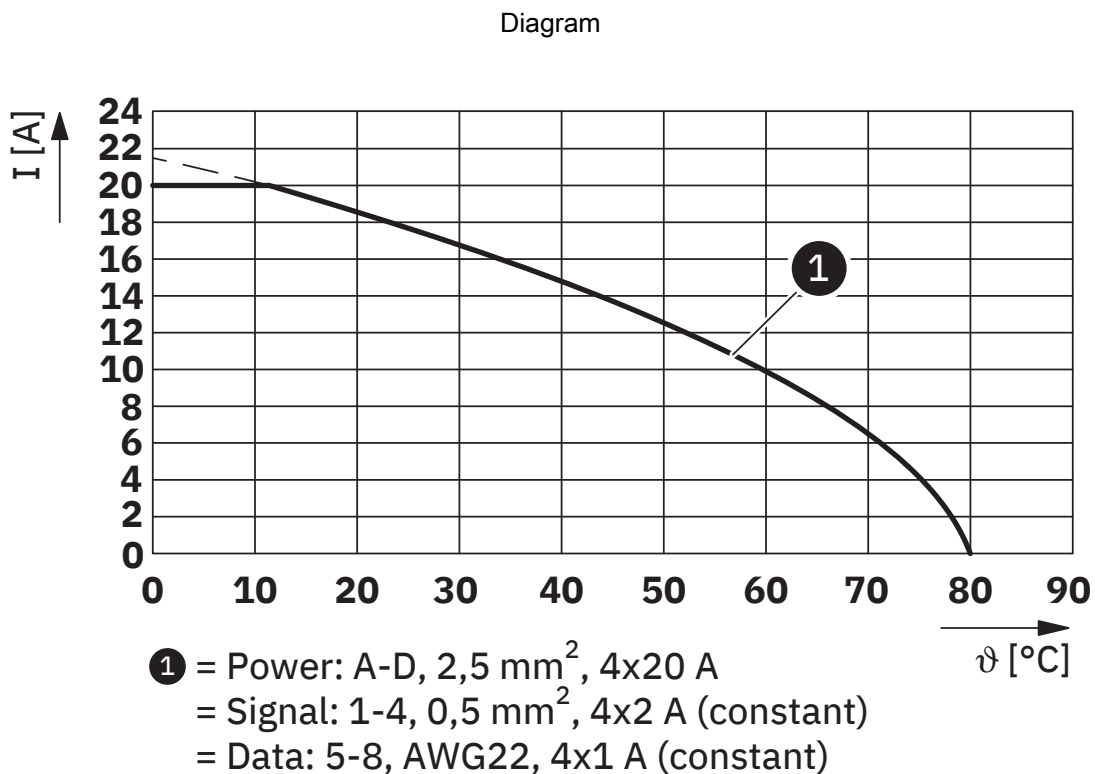

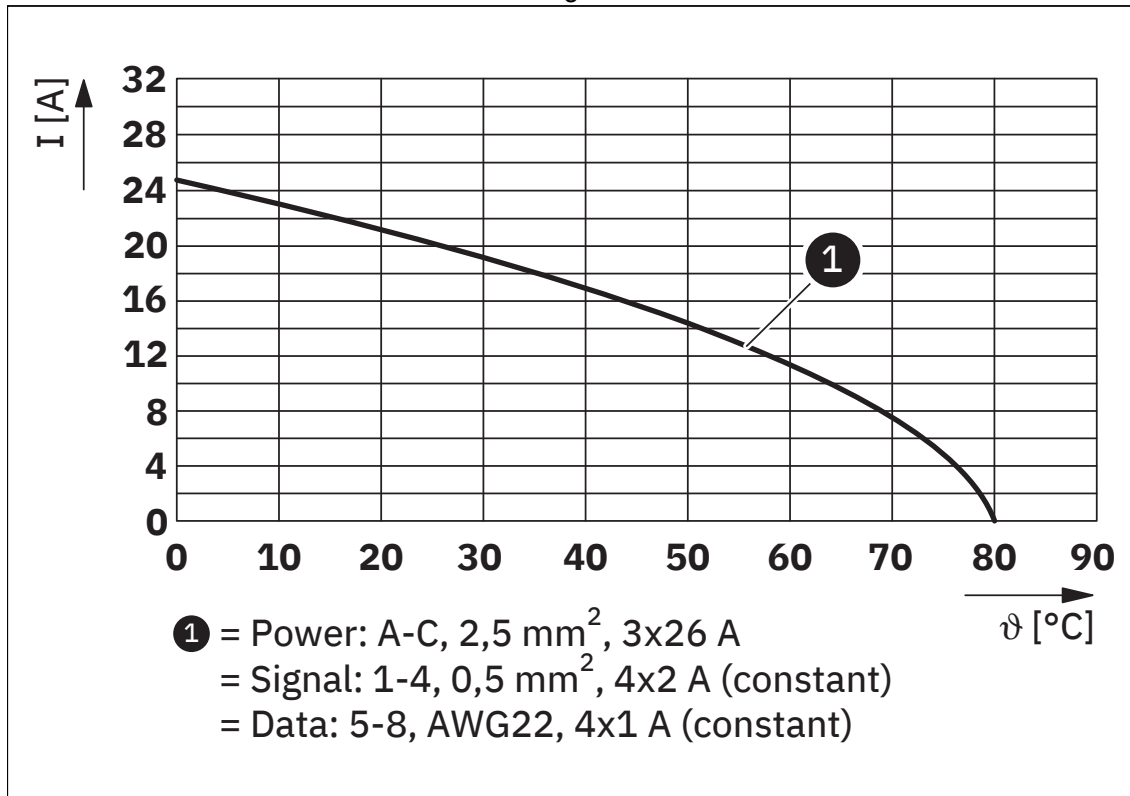
