

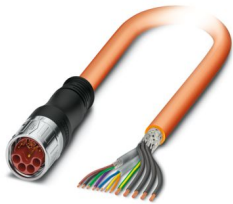

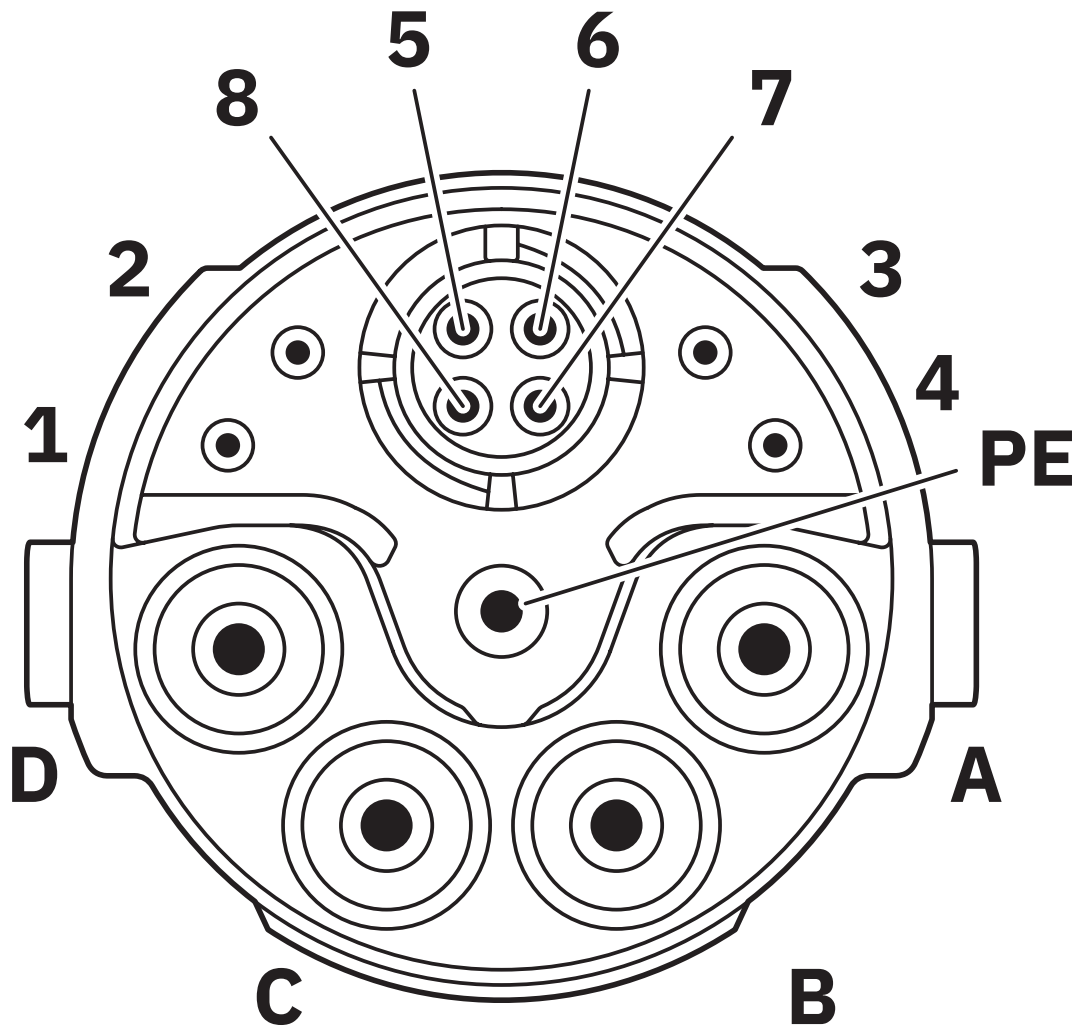

Pin assignment of pin

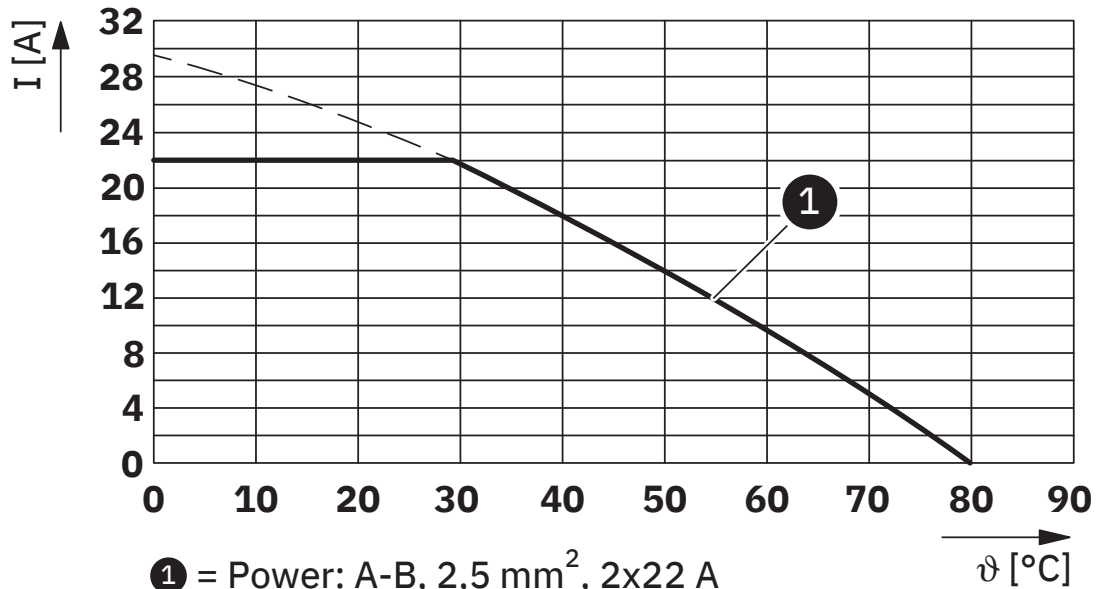

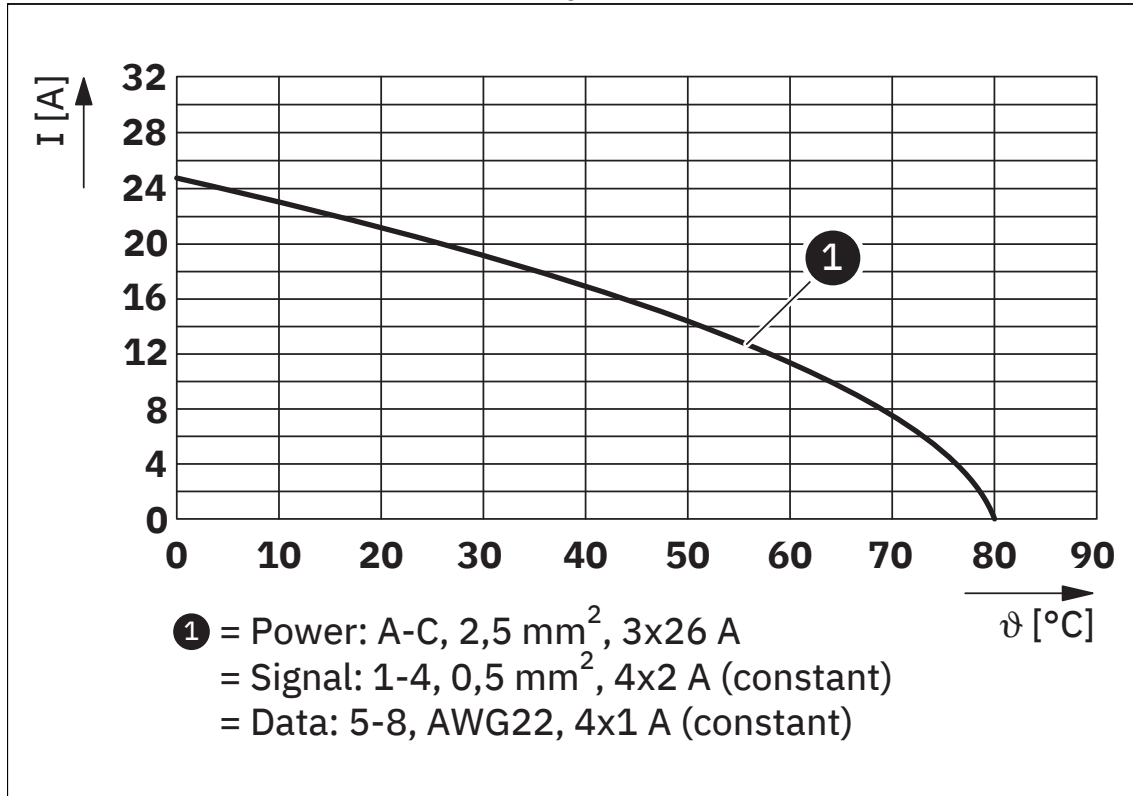
