

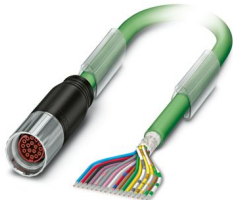

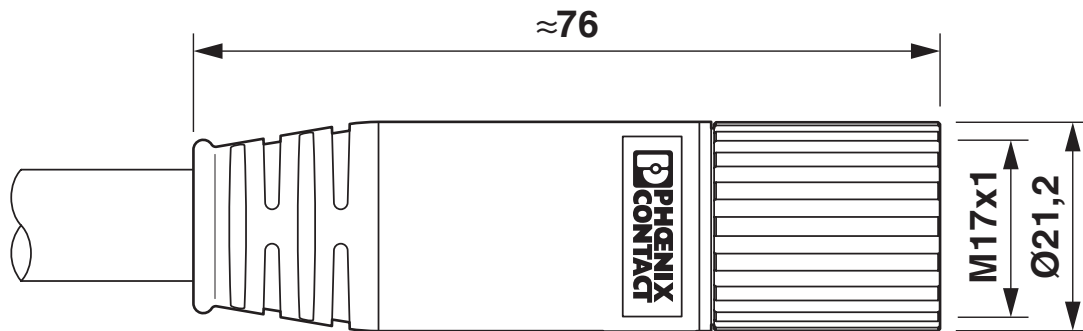

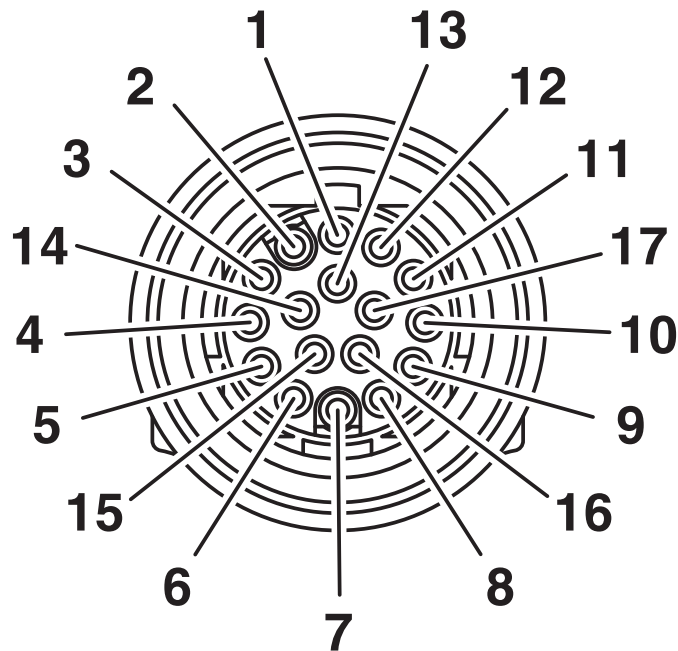

Socket pin assignment

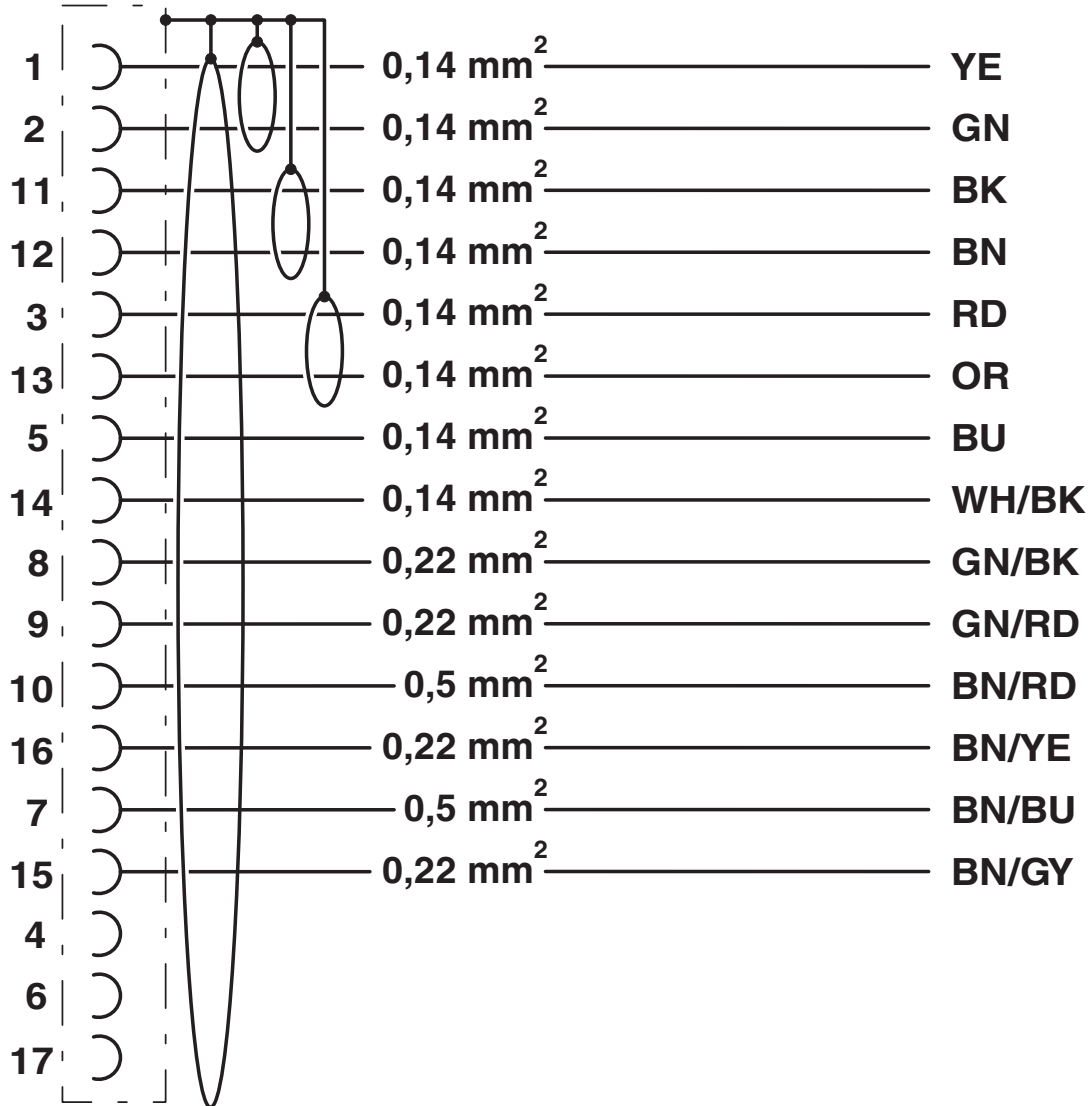
