Connector pin assignment

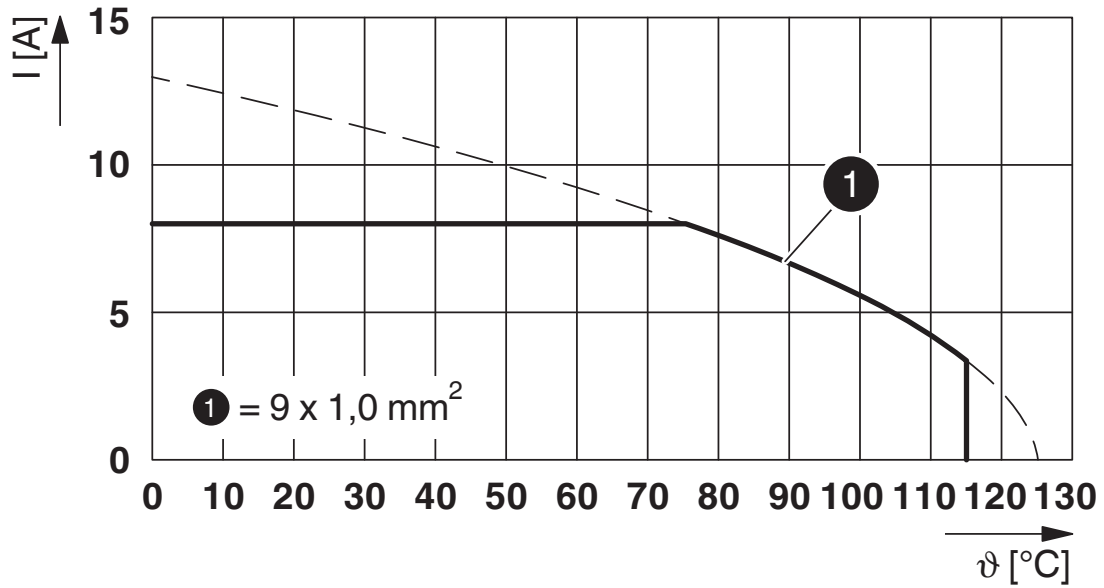
