Connector pin assignment

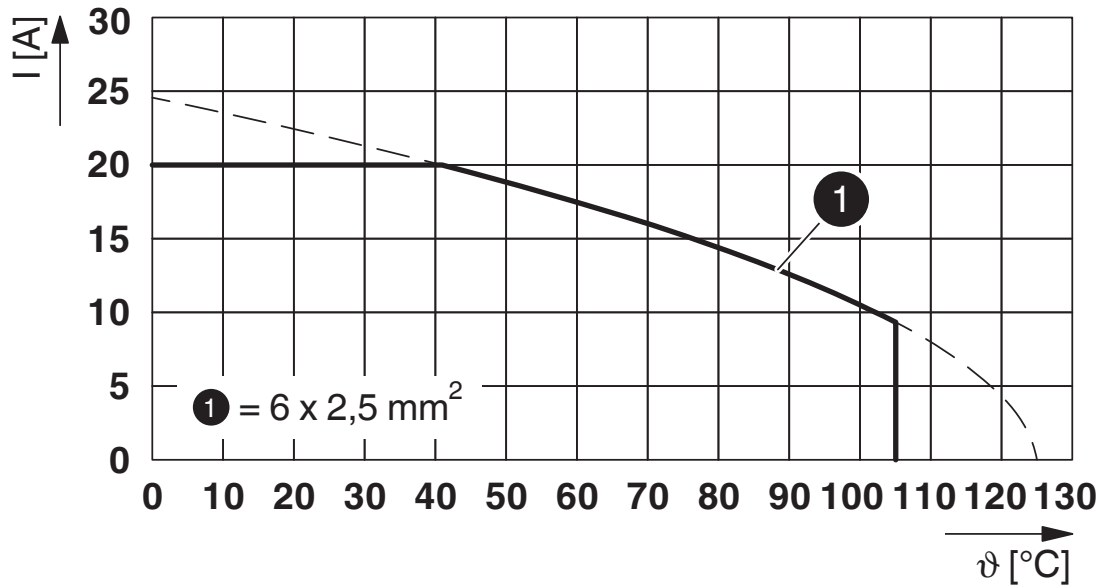
