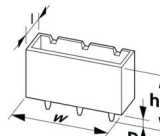

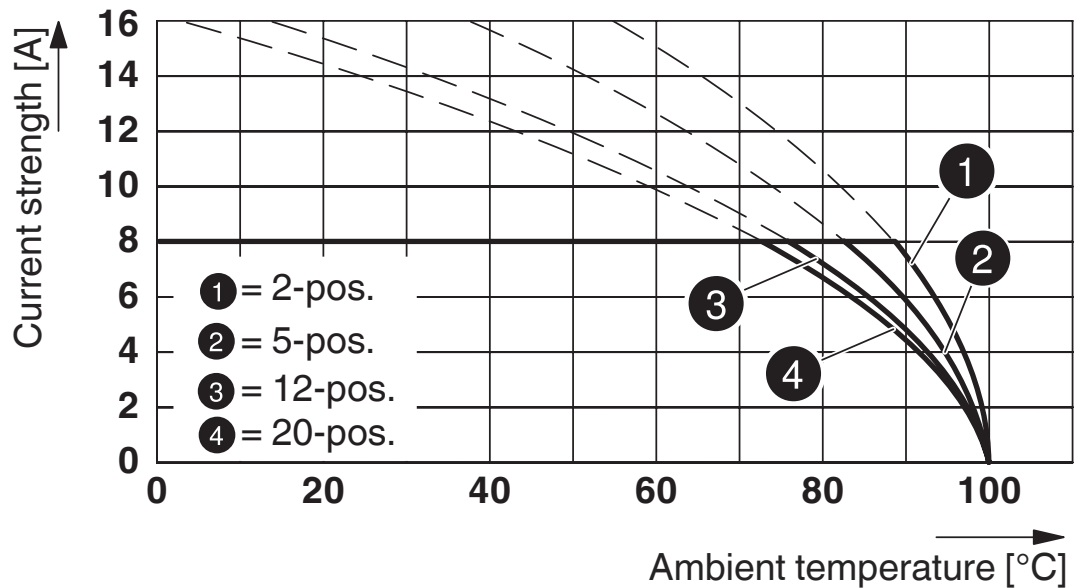

Type: MC 1,5/...-ST-3,81 with MCV 1,5/...-G-3,81



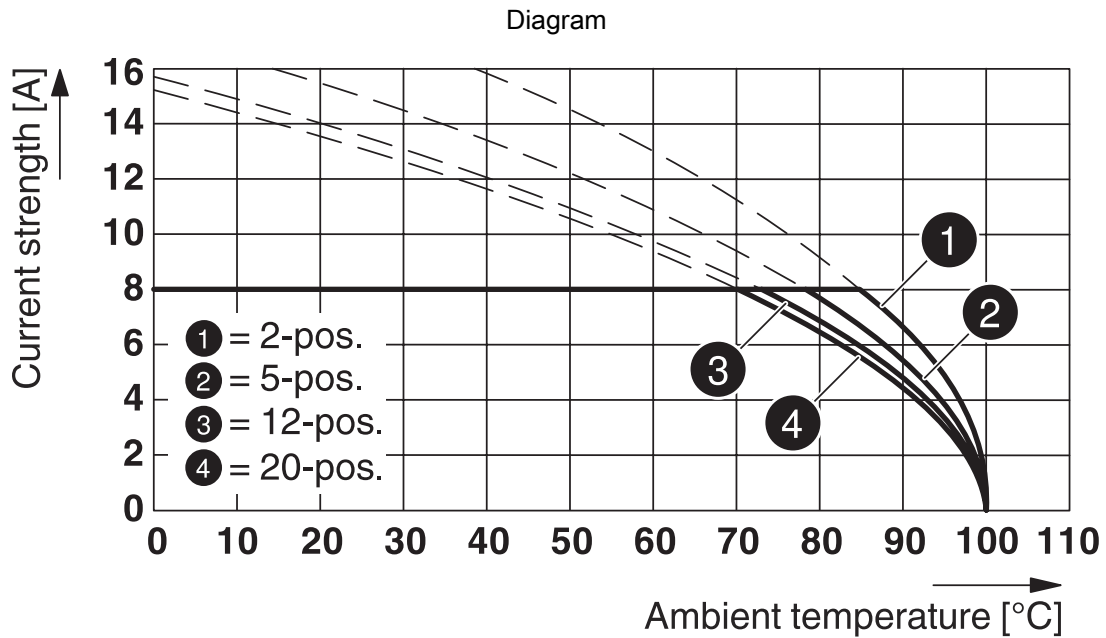
Type: FRONT-MC 1,5/...-ST-3,81 with MCV 1,5/...-G-3,81



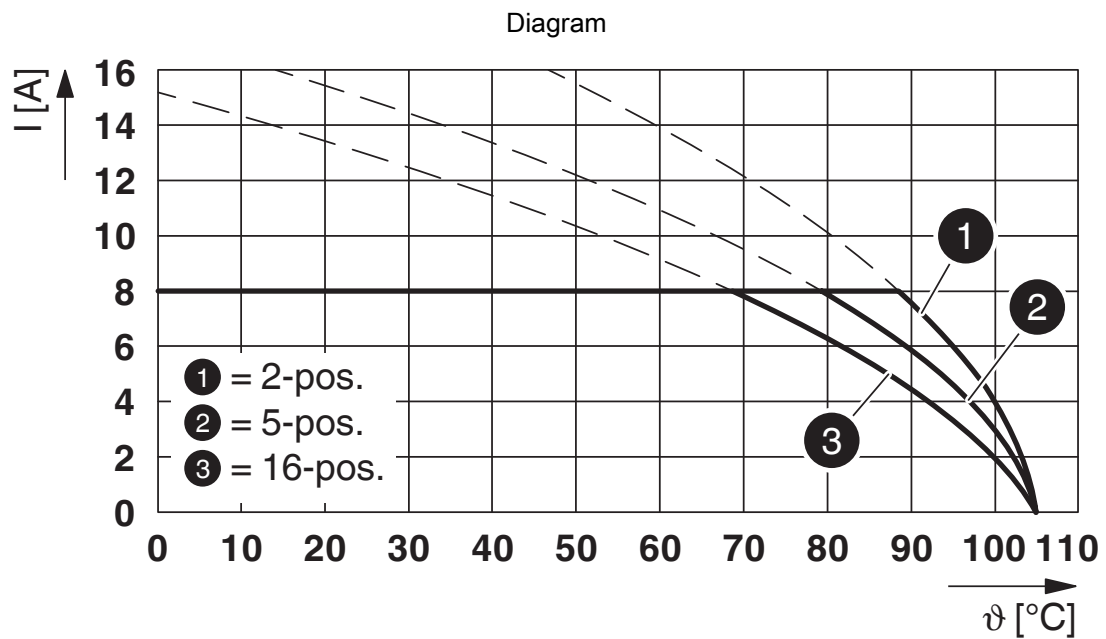
