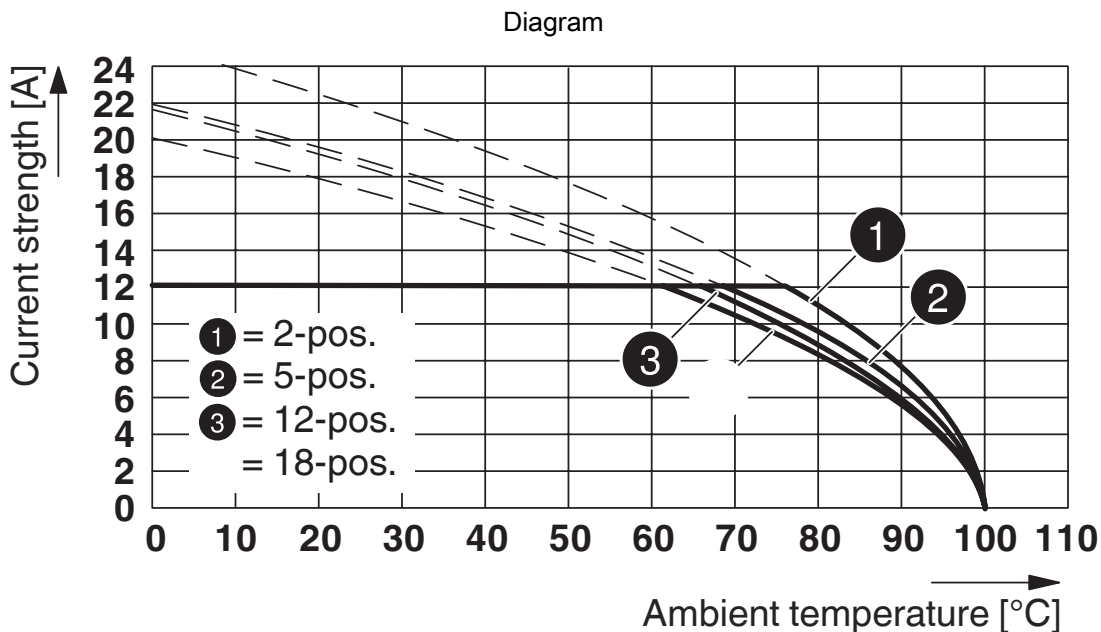

Type: MSTBT 2,5/...-ST with MSTBW 2,5/...-G



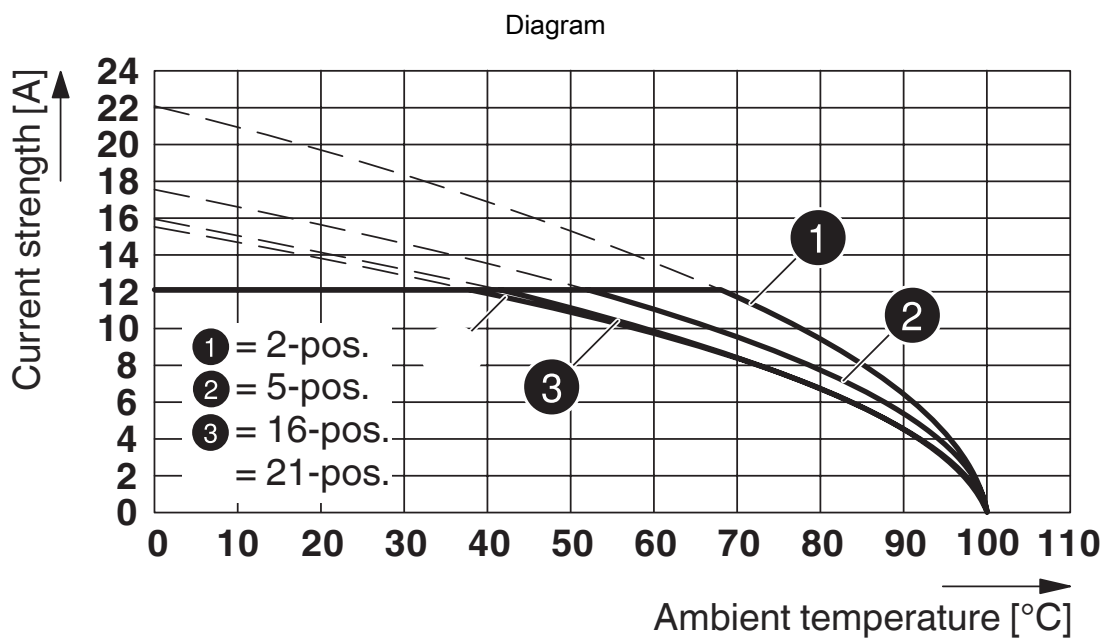

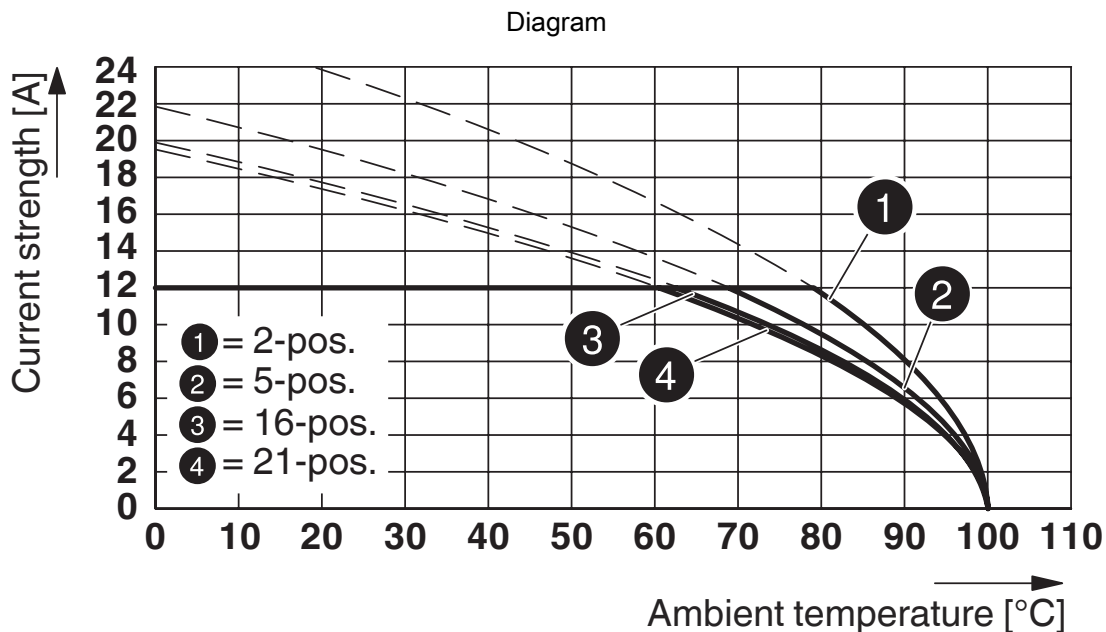

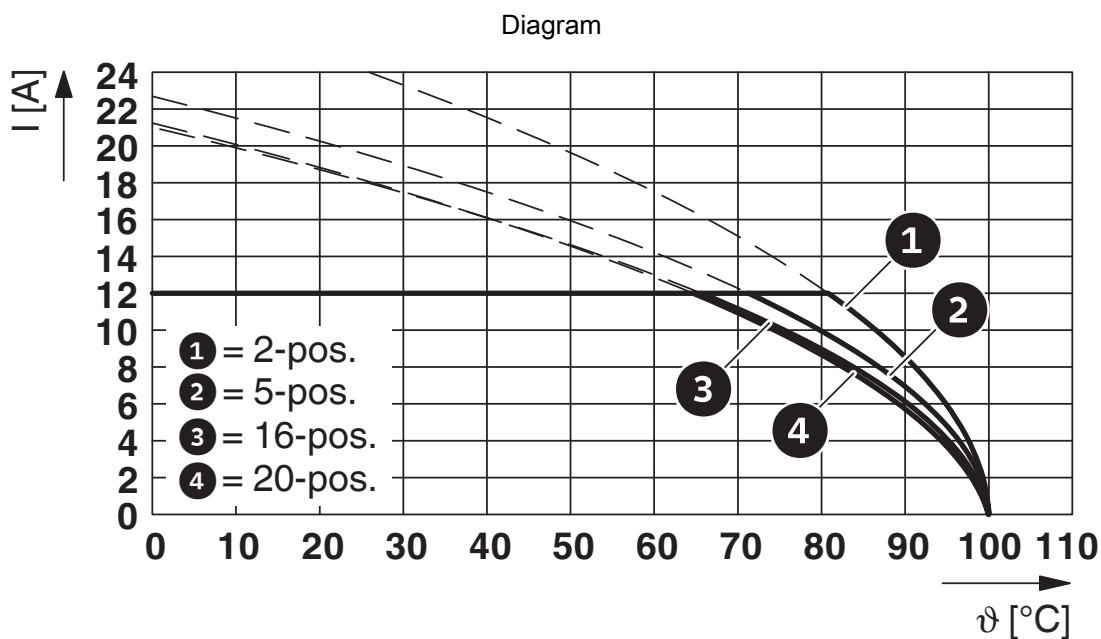

Type: MSTBP 2,5/...-ST with MSTBW 2,5/...-G



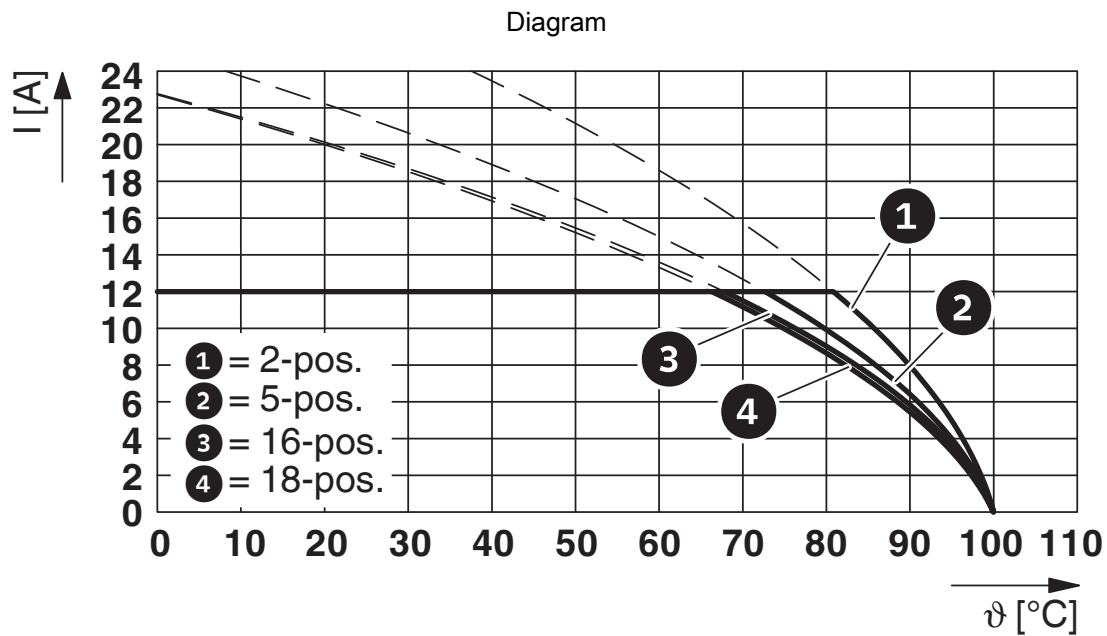

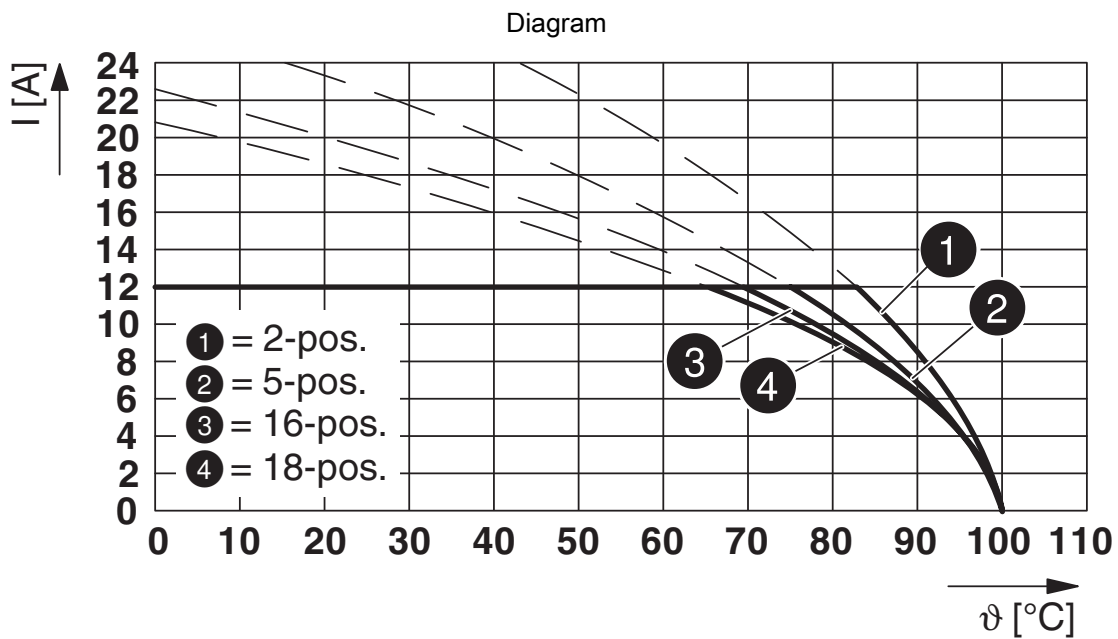
