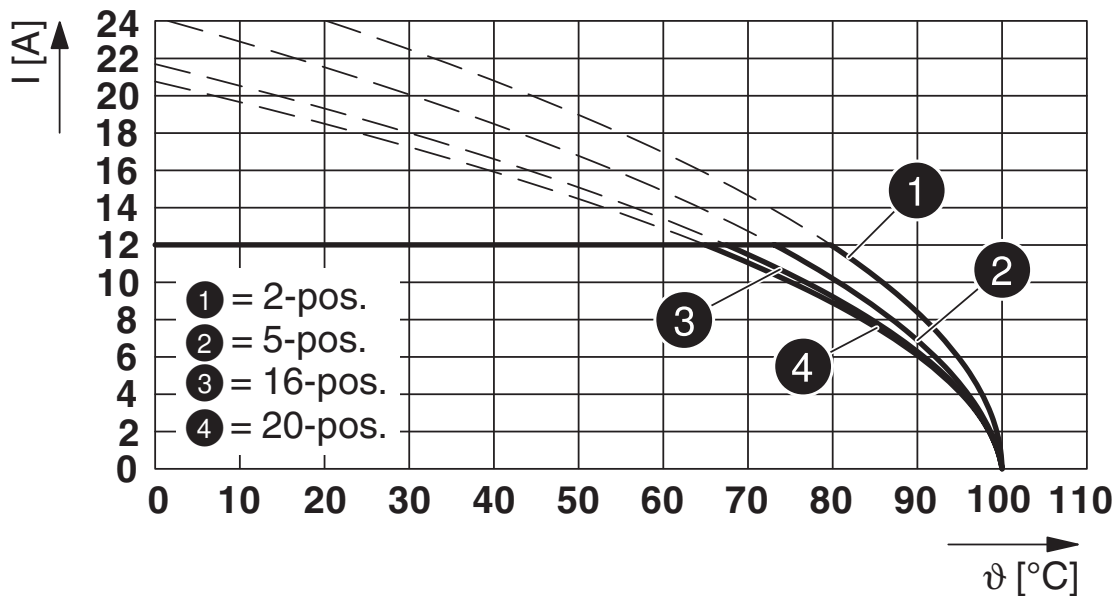

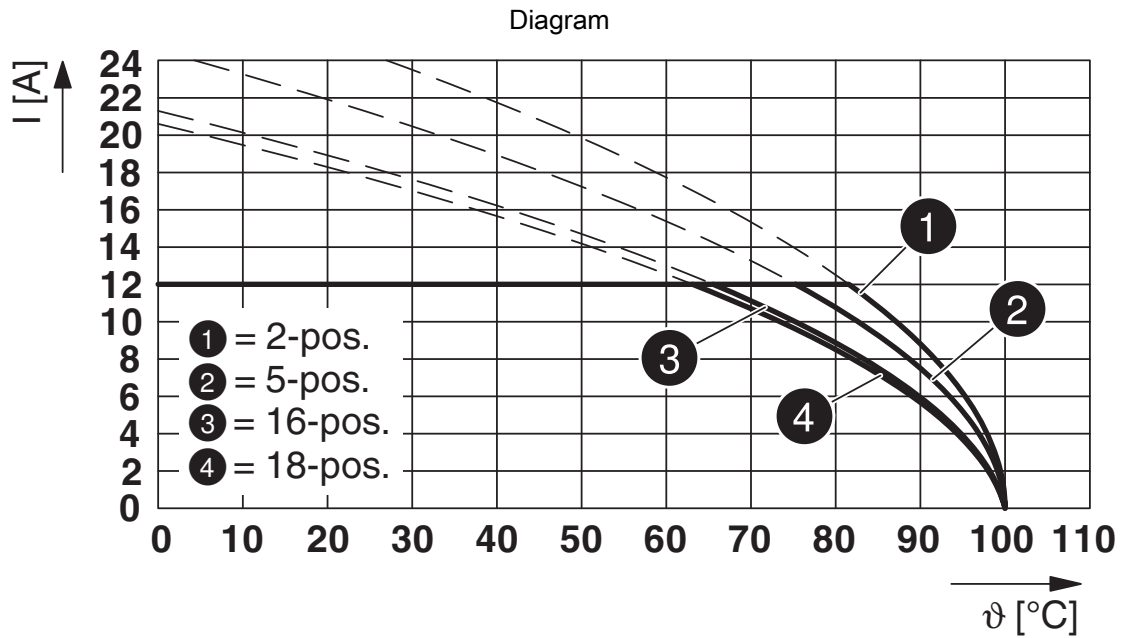

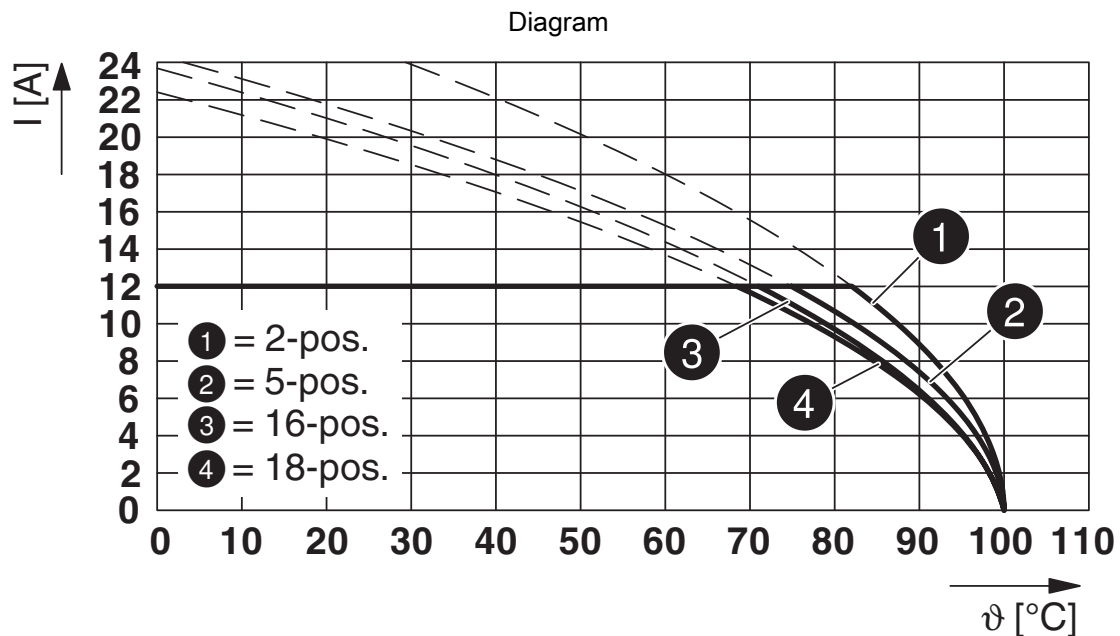
Type: FKCV(W/R) 2,5/...-ST with MSTB 2,5/...-G



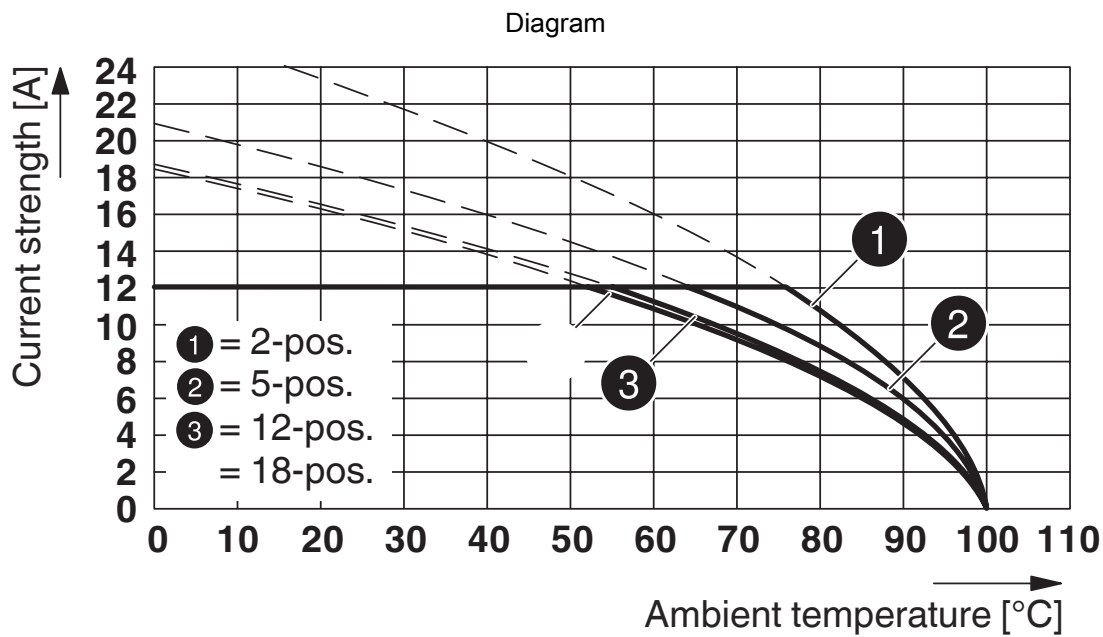

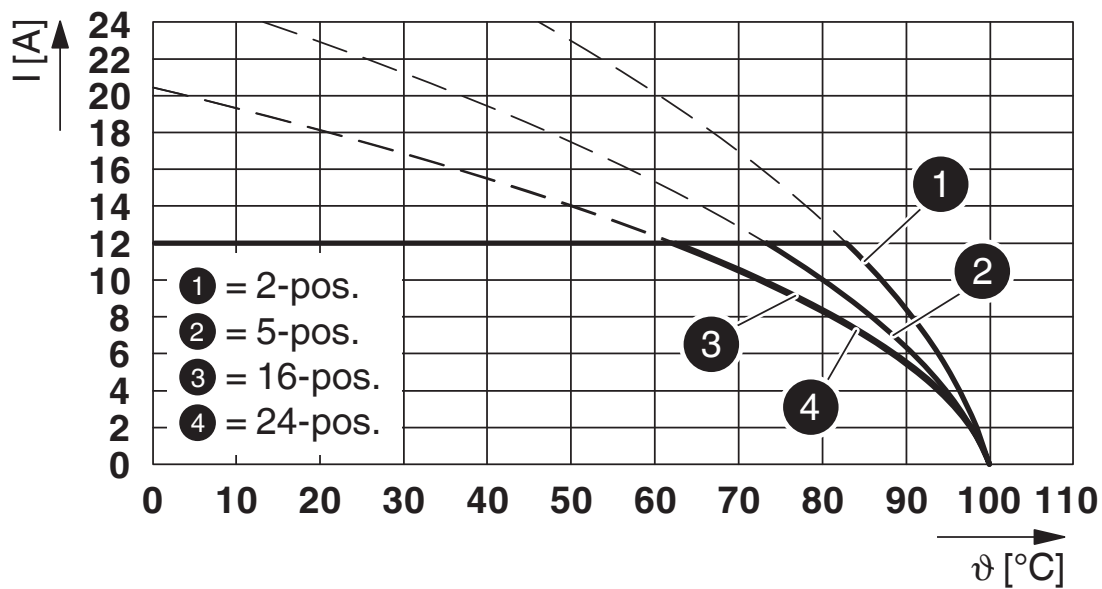

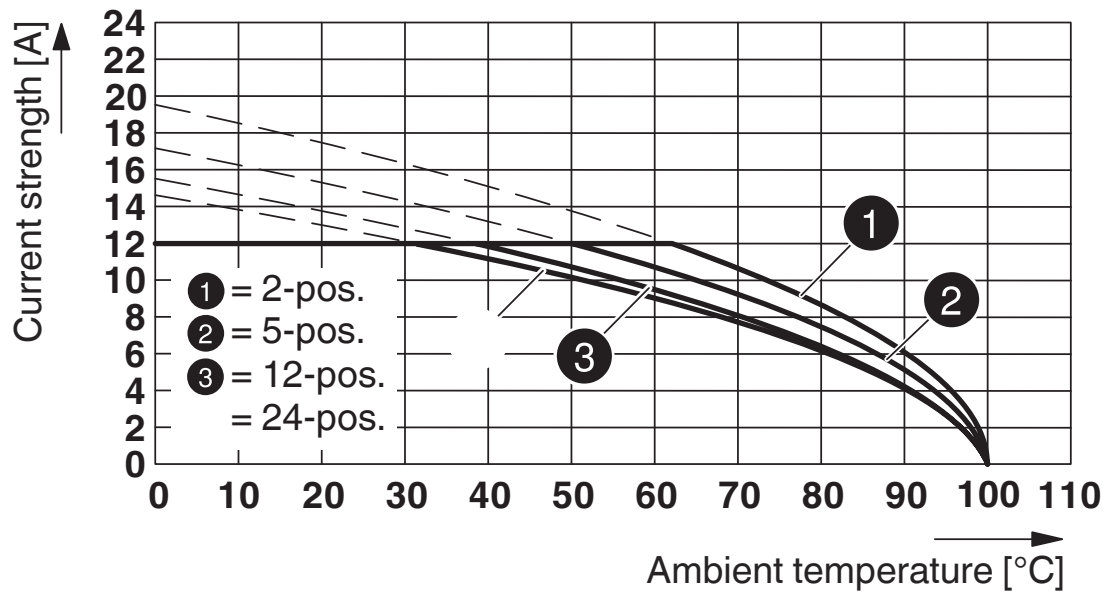
