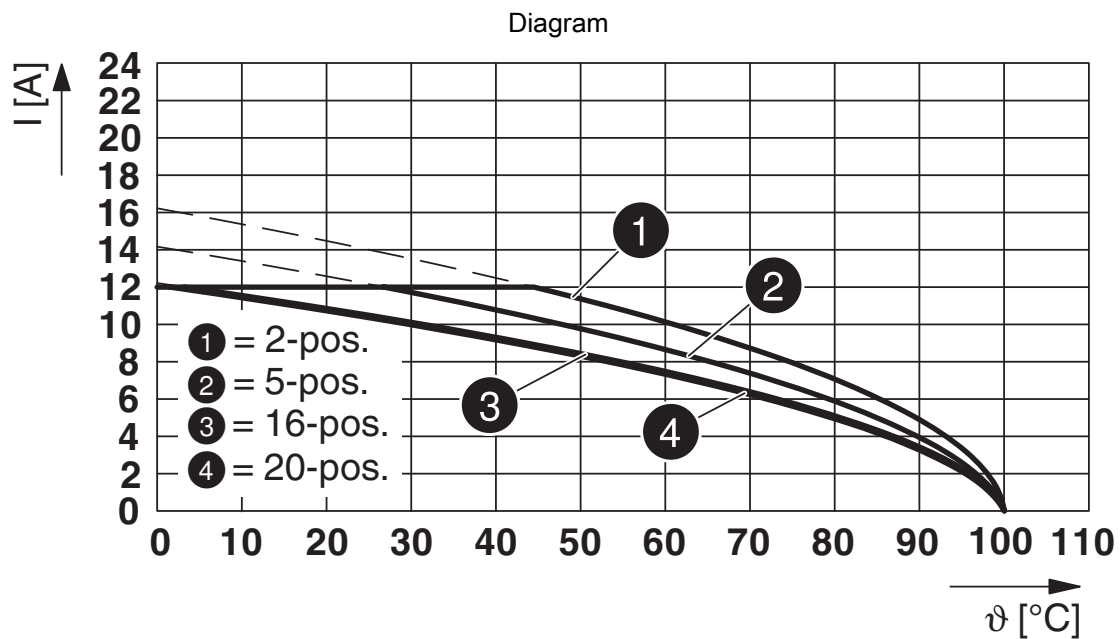

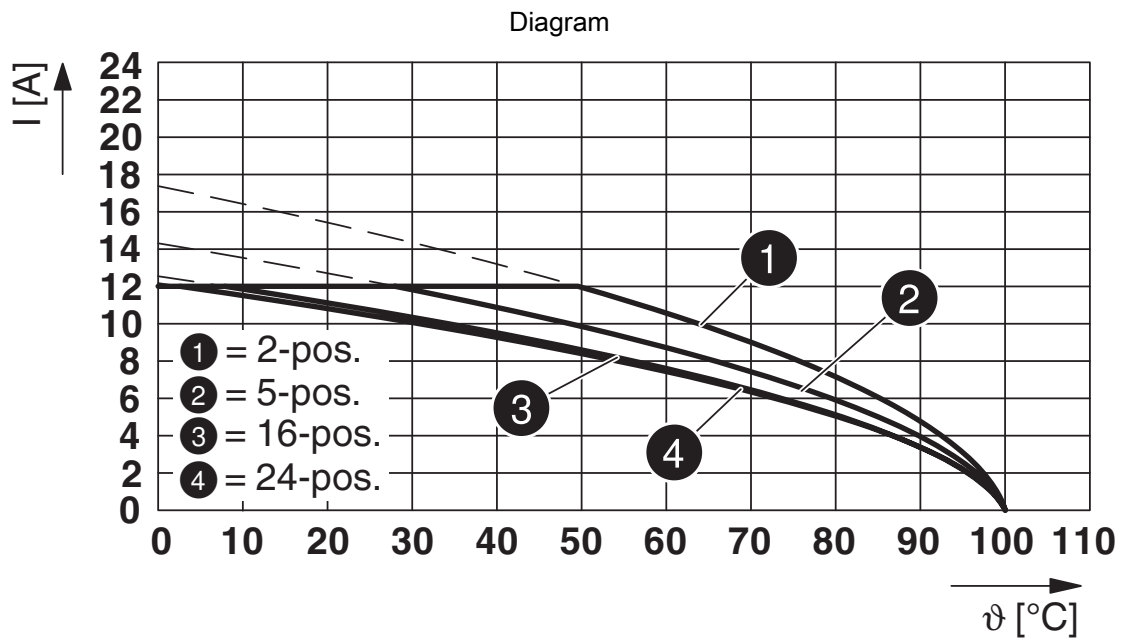

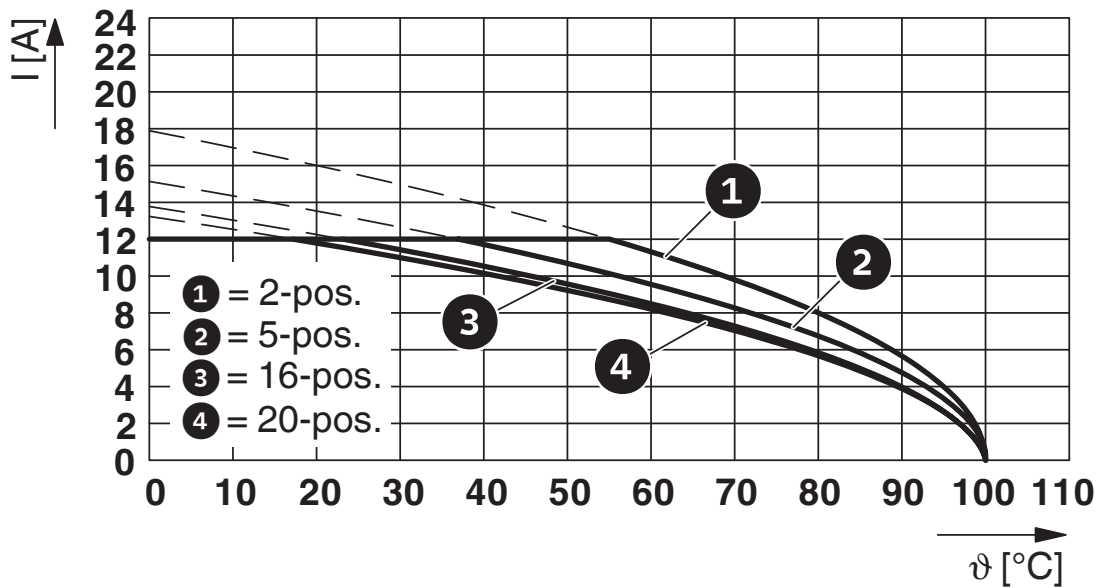

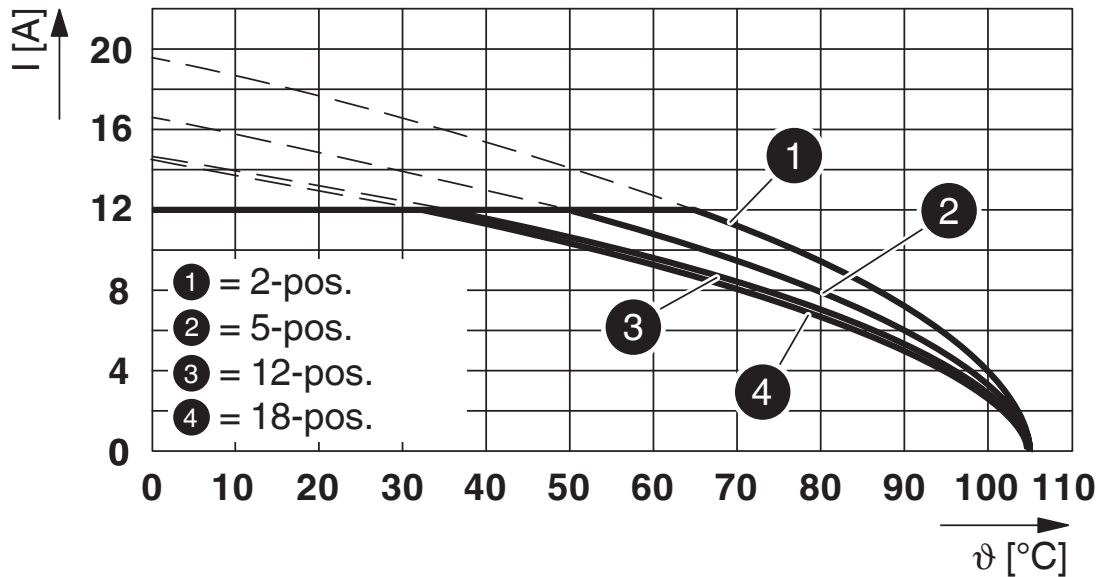


Type: FRONT-MSTB 2,5/...-STF-5,08 with MSTBV 2,5/...-GF-5,08

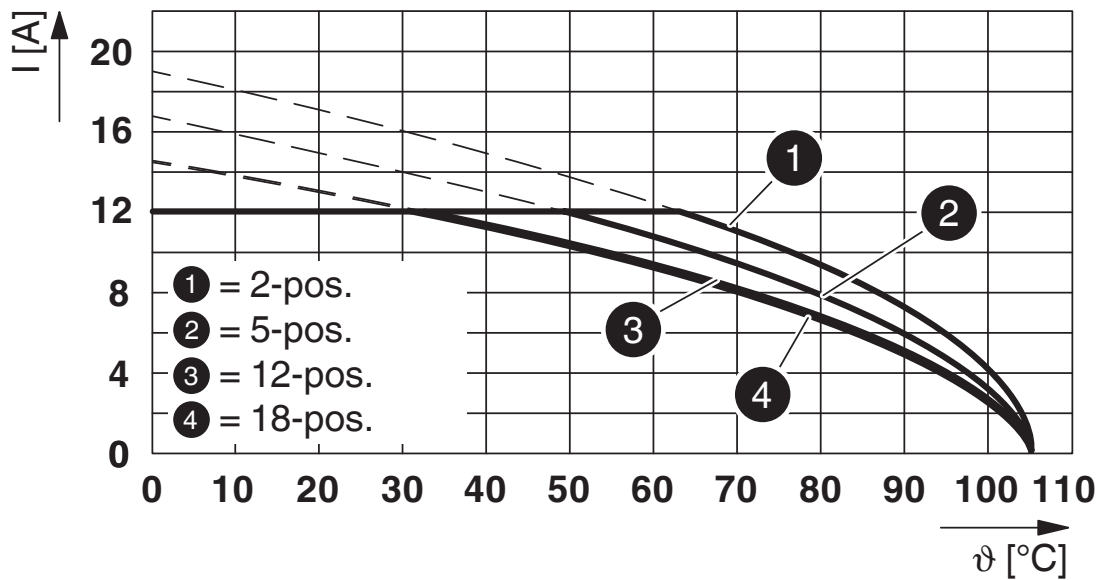

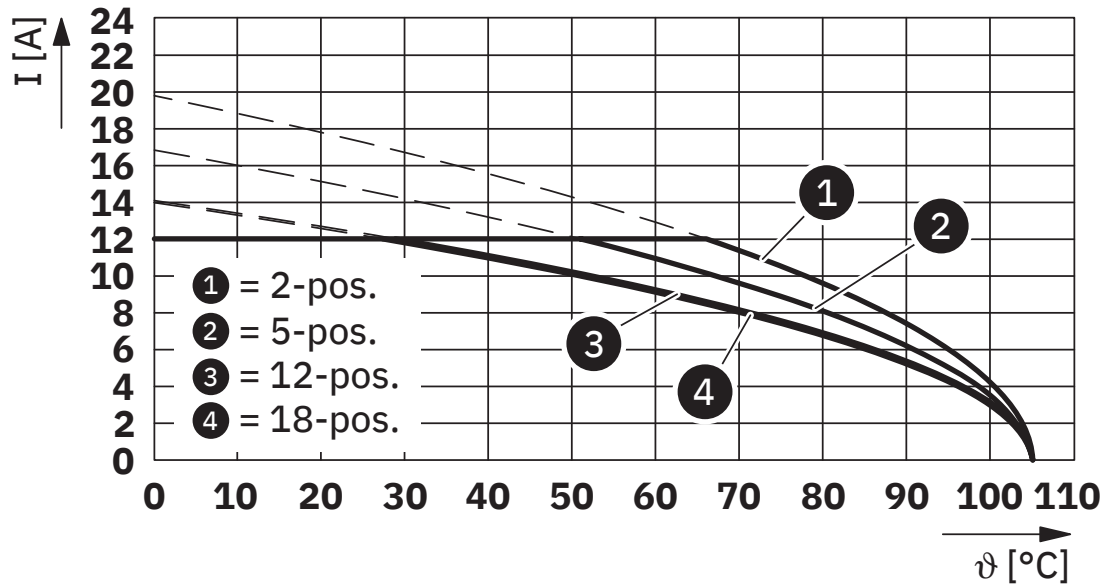

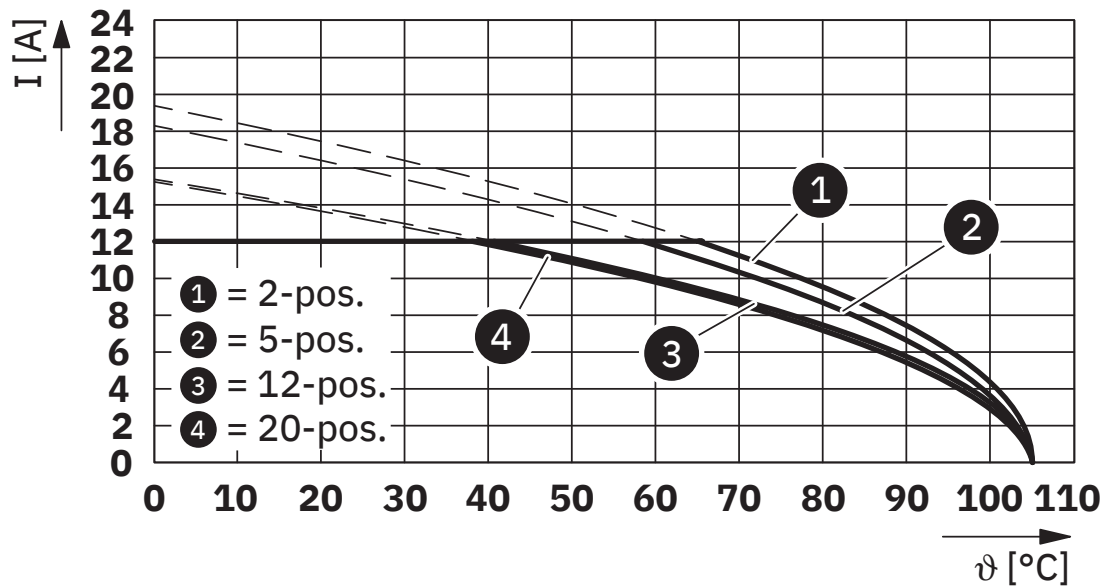
