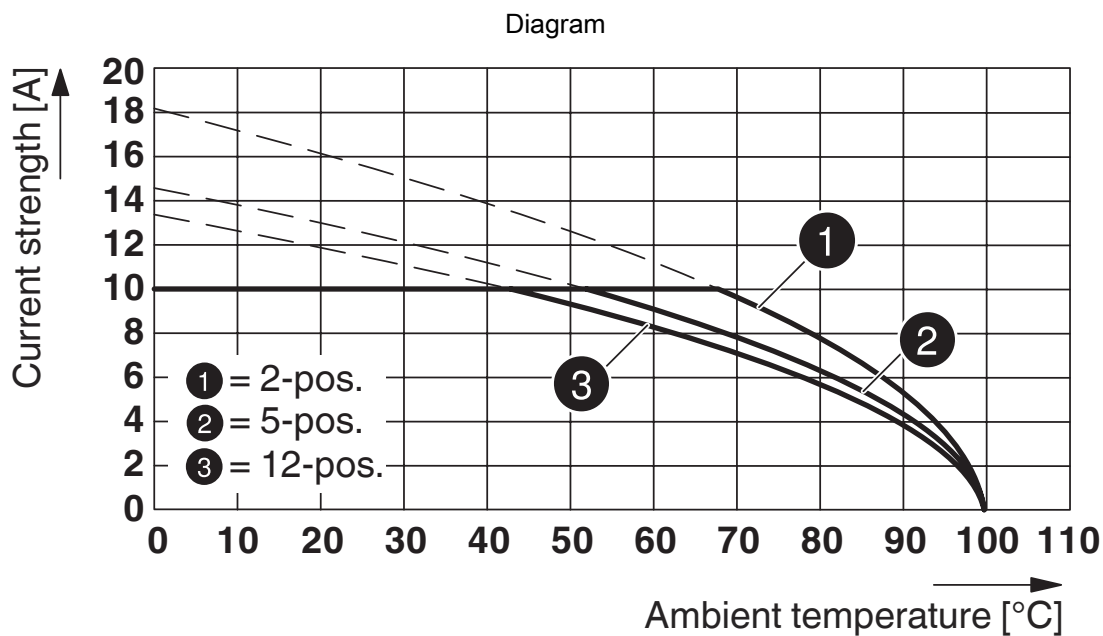

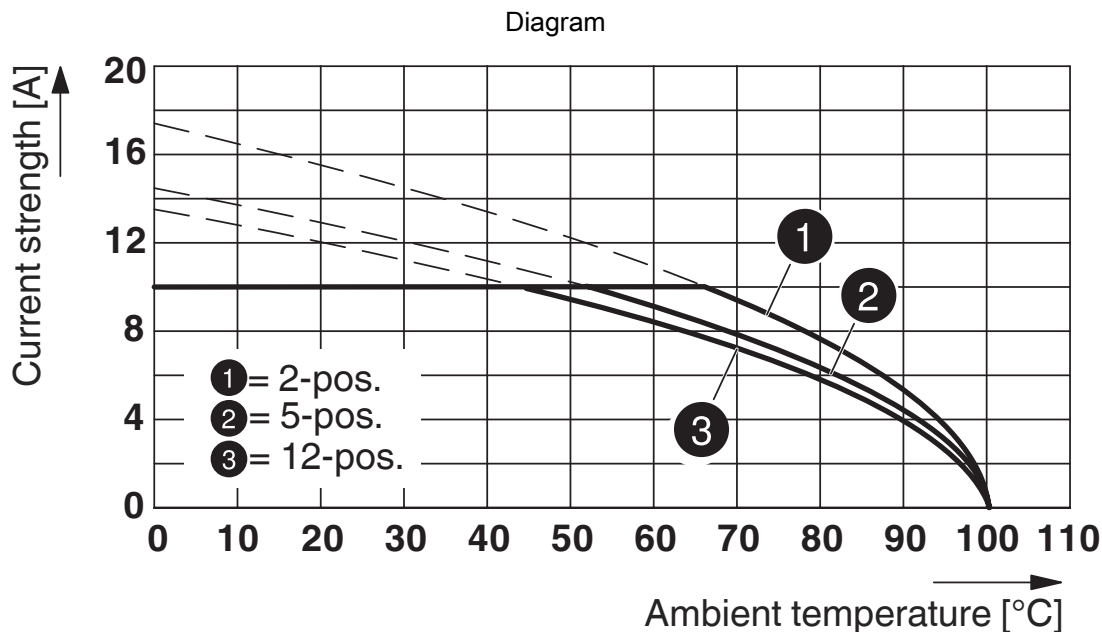
Type: MSTB 2,5/...-ST-5,08 with MDSTBV 2,5/...-G-5,08



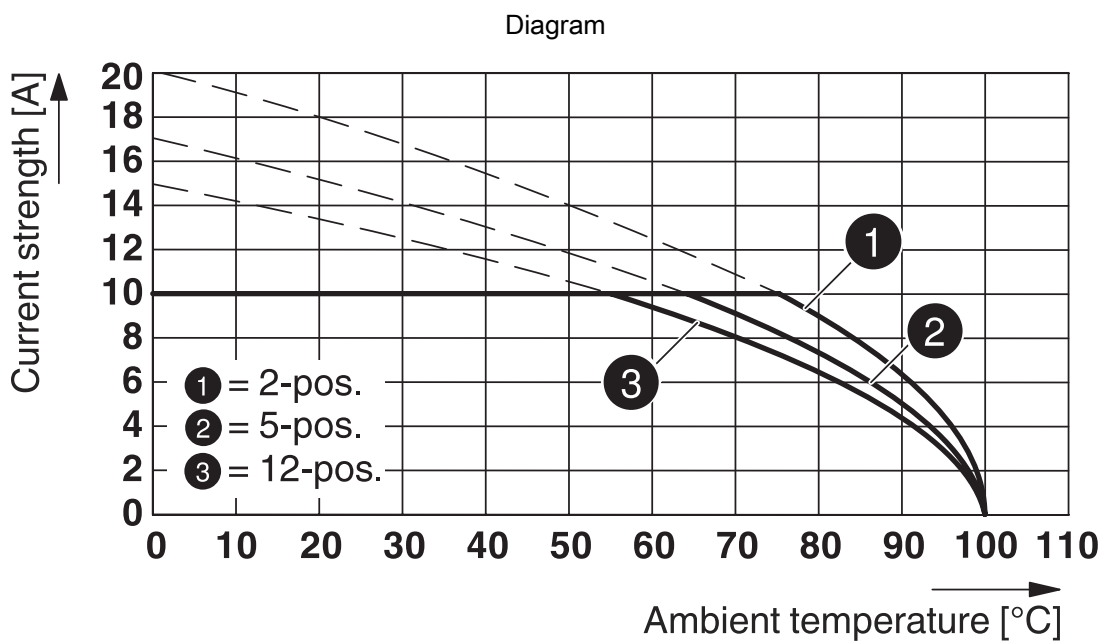
Type: MSTBT 2,5/...-ST-5,08 with MDSTBV 2,5/...-G-5,08



Type: MVSTB(R/W) 2,5/...-ST with MDSTBV 2,5/...-G-5,08

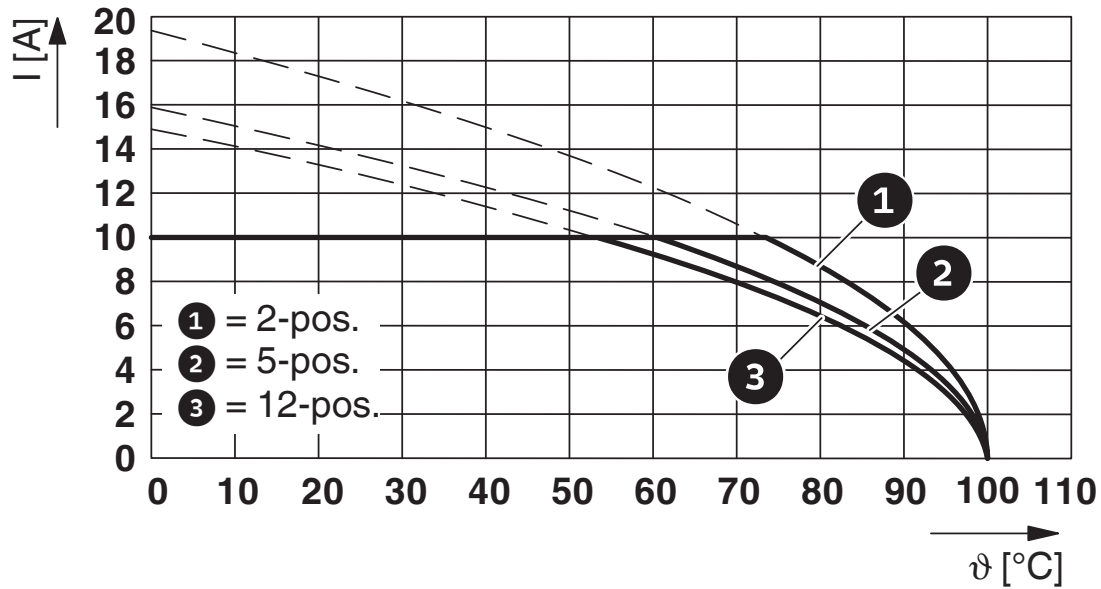


Type: FRONT-MSTB 2,5/...-ST-5,08 with MDSTBV 2,5/...-G-5,08



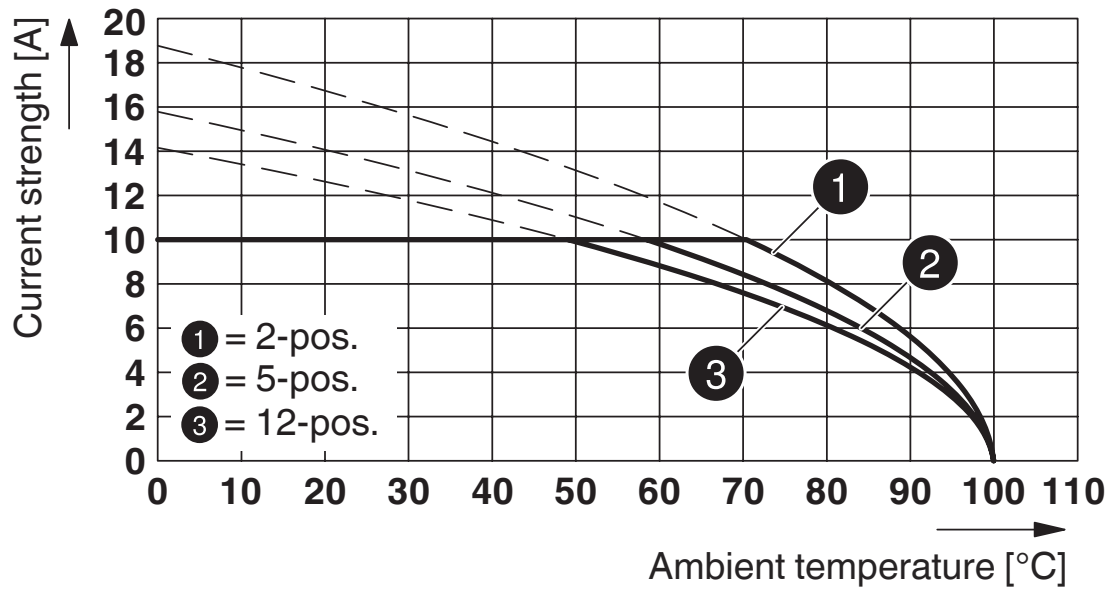
