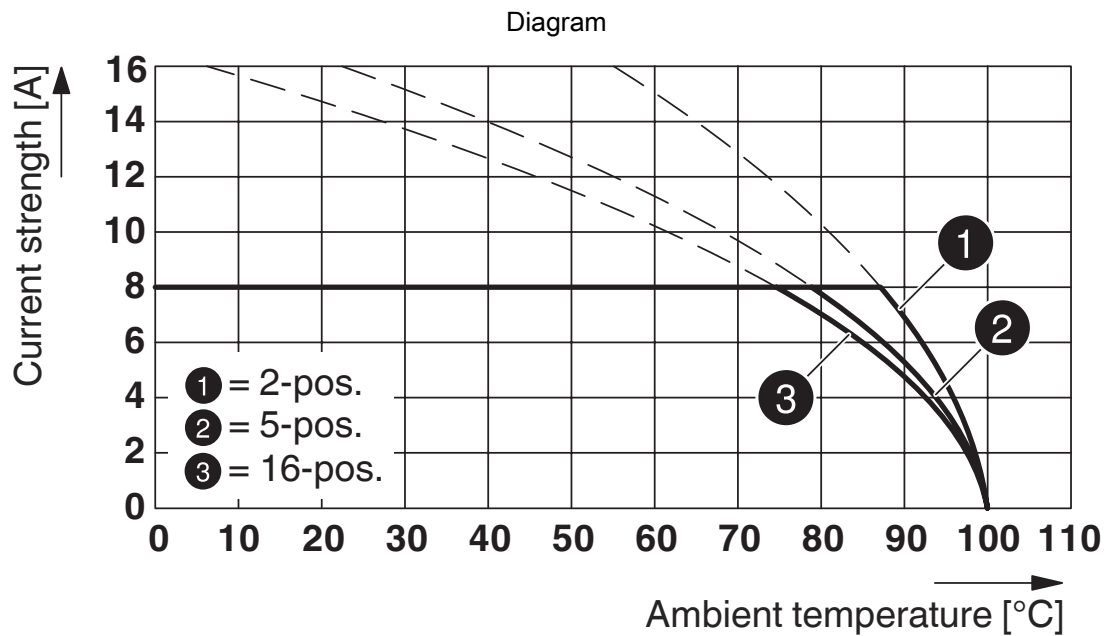

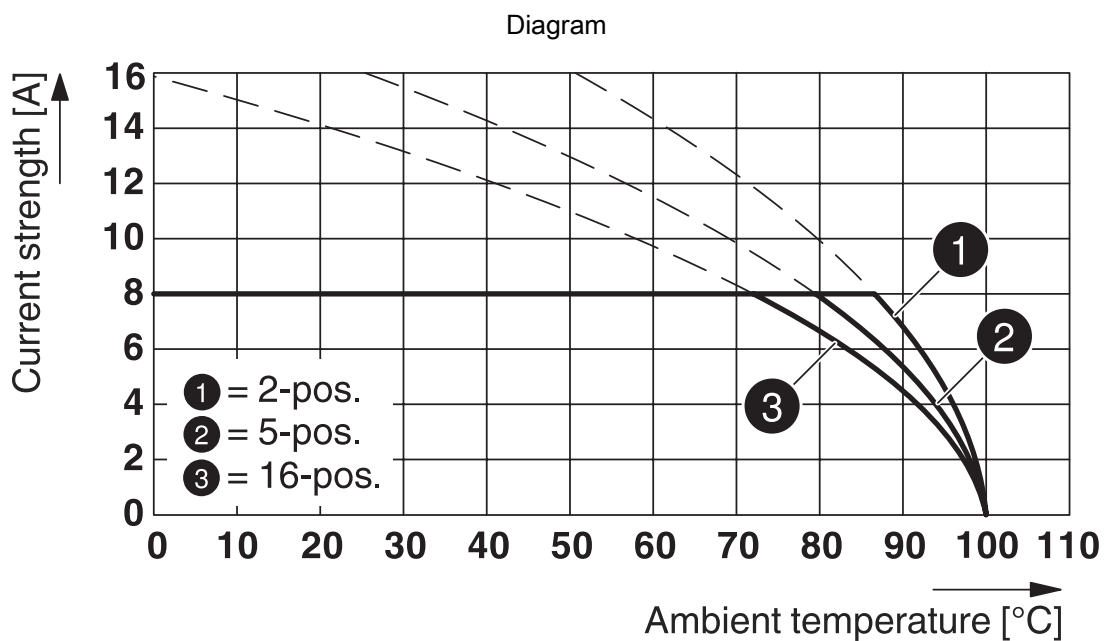

Type: FK-MCP 1,5/...-ST-3,81 with SMC 1,5/...-G-3,81

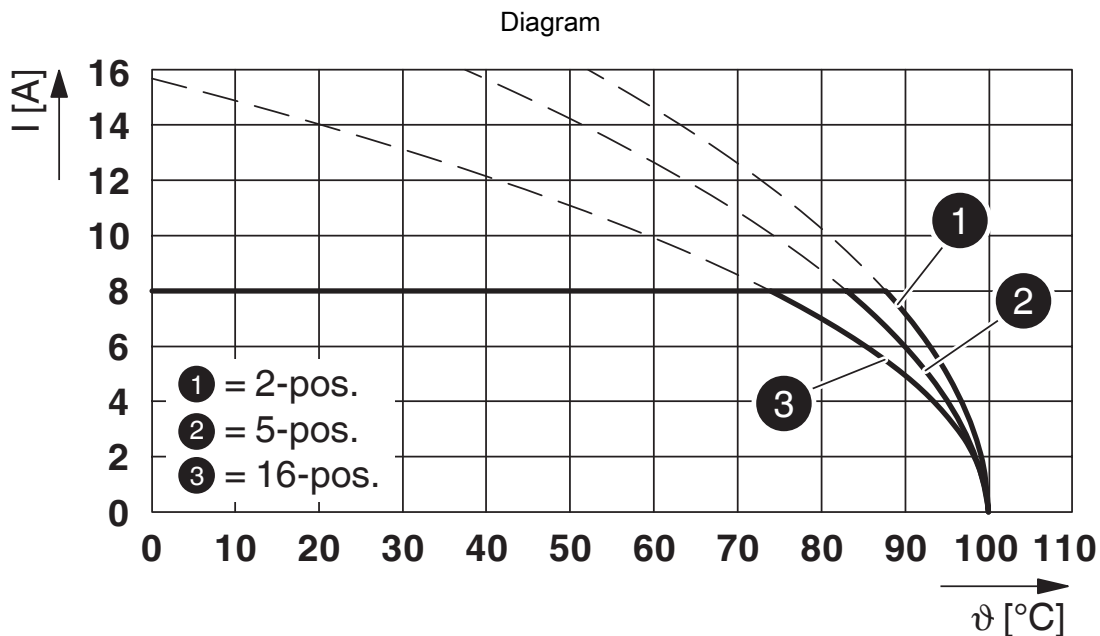


Type: FMC 1,5/...-ST-3,81 with SMC 1,5/...-G-3,81

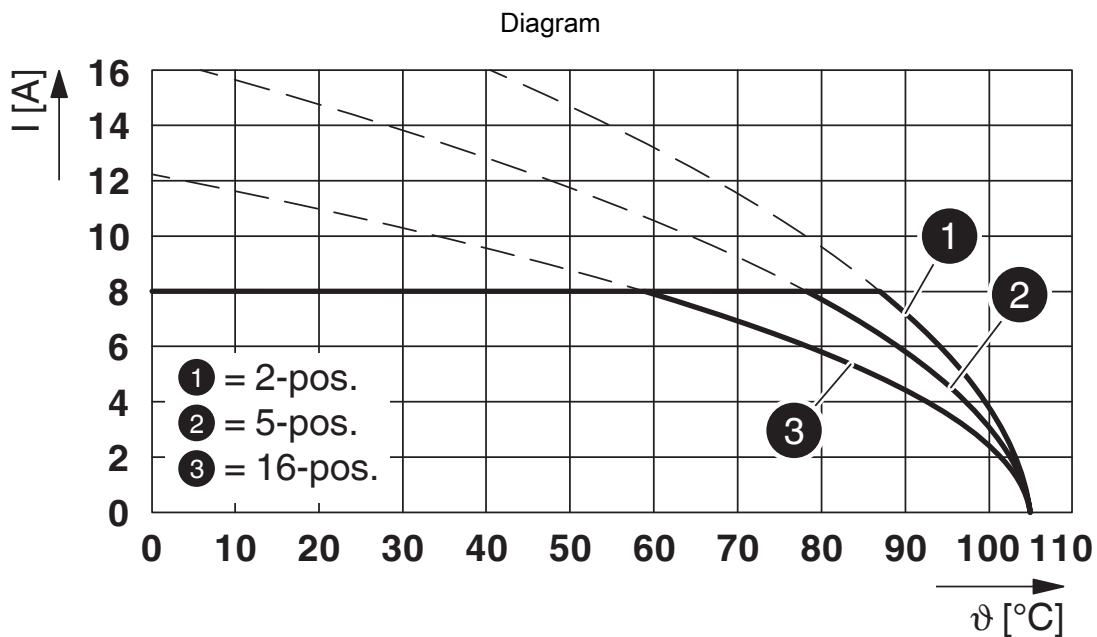

Type: MC 1,5/...-ST-3,81 with SMC 1,5/...-G-3,81

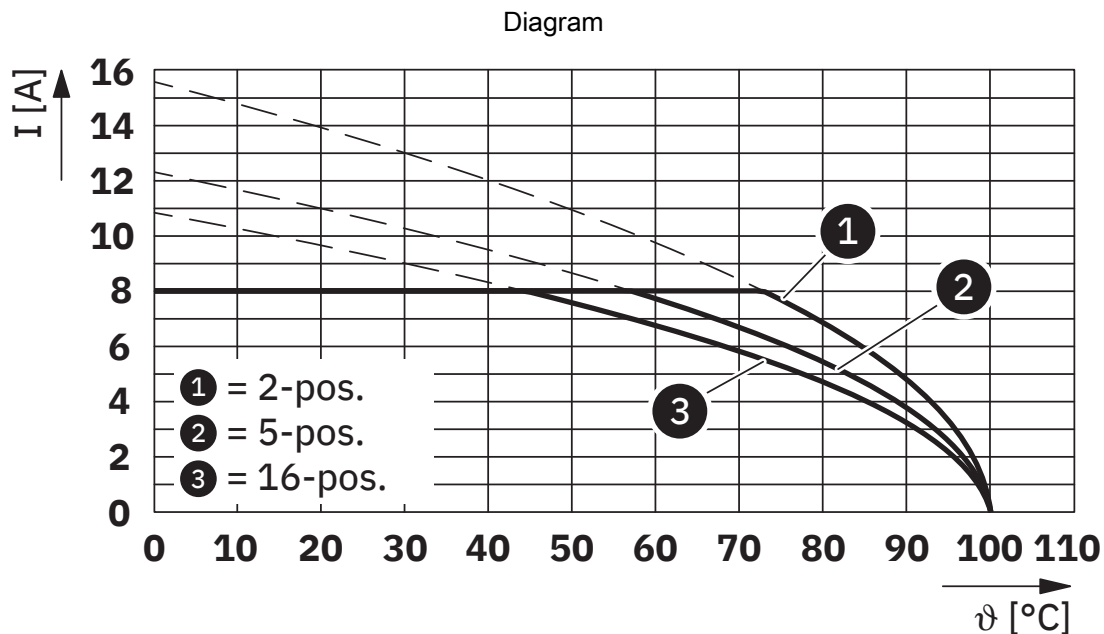

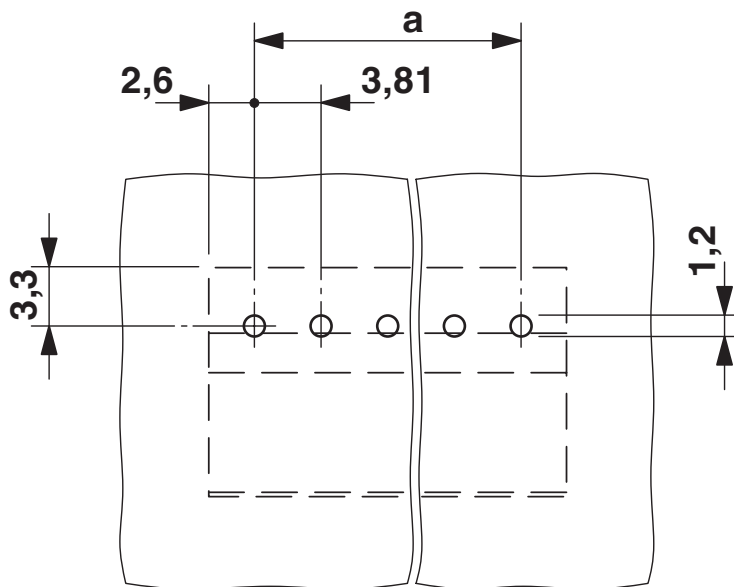
