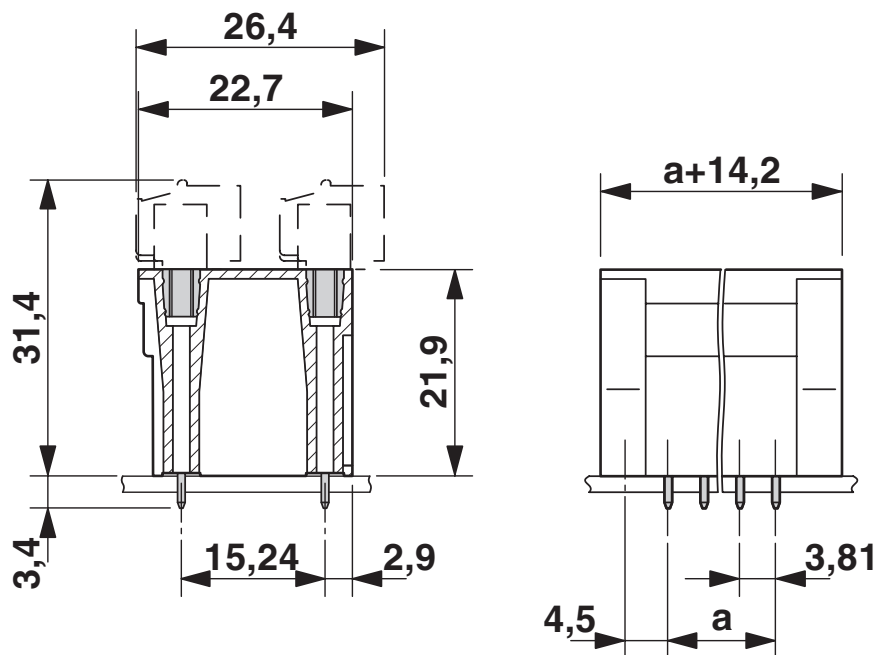

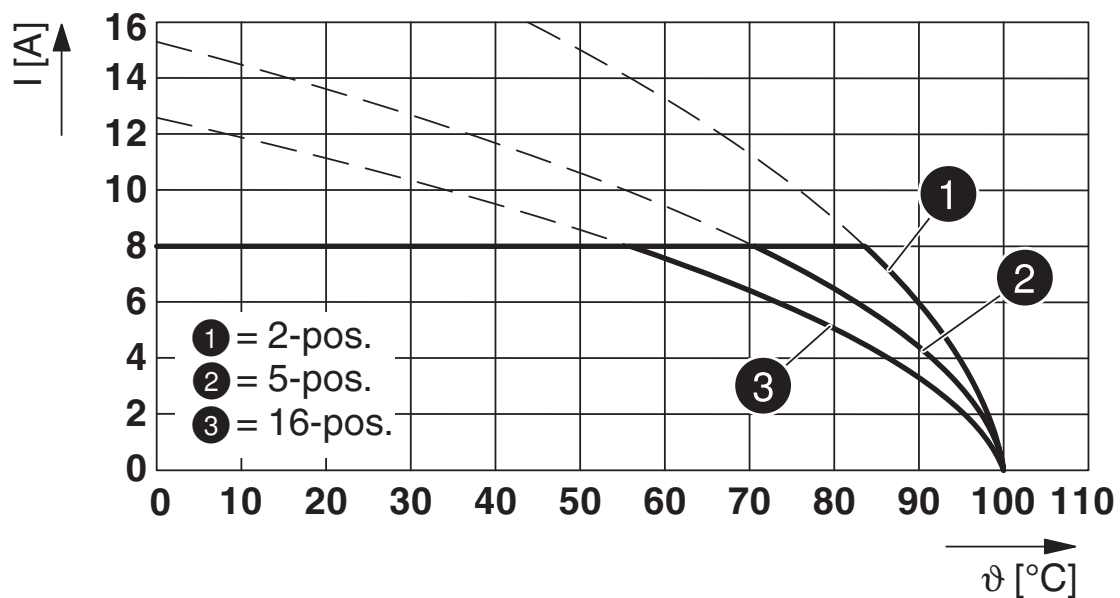

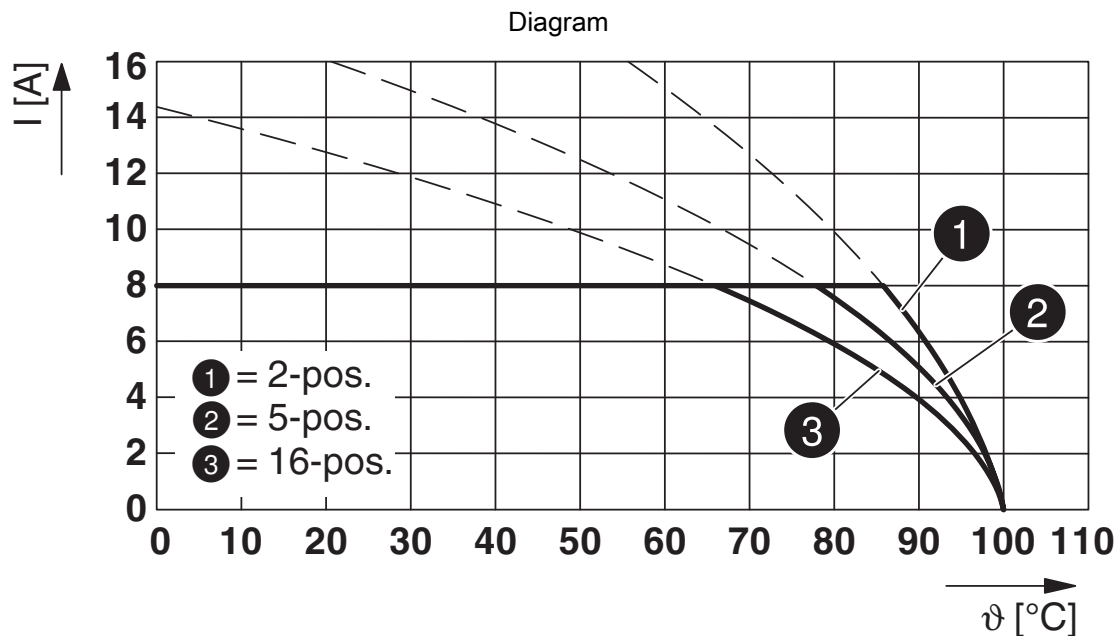

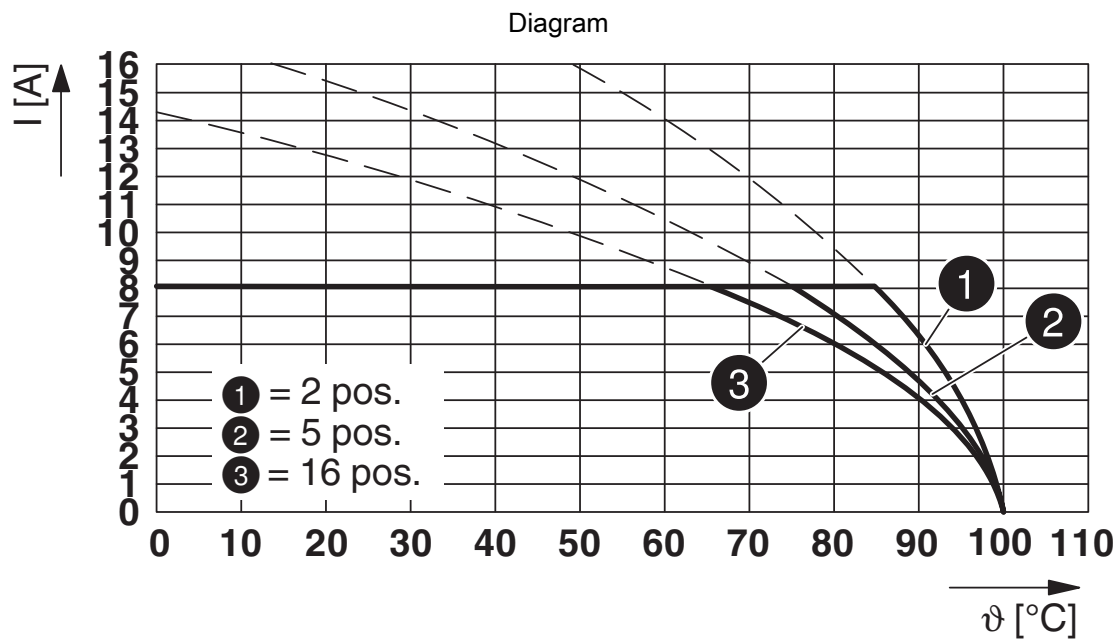

Type: FRONT-MC 1,5/...-STF-3,81 with MCDV 1,5/...-G1F-3,81

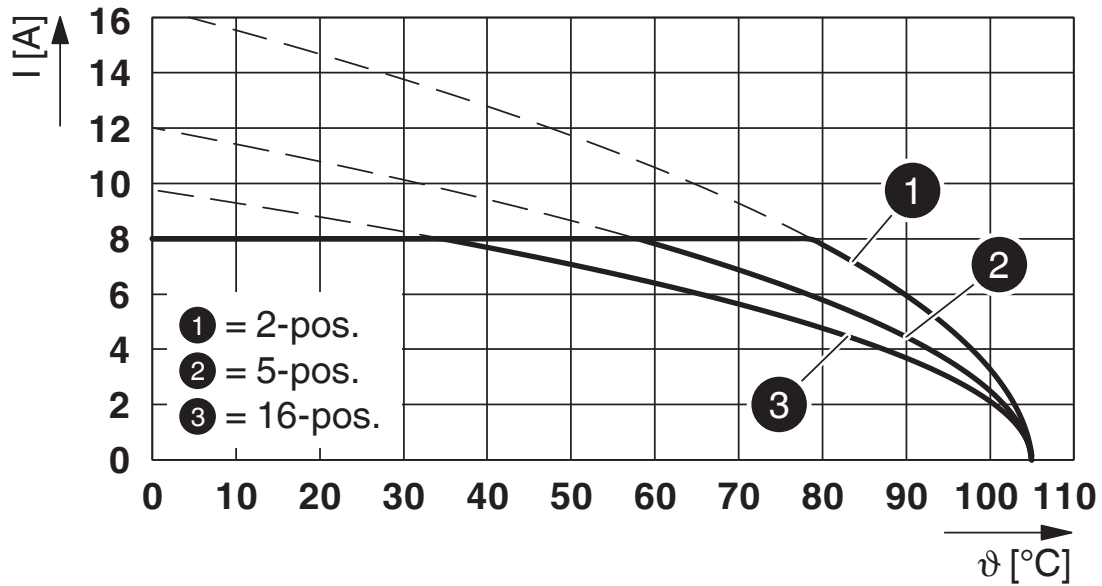


Type: MC 1,5/...-STF-3,81 with MCDV 1,5/...-G1F-3,81



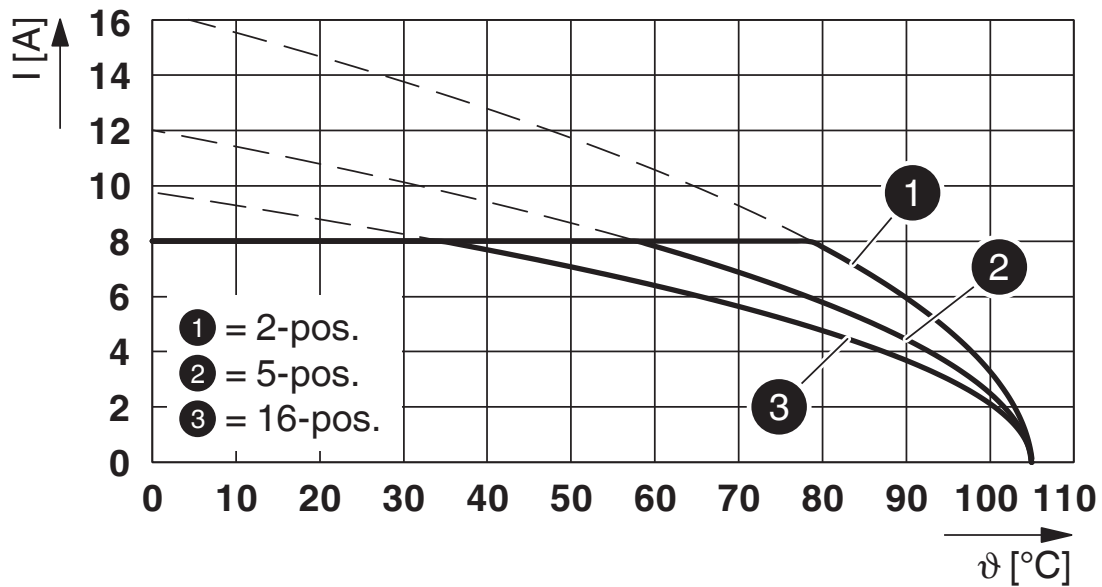
Type: FK-MCP 1,5/...-STF-3,81 with MCDV 1,5/...-G1F-3,81
