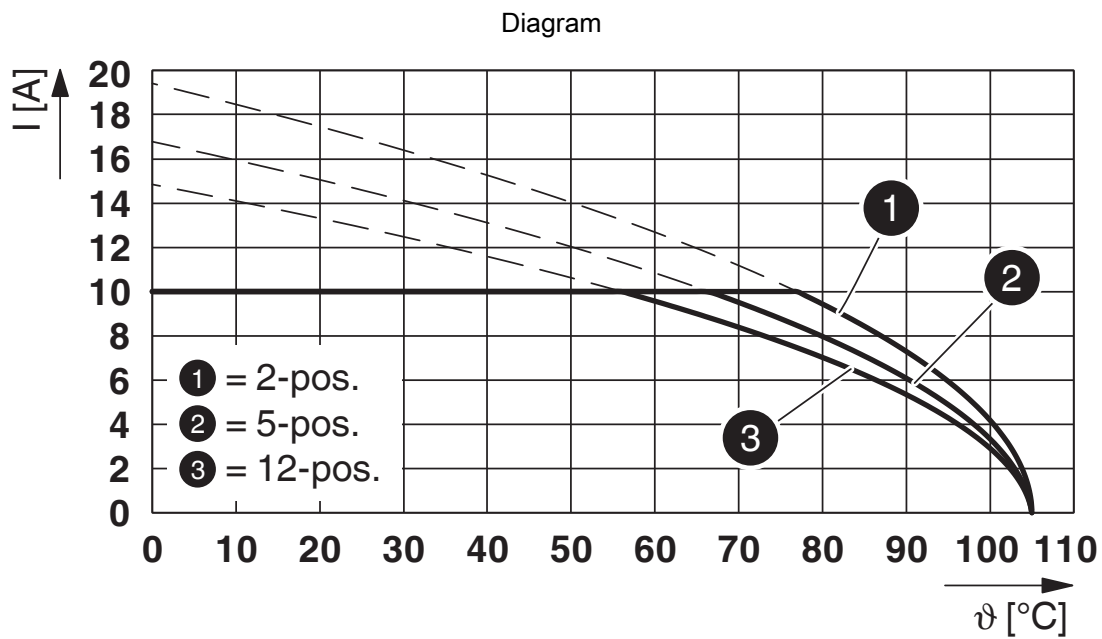

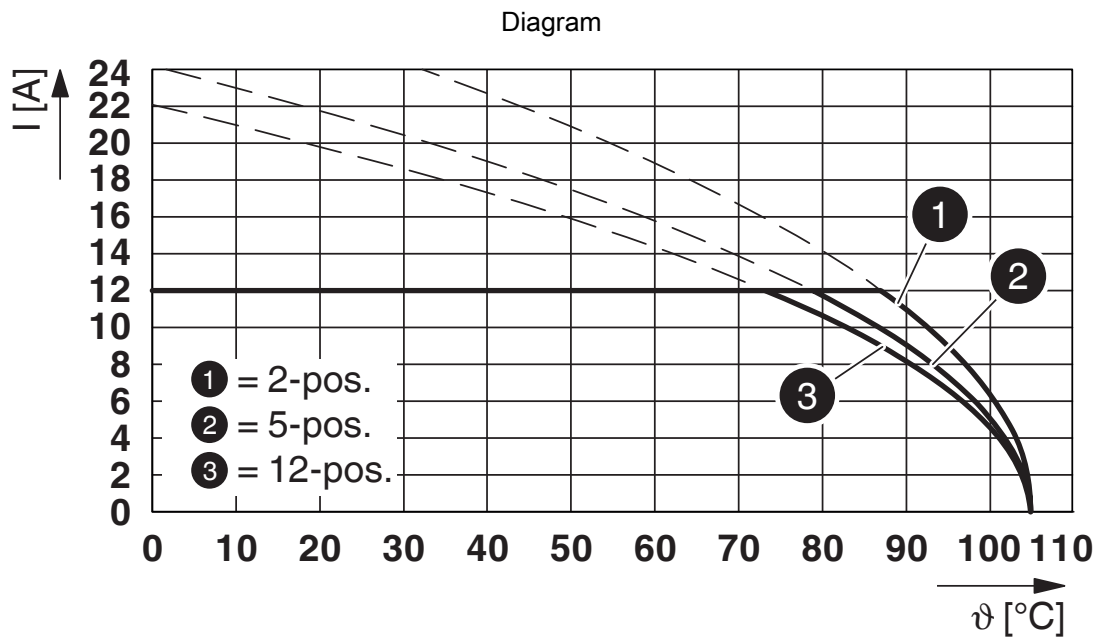
Type: FKCT 2,5/...-STF-5,08 with CCV 2,5/...-GF-5,08 P...THR



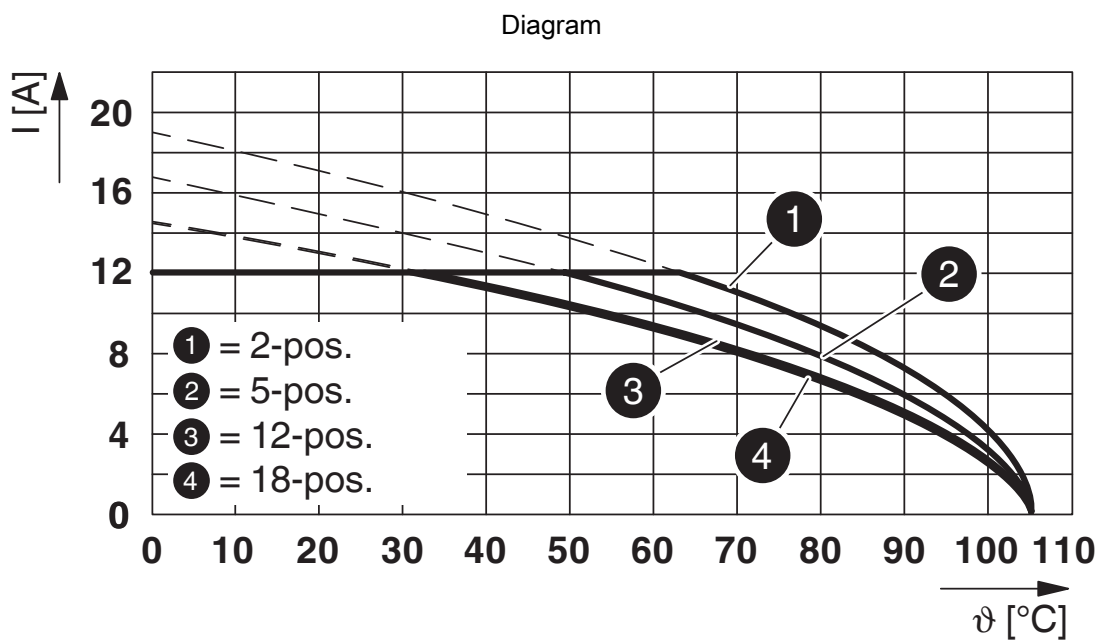
