Type: SMSTB 2,5/...-ST with FKIC 2,5/...-ST

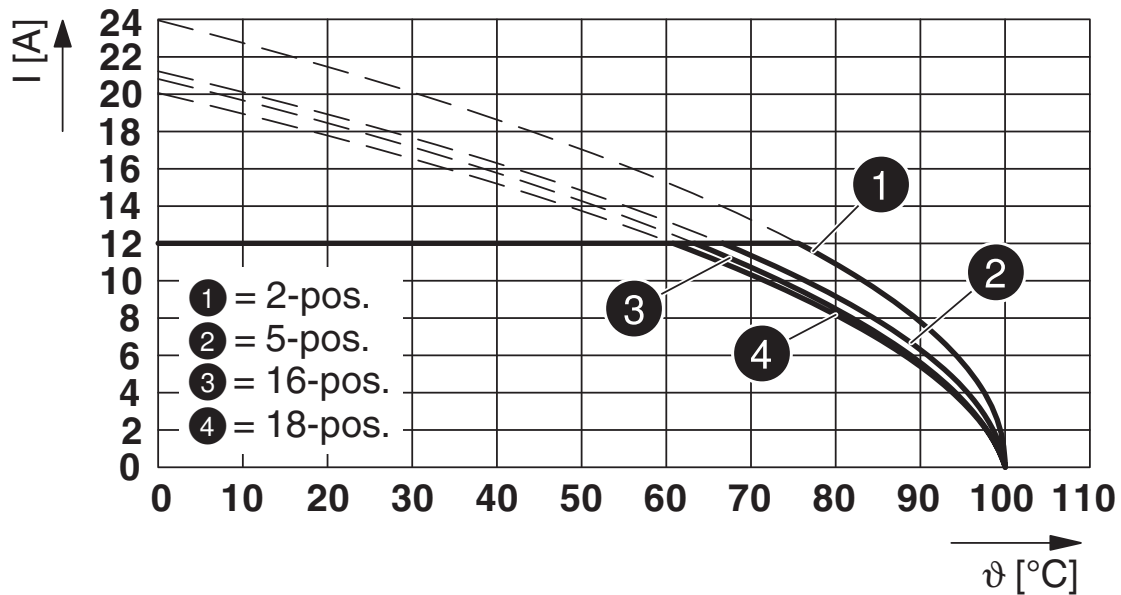

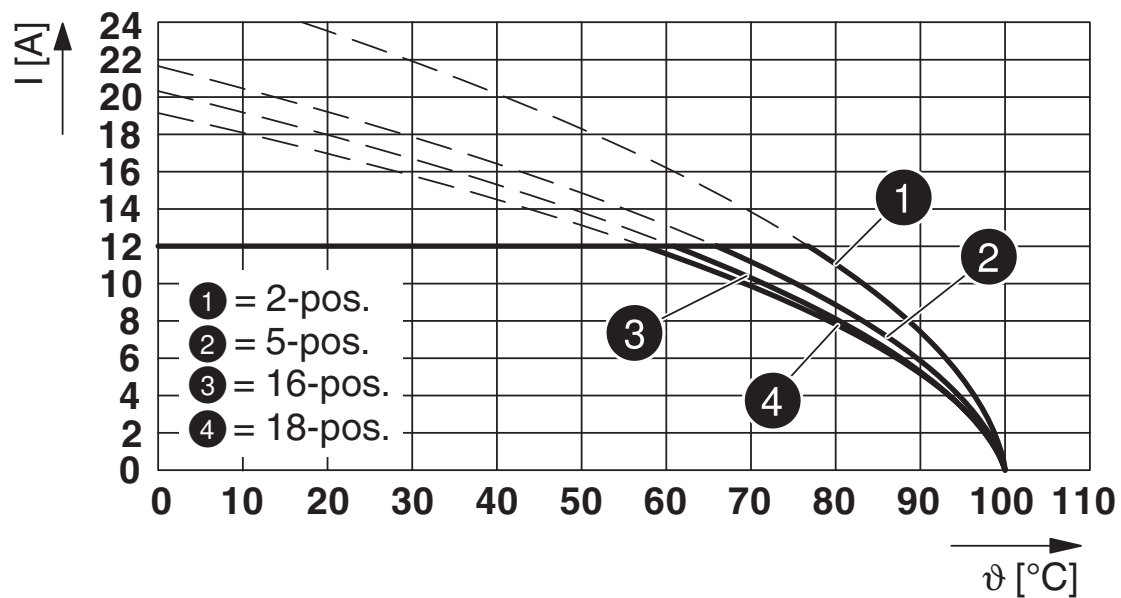
