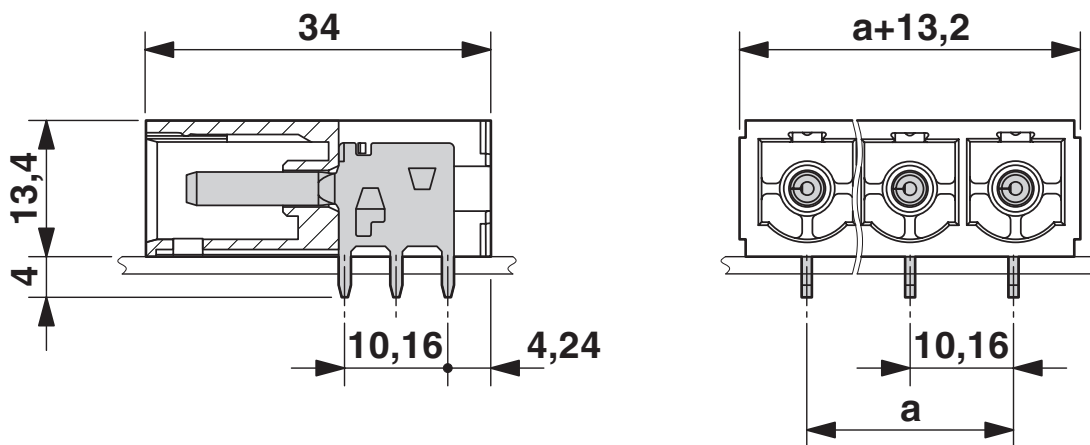

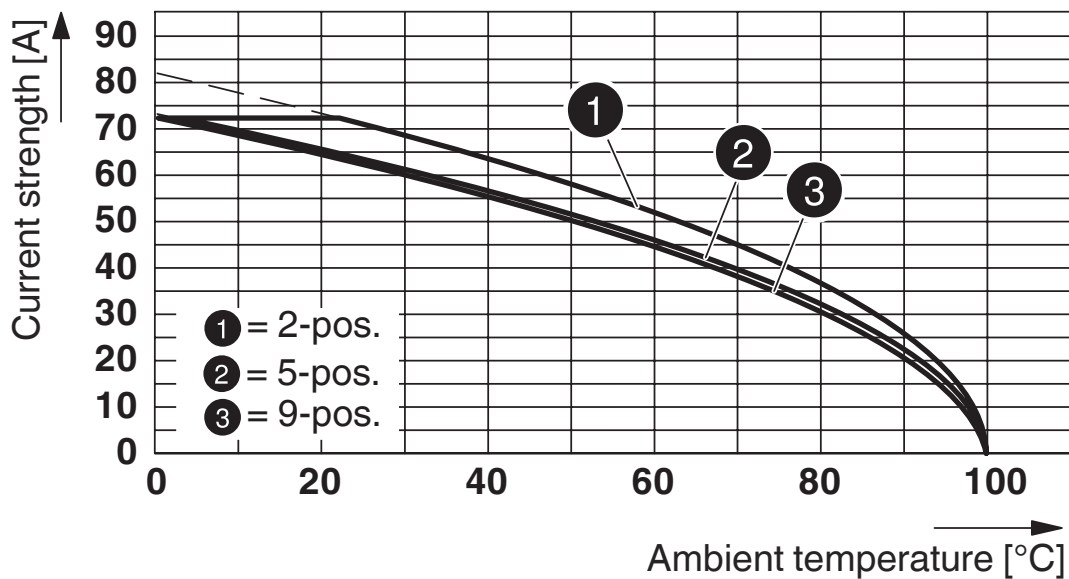

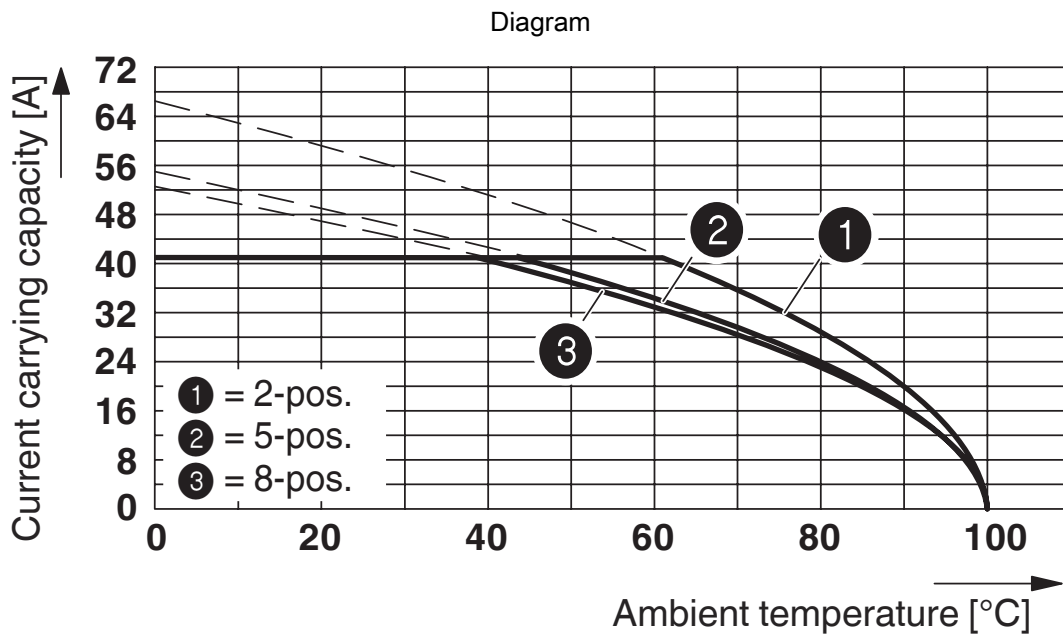

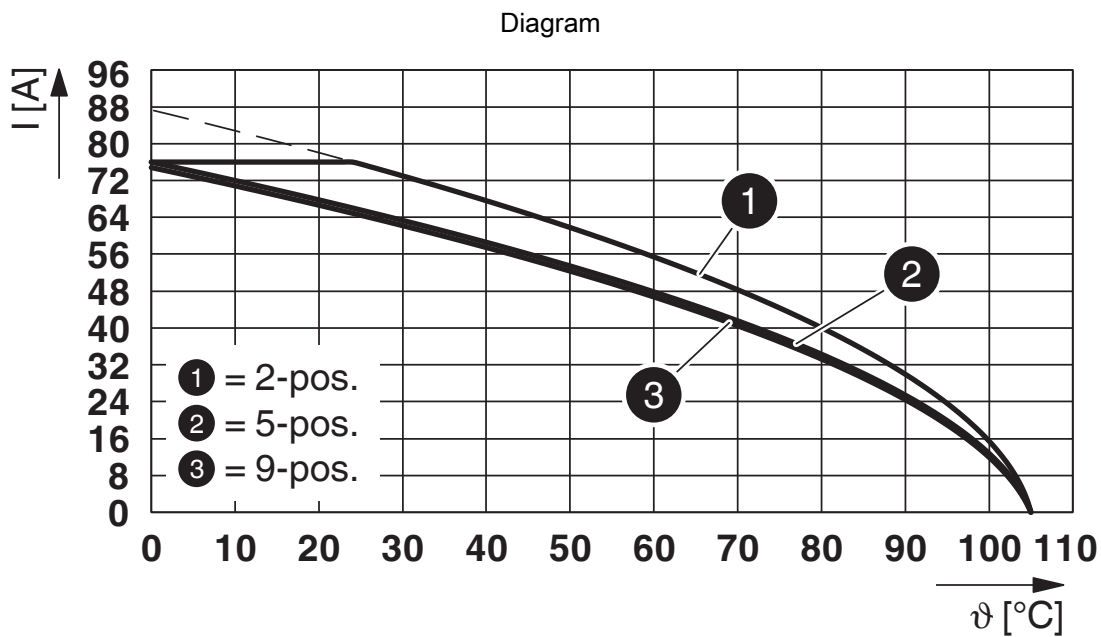

Type: SPC 16/...-ST-10,16 with PC 6-16/...-G1-10,16

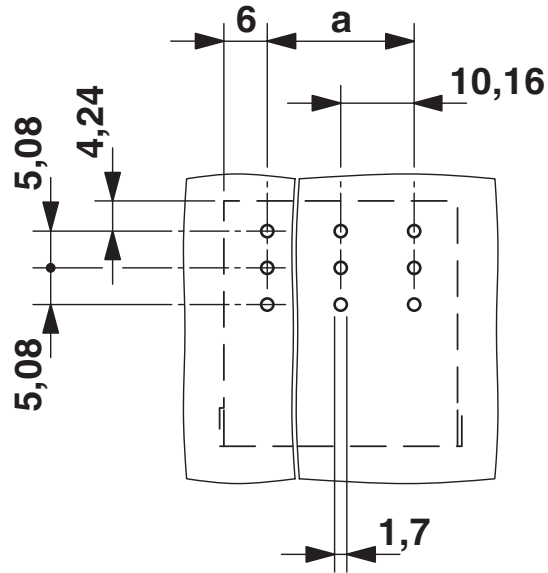
