

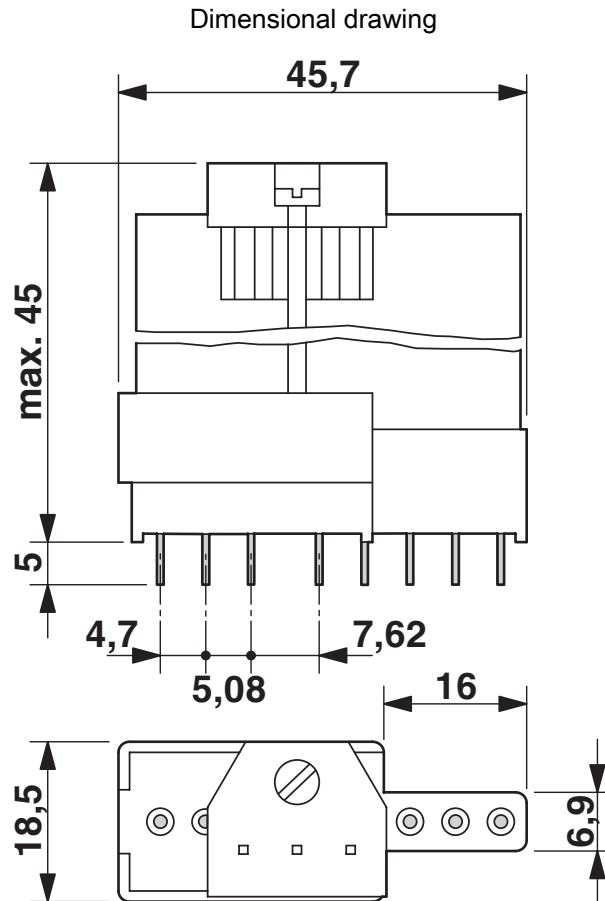

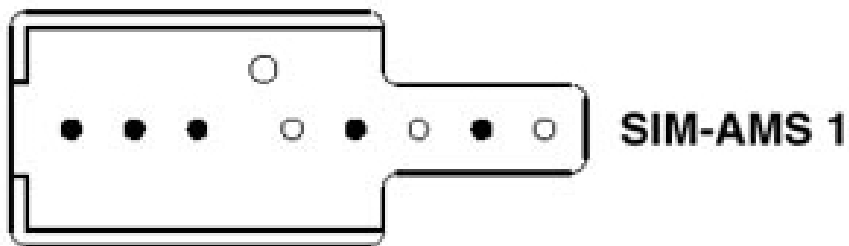

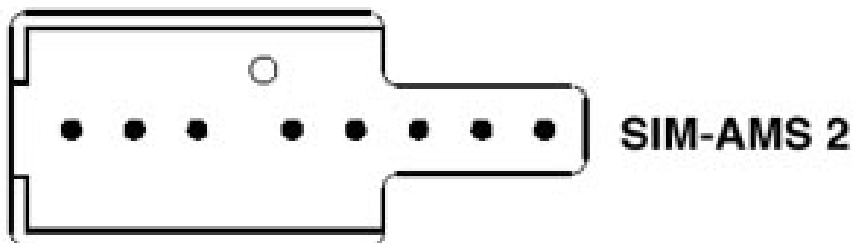
Schematic diagram
