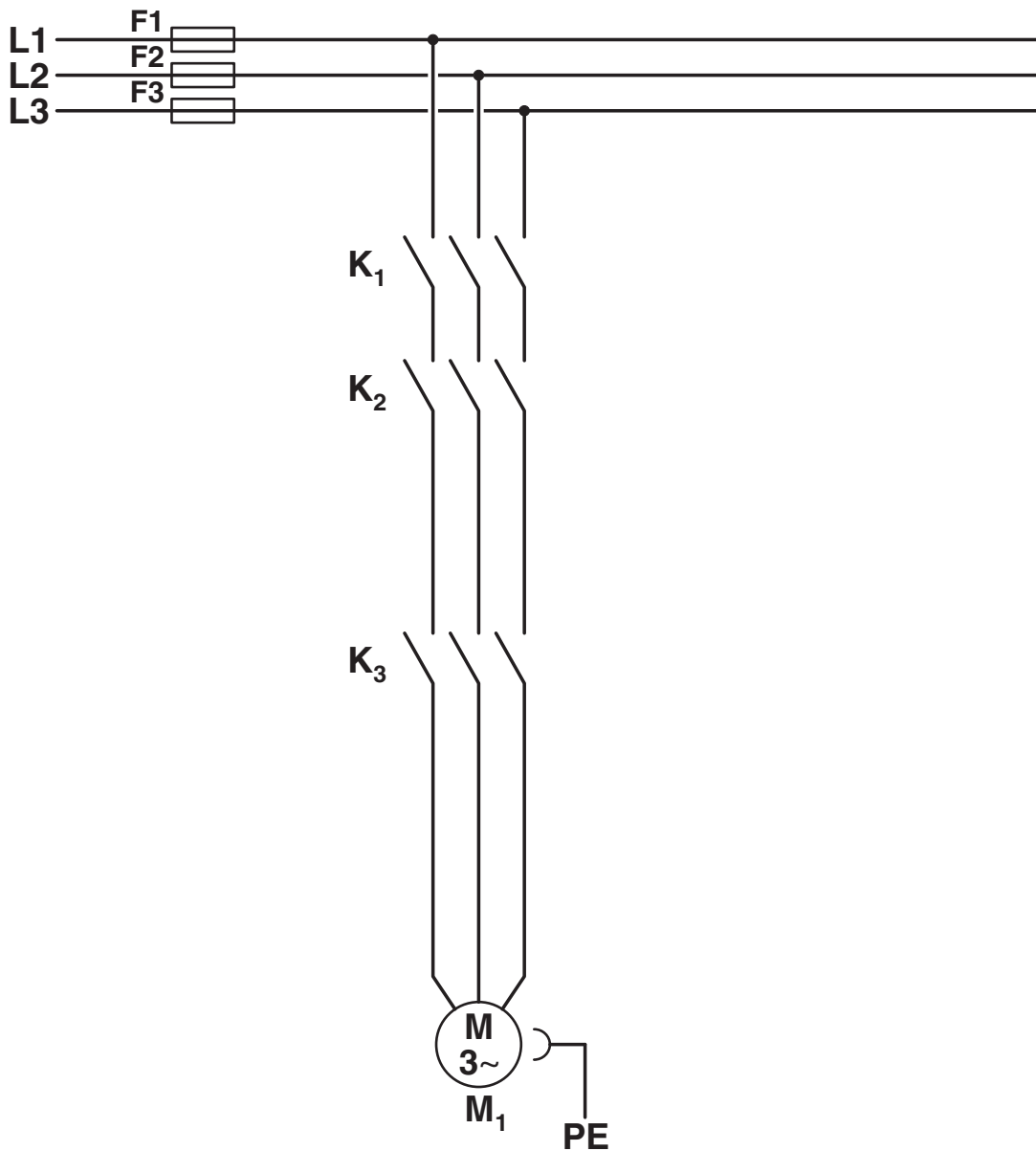

K1 + K2 = Emergency stop contactor

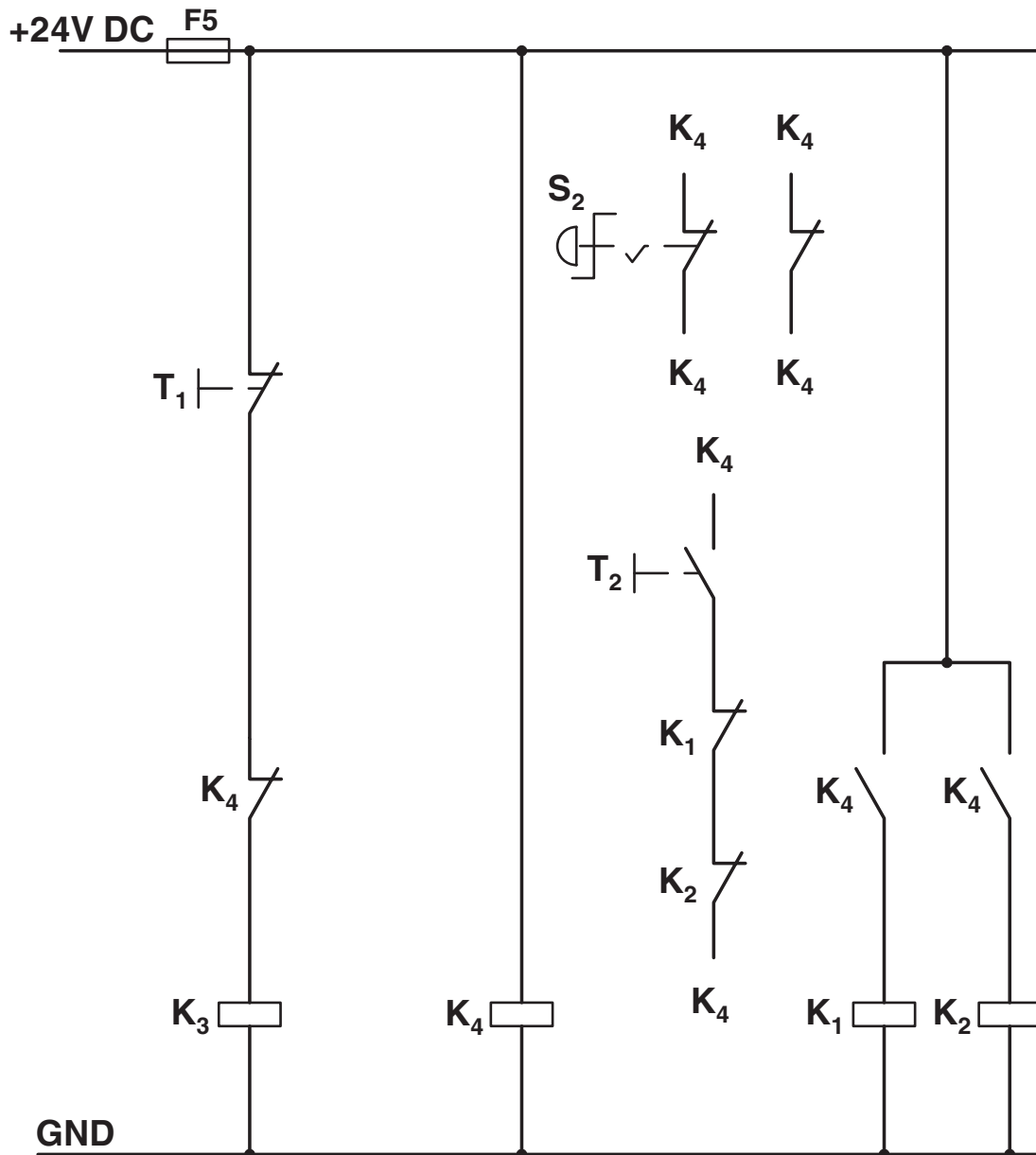
K3 = Right contactor

Control current path for contactor according to category 3

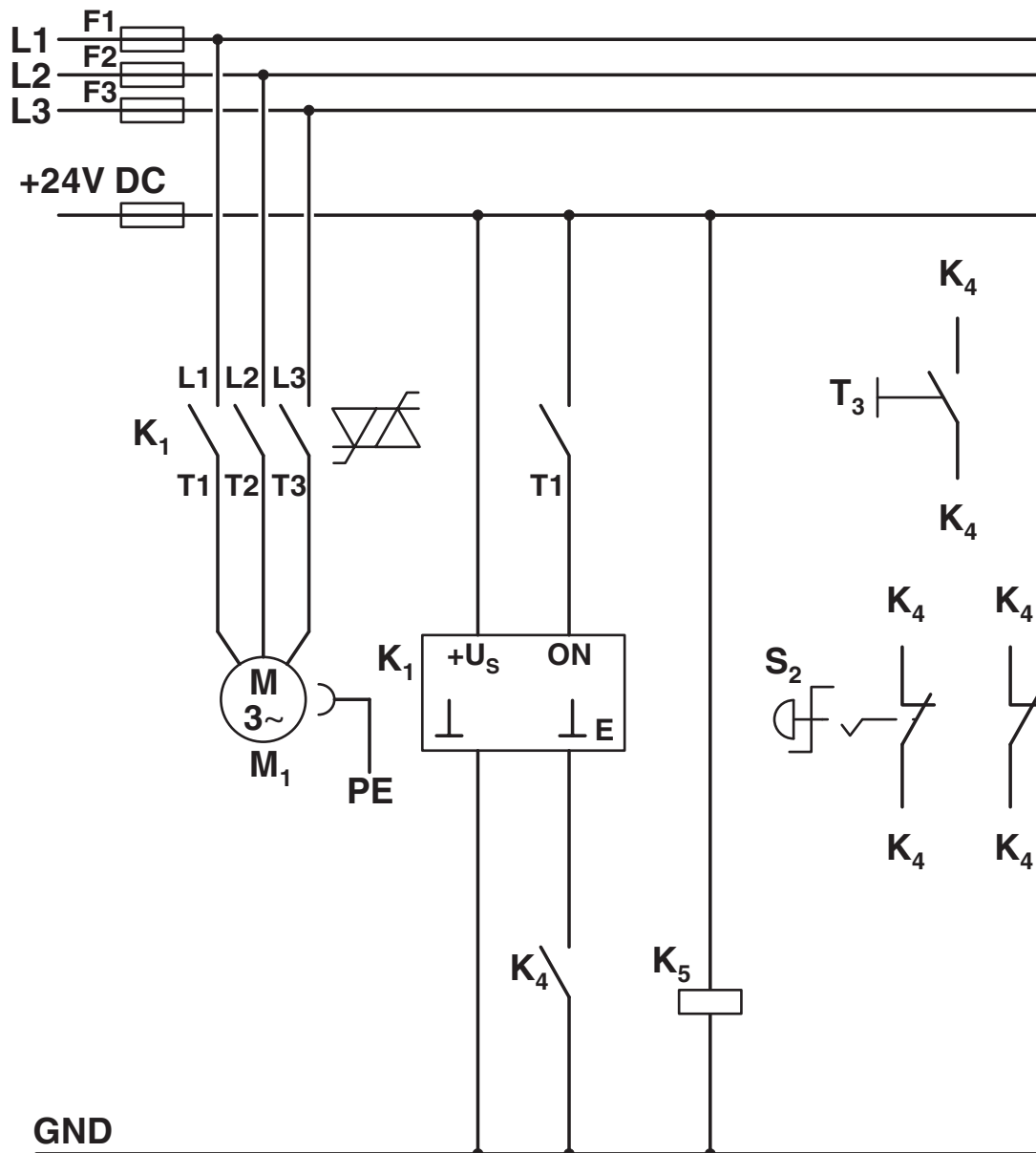
- K1 + K2 = Emergency stop contactor

T1 = Right, T3 = Reset

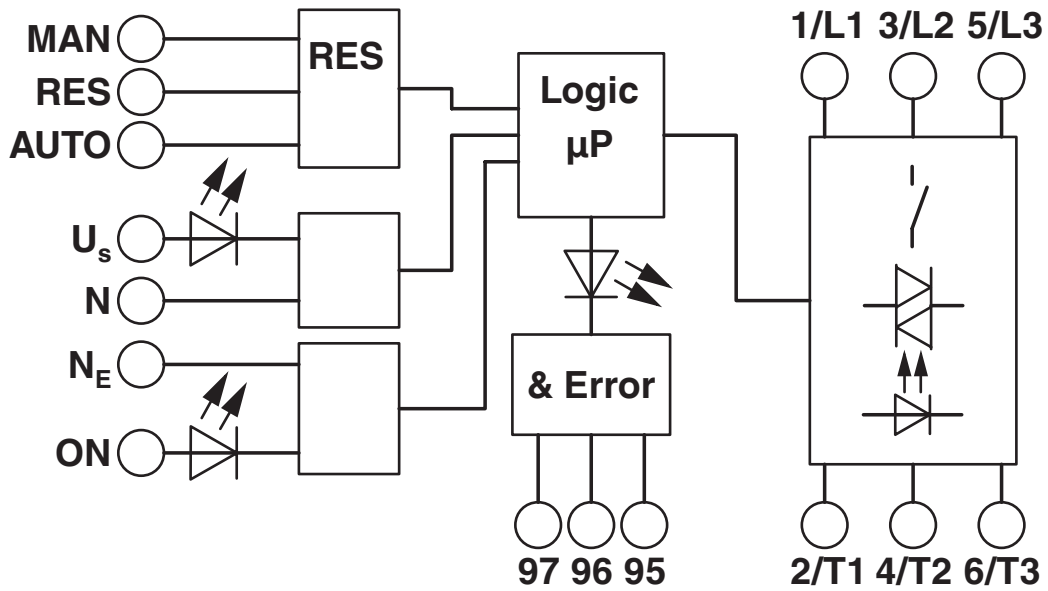
S2 = Emergency stop
