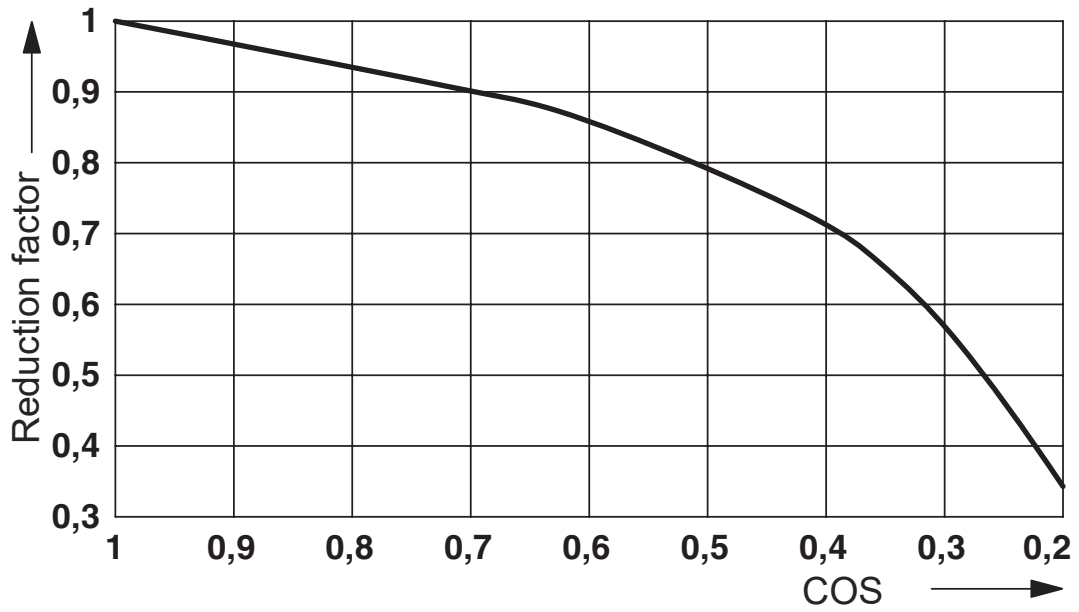

① 250 V AC, Ohmic load

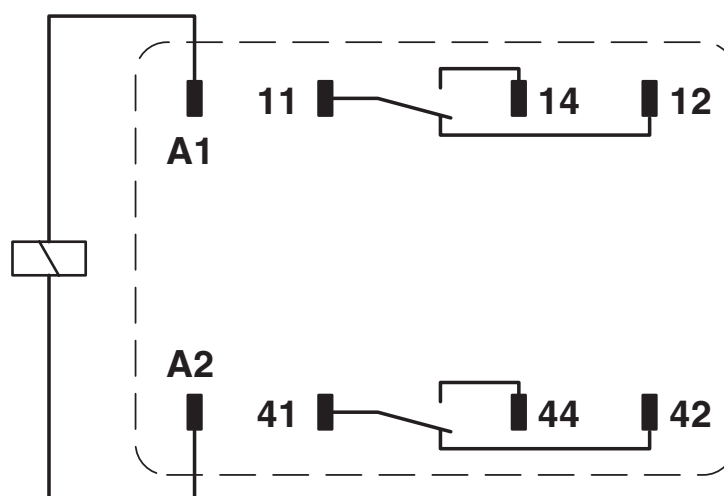
