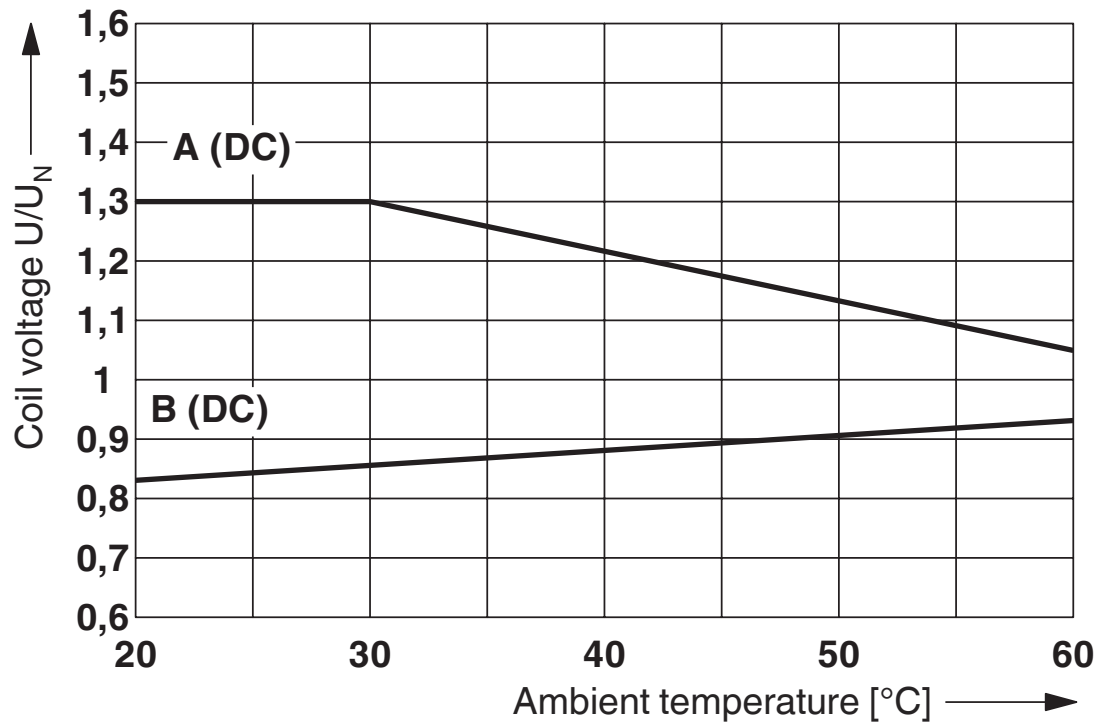

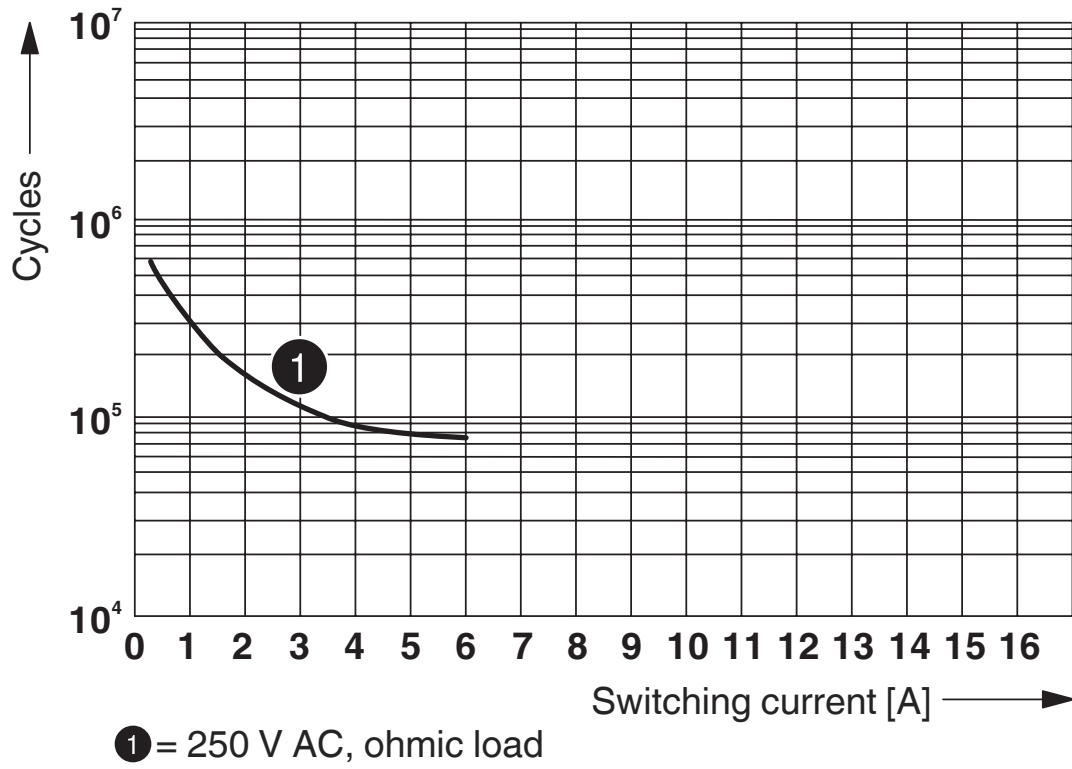
Curve A: maximum continuous voltage at limiting continuous current

Curve B: minimum pick-up voltage for pre-excitation with U_N and limiting continuous current



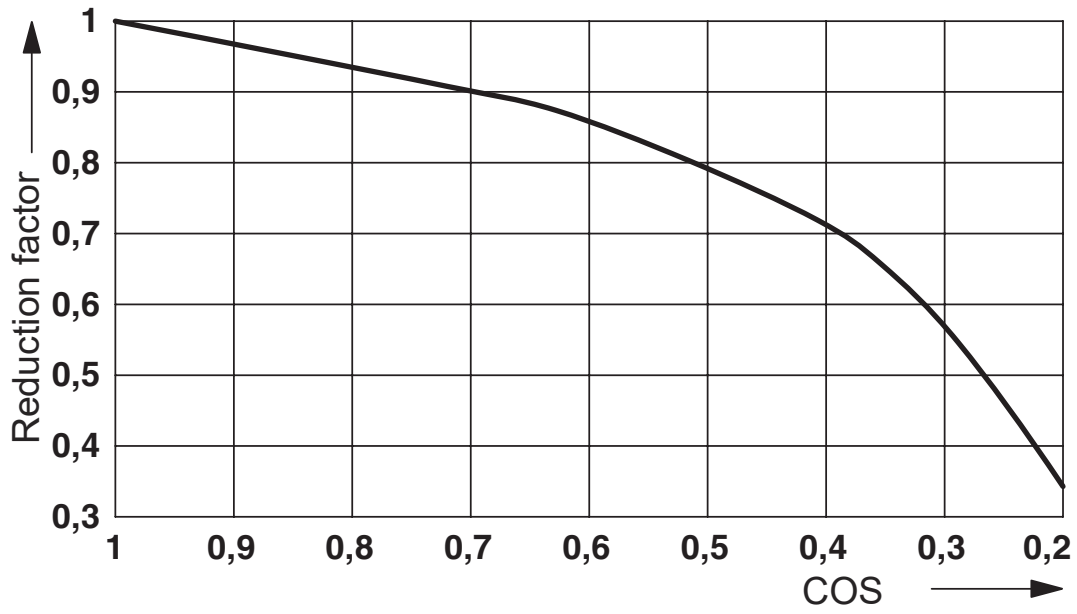

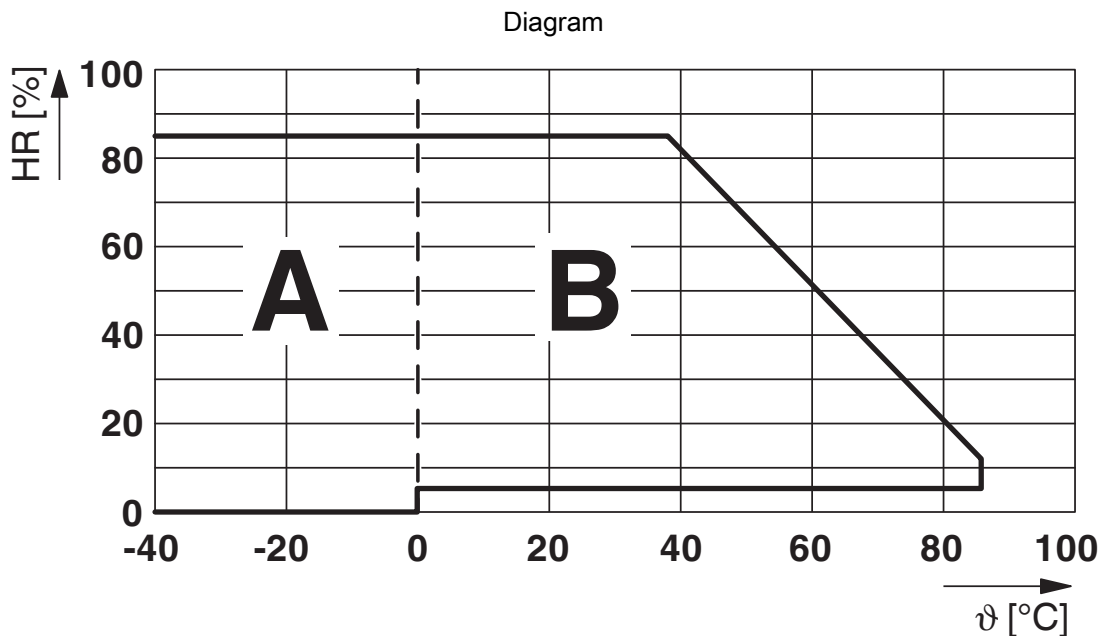


Electrical service life

Service life reduction factor



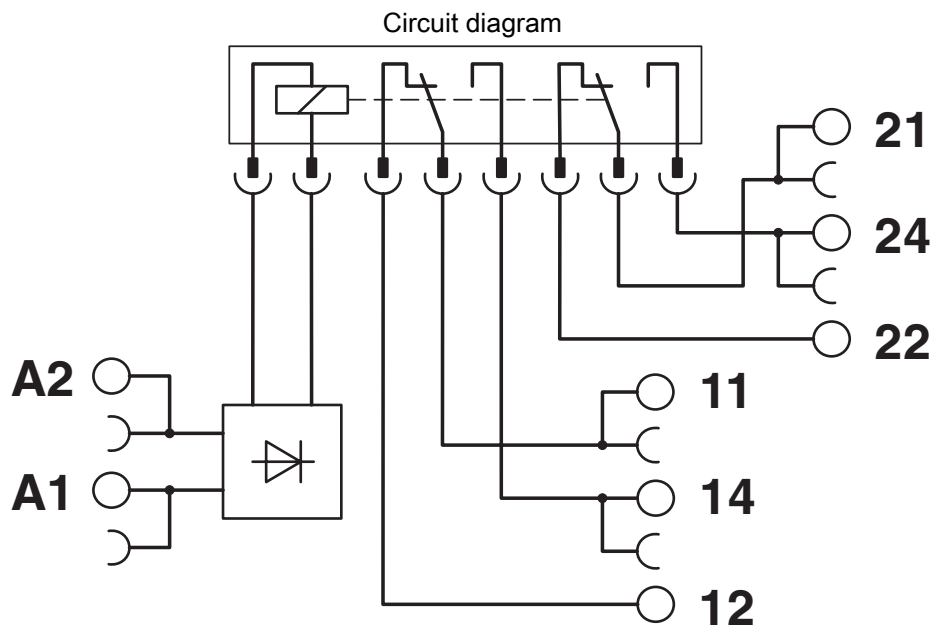
Permissible humidity for operation and storage.
