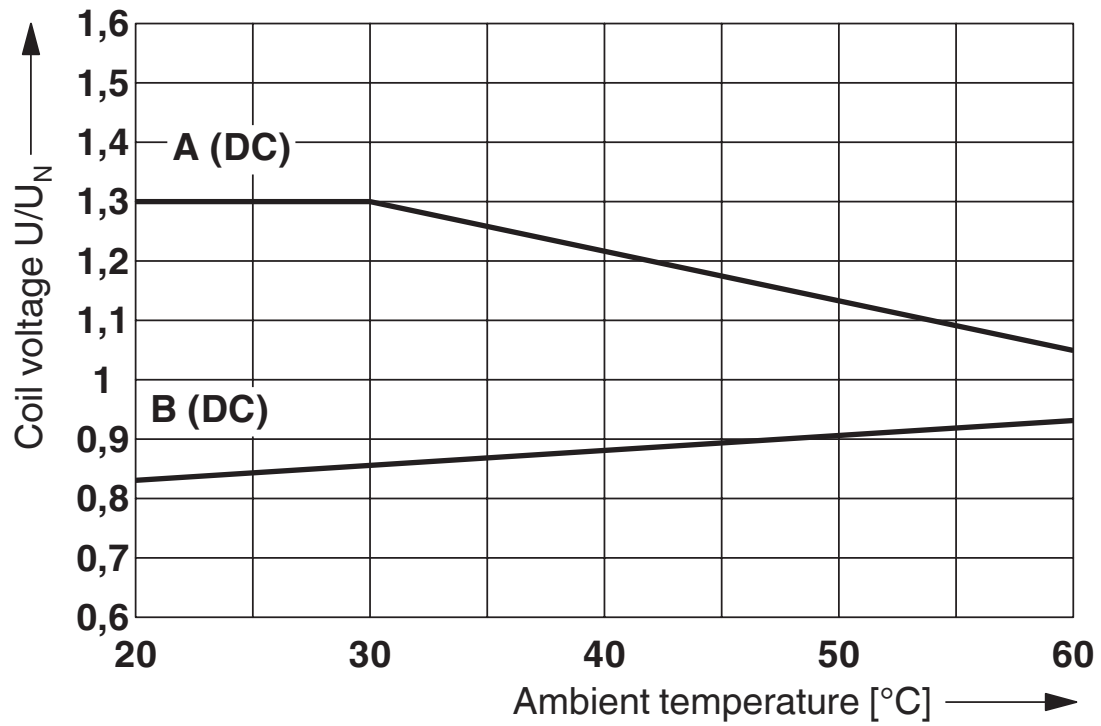

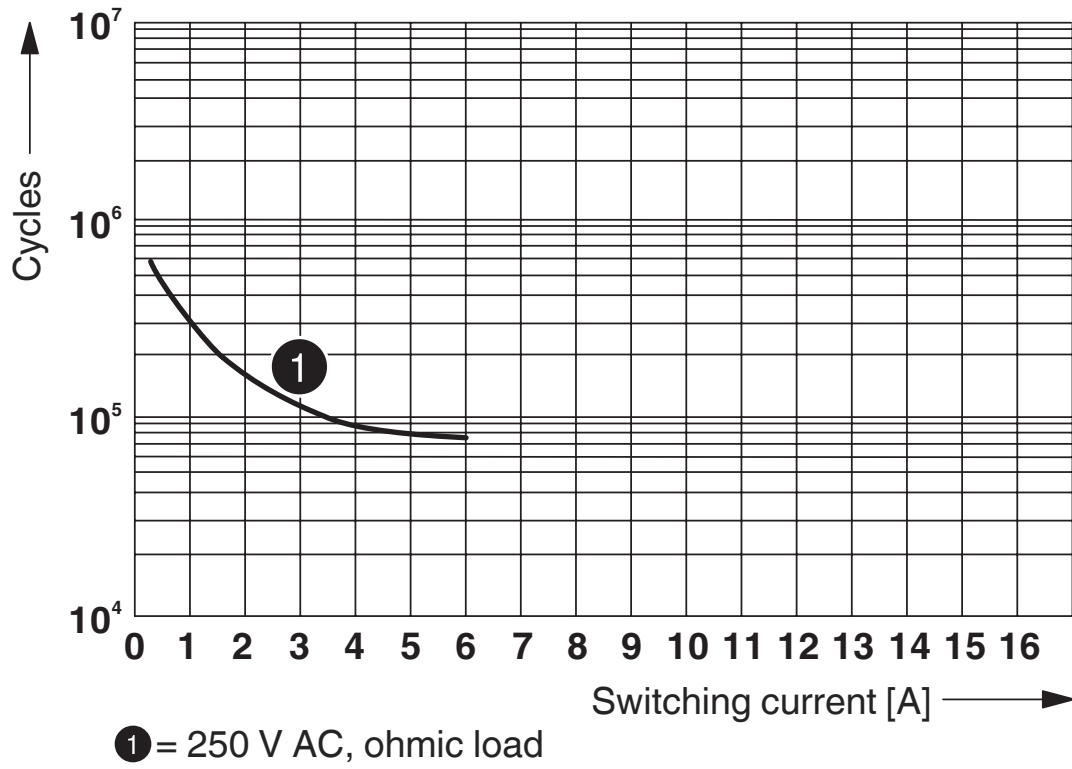
Curve A: maximum continuous voltage at limiting continuous current

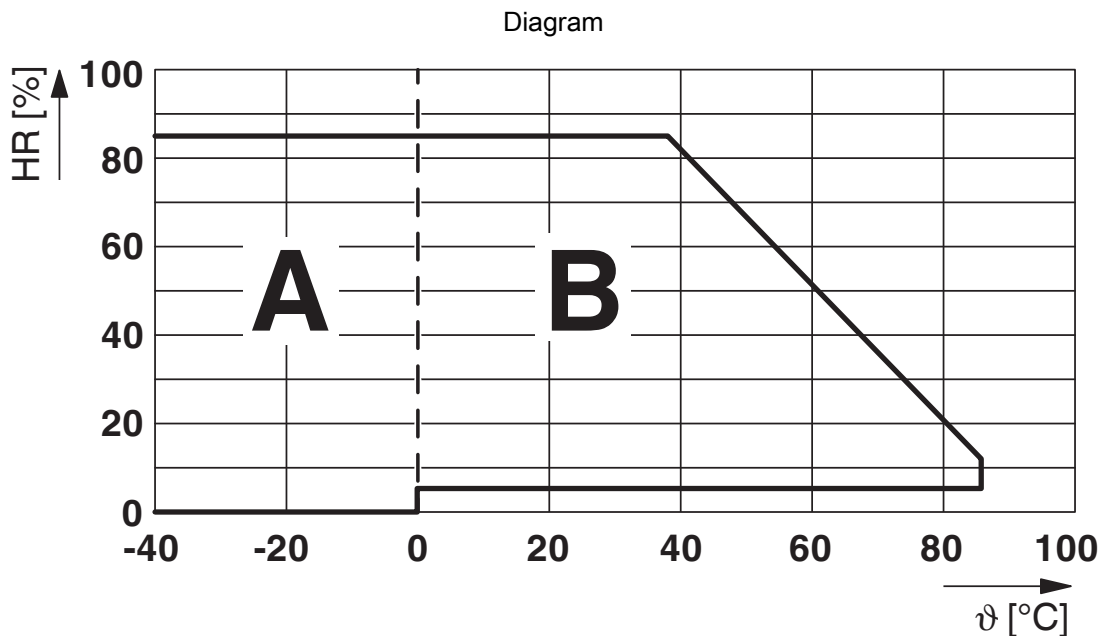


Electrical service life

Service life reduction factor



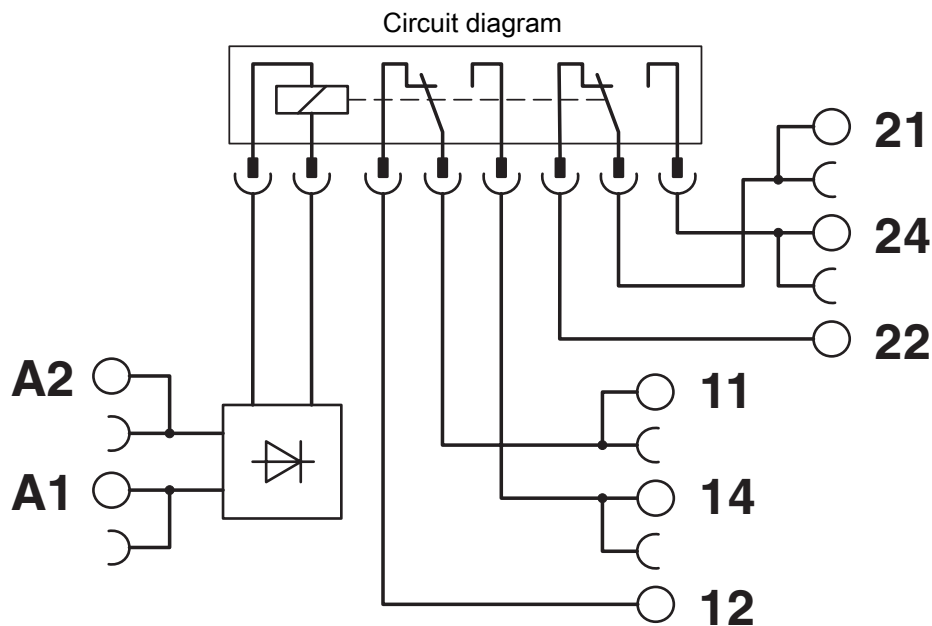
Permissible humidity for operation and storage.
