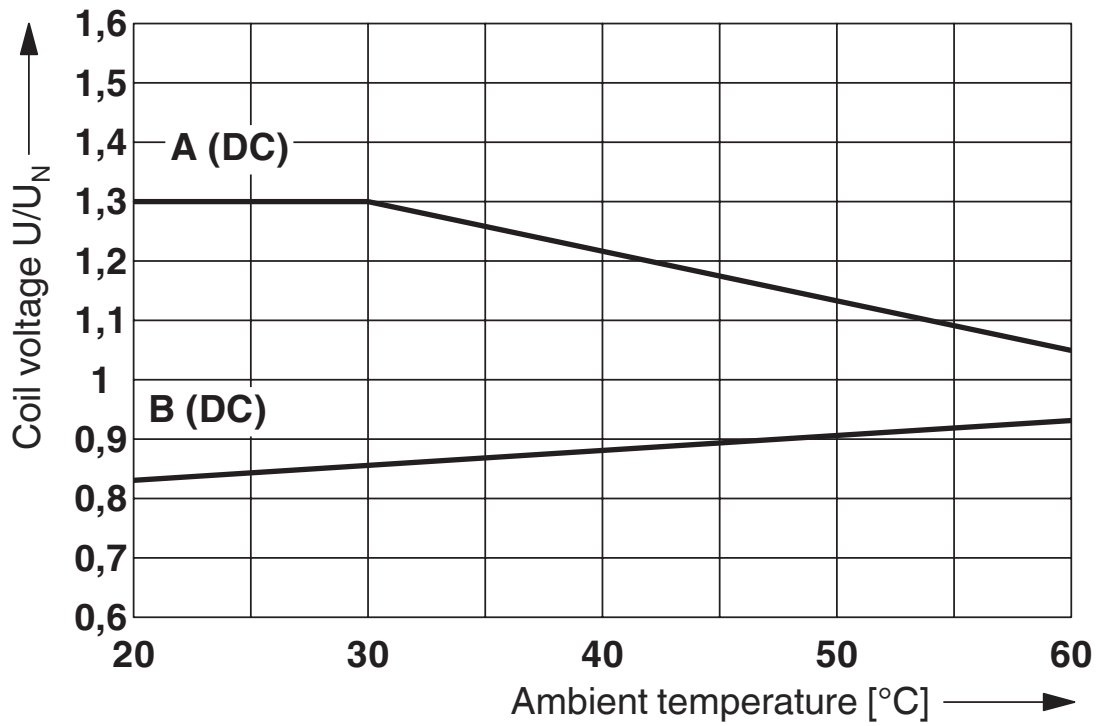

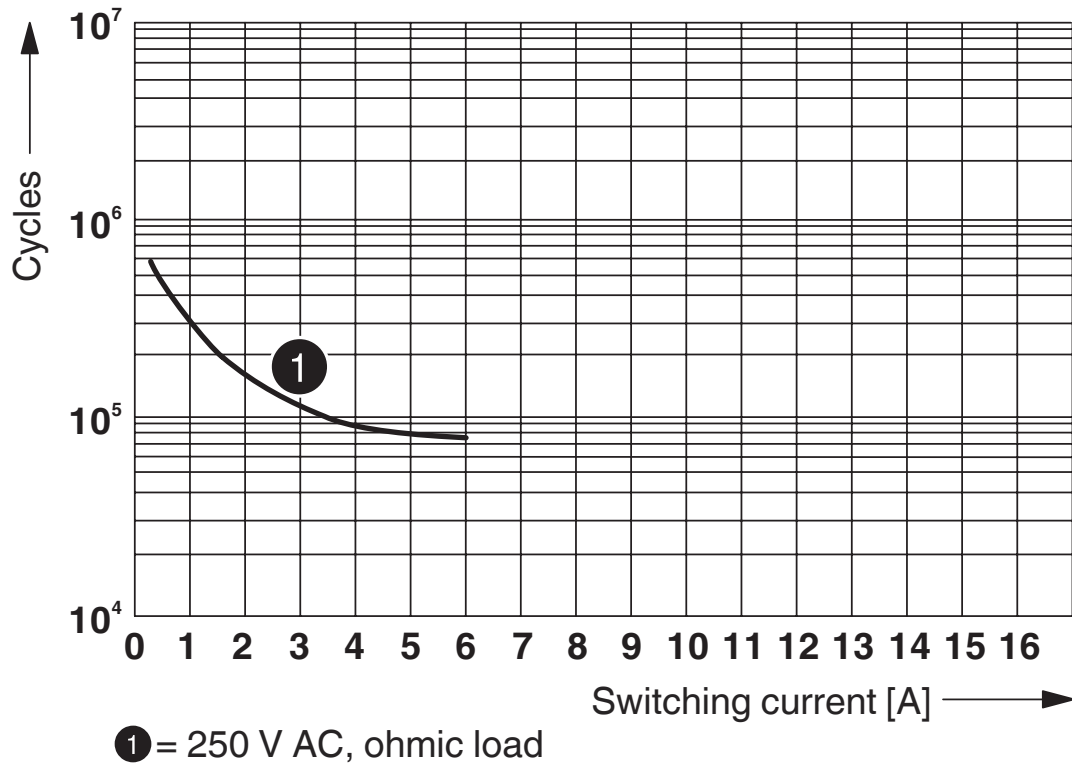
Curve A: maximum continuous voltage at limiting continuous current

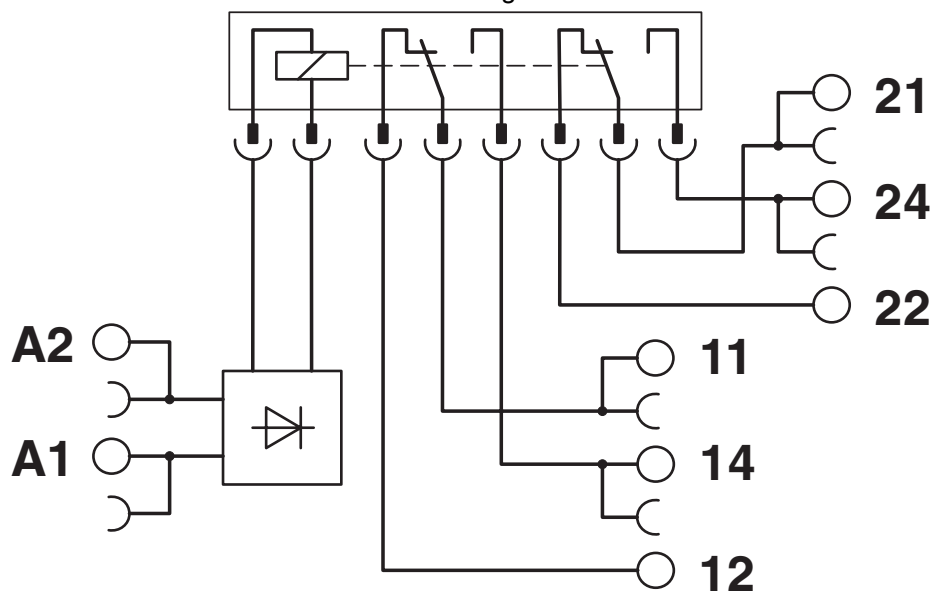
The maximum permissible ambient temperature as specified in the data sheet must be observed.
